This is our response to your July 31, 2011, Freedom of Information Act (FOIA) request for five (5) items of records from the Headquarters Air Force. As it pertains to the following item 1;

1. I respectfully request that section of the Security Classification Guide (SCG) on the DSP Satellite wherein it is indicated that one of the Missions of the DSP Satellite, is to detect the UFO Phenomena.

We conducted a comprehensive search of files within the Secretary of the Air Force Administrative Assistant (SAF/AA) office for records that would be responsive to item one (1) of your request. Unfortunately, we were unable to locate or identify any responsive records, therefore we have no records. As it pertains to items 2 thru 5 of your request, we have transferred this portion(s) to Headquarters Air Force Space Command (AFSPC), FOIA Manager for direct response to you. (U) Reference your letter dated 21 September 2010. A declassification review cannot be accomplished in response to this MDR request because specific classified Air Force (AF) records have not been identified for review. In your letter, you asked if the AF considers whether Aliens of extraterrestrial origin are now, and will continue to be a threat to our National Security and wanted a copy of the record that states so. The AF has not found any records to support this theory.

(U) In addition, you requested a declassification review of Defense Support Program (DSP) satellite records that would indicate the presence of an Unidentified Flying Object of intelligent extraterrestrial origin. 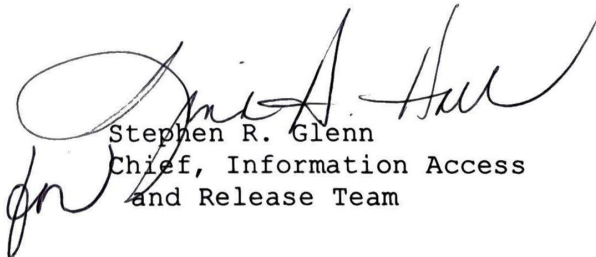

Pursuant to the Freedom of Information Act (FOIA), you requested "...the detection of any ufo by the DSP-Augmentaion (sic) satellite that has been determined to be of extraterrestrial origin and under intelligent control."

In NRO FOIA case #F10-0036, we responded to a request from you for "... a copy of any record wherein one of the DSP-A satellites has detected a UFO that has been determined to be of extraterrestrial origin and under intelligent control." 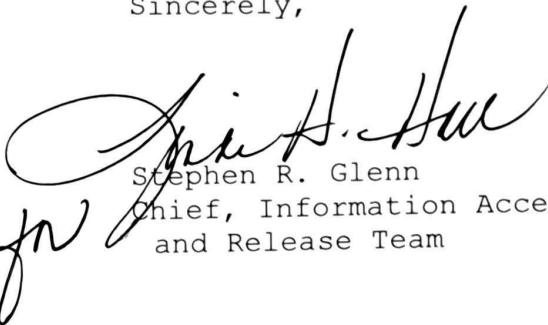

This is in response to your letter dated 17 March 2011, received in the Information Management Services Center of the National Reconnaissance Office (NRO) on 25 March 2011. You cited Executive Order 13526 and asked for a Mandatory Declassification Review. However, you did not specify a document in such a way that it could be identified and located (by date, title, subject, etc.). Therefore, we processed your request pursuant to the Freedom of Information Act (FOIA). You are requesting "that record of the first NRO Satellite, that was employed specifically as one of its missions to detect objects that are determined to be Extraterrestrial Origin . . ."

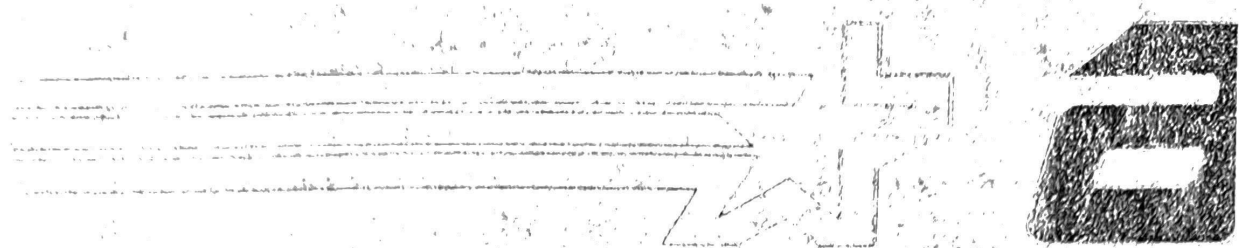
The NRO is a joint organization engaged in the **research and development, acquisition, launch and operation** of overhead reconnaissance systems necessary to meet the needs of the Intelligence Community and of the Department of Defense. In this capacity, the product of NRO systems is provided to other government organizations. Once this product is turned over to those organizations, they make determinations as to the further use and dissemination.

However, the NRO has conducted numerous searches relating to UFOs in the past, including your case numbers F10-0036 and F08-0036, and we have located no records. Since this topic is outside of the scope of NRO responsibilities as outlined in the paragraph above, and previous searches have located no records in the NRO, we are administratively closing your FOIA request.

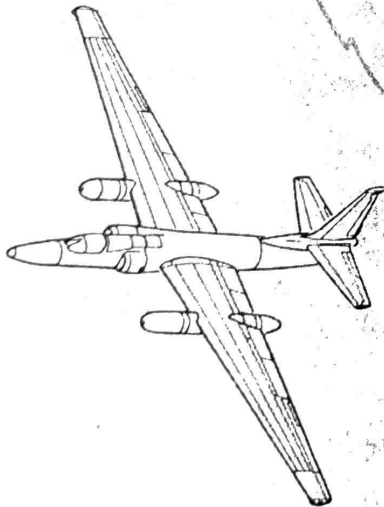

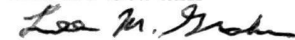

The appropriate Air Force agency conducted a review and determined an MDR cannot be accomplished because specific classified AF records have not been identified for review. You requested photographs of three aircraft projects that were listed on the "Certificate of Retirement" of Mr. Ben R. Rich, formally employed by Lockheed Martin. Since we do not maintain Mr. Rich's retirement certificate, we are unable to properly identify these aircraft. Additionally, you requested a photograph of a "Diamond shaped aircraft" that some individuals witnessed seeing hovering near Huffman, Texas on 29 December 1980. These are also not identifiable official AF classified records. Therefore, an MDR in accordance with Executive Order 13526, Section 3.6 is not warranted.

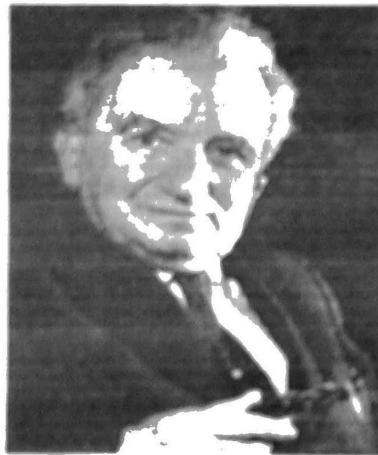

On March 20 1942, these men incorporated AEROJET ENGINEERING CORPORATION with \$250 each or a total of \$1250. Their vision resulted in the establishment of

AEROJET GENERAL CORPORATION

a company which grew to employ greater than thirty thousand people and have annual sales in excess of ONE BILLION dollars.

one contractor for Full Scale Engineering Development and Low Rate Initial Production. Two things became clear. The Aerojet design and performance were clearly superior and the down select award would go to Alliant because ARRADCOM believed they had a better history with armament production. Aerojet had little production experience except for electronics production on the DSP infrared sensor. It was decided that a thoroughly modern, clean, automated facility would be built to support the SADARM program aspirations. The result was a multi-million dollar overhaul of Building 57 at the Azusa facility. The then Executive VP Bob Coogan conducted an in depth transcontinental survey of potential production sites, finally settling on Azusa.

As the competitive "shoot off" was drawing to a close, with mixed test results by both companies, Aerojet and Alliant agreed to form a joint venture and to collectively bid the subsequent phases of the program by dividing up the production responsibilities on an approximate 50/50 basis through assigning subsystems to each company. Eventually the Army rejected the joint venture approach and Aerojet became the prime with Alliant as the subcontractor.

The main reason was that the Aerojet sensor and electronics were to be the baseline design. The 50/50 split was maintained. The two companies worked well as a team and the relationship continues to this day.

Based on successful field tests the program has gone into production of the first 600 projectiles. The main mission for SADARM is to attack self propelled artillery by using radar backtracking of enemy shells to provide an aimpoint for prompt counter attacks. It has other potential applications as an anti-tank weapon in the Army's multiple launch rocket system or deployed from aircraft. (See Endnote 7).

C. Aerojet Infrared Programs

1. Airborne Sensors and Measurements Programs (Dick Newton)

During the 1950s, Aerojet was clearly the pioneer and leader in infrared technology, systems, and phenomenology. It was a relatively new field, but we were the leaders. Folklore says we got in the game by developing instruments to monitor rocket firings. This activity was resident in the Electronics and Guidance Division. (Later Avionics Division and then Astrionics Division).

Infrared radiometry was (and still is) a tough job. Techniques to separate target from background was a continuing challenge. Aerojet was the leader in developing these techniques. One of the first successful units built by Aerojet was the R1 radiometer in the early 1950s for a classified customer. The purpose was for field use to measure foreign aircraft plume radiation. As the Division lead phenomenologist, Chuck Dunning was in charge, and he was the reason we got the contract. This system was successfully deployed throughout the world and did provide valuable data for infrared aircraft detection and targeting. An interesting sidelight was when two Aerojet engineers accompanied an Air Force Lieutenant (Dick Newton who later joined Aerojet), to Europe to train field agents in R1 operation. The Aerojet people asked what form to carry money for the trip. Assuming they would take a few hundred dollars, they were told to bring

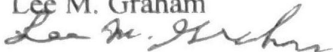

The other day while cleaning out my closet I chanced to find some old documentation that has been sent to me by the Government Accounting Office (GAO). Among this documentation were several pages of interests to me namely pages 044, 045, and 056 (see same enclosed), the first page titled-

REVIEW OF GOVERNMENT RECORDS ACCOUNTABILITY
JOB CODE 701034

Dated, March 22, 1994.

On page 045 there is in part a statement attributed to a Col Richard Weaver which reads as follows-

"I then asked about the ""Majestic 12"" document and whether the Air Force believed it to be an authentic document. Col. Weaver stated that the Air Force's position is that the document is bogus and therefore not classified. Col. Weaver said that when that document was first sent to Internal Security Office for review they stamped it unclassified before they reviewed it for authenticity. After they had studied it and determined that it was not authentic, they returned it to the sender, however, they had already put the unclassified mark on it which to the sender meant that it was an authentic document. Col. Weaver said that because of that blunder the government has had to deny the authenticity of the document ever since. Mr. Boesch stated that in the early 1980's the document was sent to the Information and Security Oversight Office for review and they sent a memo stating that the document was bogus. He stated that the files would have to be reviewed to find it but that they would furnish me a copy of the memo if it can be located."

If I might reiterate the above quoted statement as-

"...the document was sent to the Information Security Oversight Office for review and they sent a memo stating that the document was bogus. Ergo-

The problem?-

Please note the "UNCLASSIFIED" copy of the BRIEFING DOCUMENT: OPERATION MAJESTIC-12" (see enclosure H) an intrinsic part of my Defense Investigative Service (DIS) file number 89311-DK1—3408-1W9 dated 19 APR 90, which I had sent the still classified copy to Vice President Dan Quayle to on "6 August 1989, requesting-

"5b. Am I permitted to circulate copies of the BRIEFING DOCUMENT: OPERATION MAJESTIC-12 as an authentic copy of real events and indicate to others the document HAS been properly declassified?"

My question was answered in a letter from the Air Force Office of Special Investigations (AFOSI) see the enclosed response dated, FEB 14 2002, wherein they (in part) state-

"AFOSI does not possess any records that would prohibit you from circulating the copies of the unclassified briefing."

The Briefing Document Operation Majestic-12 became unclassified in the following manner-

Please note page 5 of Mr. William L. Moore's speech given in Las Vegas, Nevada on July 1, 1989, where it is (in part) stated-

"In early September, 1980, I was approached by a well-placed individual in the intelligence community who claimed to be directly connected to a high-level government project dealing with UFOs. This individual, who subsequently came to be known as ""the Falcon"", told me that he spoke for a small group of similar individuals who were uncomfortable with the government's continuing cover-up of the truth and indicated that he and his group would like to help me with my research into the subject in the hope and expectation that I might be able to help them find a way to change the prevailing policy and get the facts to the public without breaking any laws in the process. I knew that I was being recruited, but at that point I had no idea for what. In any case, I was told that if I was interested in cooperating with their group, I would be further contacted by a liaison man and that future meetings between me and ""the Falcon"" would be arranged by this person. The liaison person who subsequently made contact with me was AFOSI agent Richard Doty-- a man who has since become quite controversial in his own right and who many people have mistakenly assumed is ""the Falcon"" himself."

Mr. Moore further states-

"In any case, it was ""Falcon"" who sought me out in September 1980, and it was Richard Doty, then with AFOSI at Kirtland AFB, who soon came into play as the middle-man in that process. Shortly thereafter, it became apparent to me that my supplying information to the government, through Doty, on the activities of Paul Bennewitz, APRO, and to a lesser extent, several other individuals, was to be a part of this equation. ..."

And on page 13 of his speech Mr. Moore further states-

"Earlier in this paper I told you of how I was recruited to supply information on Mr. Bennewitz. The exact wording of my statement was "'Bennewitz... and to a lesser extent, several other individuals.'" One of these "'other individuals'" was Lee Graham. This began in 1983 if memory serves."

Thus, Mr. Moore approached me to circulate documents about UFOs that had been "leaked" to him.

As is indicated on one of the pages of the "Q & A FORUM" of Mr. Moore's FOCUS Magazine, (see a copy of same enclosed) my wife and I were shown a copy of the Briefing Document Operation Majestic-12 "... early October 1985...",

and-

"According to Bill Moore, the first person to have been provided with copies without restrictions as to how they could be used, was Lee Graham in the latter part of April, 1987,"

I, thus, informed the DIS (see my letter dated 5 May 1987) that I had an still classified copy of the Briefing Document Operation Majestic-12.

I got into trouble with the Air Force, because in my letter to Vice President Dan Quayle I had mentioned the designation of F-1117 in connection with the code word SENIOR TREND which I had signed a "CERTIFICATE" (see a copy of same enclosed) that I would not disclose. Because of this the Air Force asked the DIS to investigate me resulting in the creation of the enclosed DIS file.

The association of the designation F-117 in connection with the code word SENIOR TREND was declassified on 17 APR 1990 (see the enclosed letter bearing that date) and two days later my file was closed on 19 APR 90. I, thus made a FOIA for a copy of my DIS file and when it was sent to me I found the "UNCLASSIFIED" copy of the "BRIEFING DOCUMENT: OPERATION MAJESTIC-12" as well as other material which as you can see is also now "UNCLASSIFIED".

There exist yet another document that mentions MJ-12, the Project Aquarius document, a copy of which I have enclosed for your perusal. In order to find out if the Project Aquarius document is genuine I made a FOIA request for a unclassified copy of same to that Agency that I holds the original document (see the enclosed letter dated July 23, 2007) While my FOIA requests dated July 23, 2007 and 1 December 2007 seem to have been received, (see the Air Force response dated 7 Mar 08) the FOIA have yet to be responded to. My request to President Jimmy Carter (see the enclosed letter dated 4 December 2007) asking him to repudiate the content of the Project Aquarius document has also gone unanswered.

I found the address of the of the NSC/MJ-12 Special Studies Project in a letter from Mr. John Andrews (see same enclosed dated 19 Oct 1987) to "Ron".

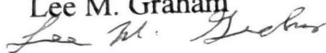

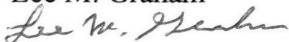

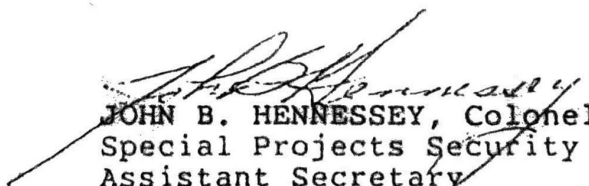

This memorandum constitutes a "letter change" to the SENIOR TREND Security Guide, 1 October 1989. Effective immediately, the association of the nickname "SENIOR TREND" and the F-117A aircraft is declassified. Each holder of the SENIOR TREND Security Guide should post this memorandum to their copy of the Guide. Documents classified solely because of the former classification of this association are now unclassified; and may be handled and stored accordingly. Each document should be reviewed to assure that there is no classified information other than the association.

Documents declassified under the provisions of this change should have their classification marked through, show the initials of the individual reviewing the document; and reference this memorandum as authority for the declassification. On bulky documents, it will only be necessary to re-mark the cover and title page, first two pages, and the back of the document. Post a copy of this memorandum inside the cover of the document.

The Air Force will continue a review of the classification of SENIOR TREND information, and will notify program participants of changes. I enjoin each organization and participant to remember that much information remains classified and to redouble efforts to protect this vital program.

Please note this Freedom of Information Act request 5 U.S.C. 552 (see enclosure A) dated 12/23/99 to the-

which was responded to by the United States Air Force (see enclosure B-3) dated 3 March 2000 wherein they state-

"The Security and Special Oversight office conducted a search for records responsive to your request, no records were found."

With regard to the authenticity of the Briefing Document Operation Majestic 12 the FBI however responded (see enclosure C-5, page 7) by stating-

"THE OFFICE OF SPECIAL INVESTIGATIONS, U. S. AIR FORCE, ADVISED ON NOVEMBER 30, 1988, THAT THE DOCUMENT WAS FABRICATED. COPIES OF THAT DOCUMENT HAVE BEEN DISTRIBUTED TO VARIOUS PARTS OF THE UNITED STATES. THE DOCUMENT IS COMPLETELY BOGUS."

Quite obviously if the Air Force knows that the Briefing Document Operation Majestic 12 is a fabrication and bogus they would possess records of proof for same and this response (see enclosure B-3) would be incorrect.

Further, there is no explanation as to why I was provided an UNCLASSIFIED copy (see enclosure D) of the document.

I had sent a copy of the still classified Briefing Document Operation Majestic 12 to Vice President Dan Quayle requesting its classification and authenticity status. The document was returned to me in its UNCLASSIFIED form as a part of a Defense Investigative Service File number 89311-DKI-3408-1W9 I had received under the Freedom of Information Act. I had been investigated by the Defense Investigative Service because in my letter to Vice President Dan Quayle I had included the designation of F-117 in connection with SENIOR TREND which was at the time still classified information.

My original requests were-

1. Under the FOIA (5 U.S.C. 552) I respectfully request a copy

of that record which prohibits me from circulating copies of the UNCLASSIFIED Briefing Document Operation Majestic 12 as genuine and properly UNCLASSIFIED.

I am sure that you recognize that if this document is genuine it will change some 32 years of history. However, if the document is bogus, then the Air Force Office Special Investigations (AFOSI) is guilty of breaking the law, most specifically Title 18, 1001 which states-

Whoever in any matter within the jurisdiction of any department or agency of the United States knowingly and willfully falsifies, conceals or covers up by any trick, scheme, or device a material fact, or makes any false, fictitious or fraudulent statements or representations, or makes or uses any false writing or fraudulent document knowing the same to contain any false, fictitious or fraudulent statement or entry, shall be fined not more than \$10,000 or imprisoned not more than five years or both."

Ergo-

If the Briefing Document Operation Majestic 12 is bogus-

2. I respectfully request a copy of that record wherein the Office of the Inspector General has taken action against the AFOSI for breaking the law (Title 18, 1001).

Also, if the Briefing Document Operation Majestic 12 was fabricated and bogus-

3. Under the Freedom of Information Act 5 U.S.C. I respectfully request a copy of that record that proves such a fact.

I will pay up to 15 dollars for a copy of the requested records.

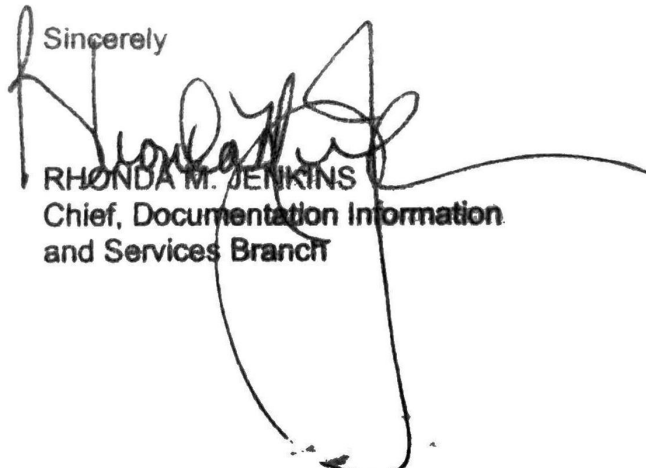

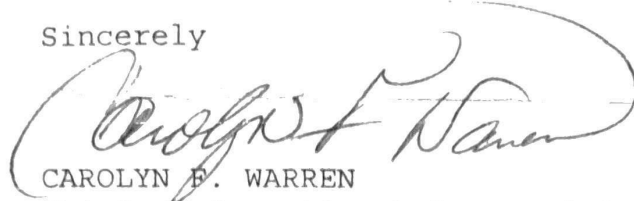
