(1) Why was Bill Moore used to provide disinformation to UFOLOGISTS? Why the "hall of mirrors" as Jacques Vallee puts it?

Answer: Richard Doty's mission was to use Bill Moore for disinformation amongst all UFO investigators, ~~MALIGHAN~~ **MUFON**, and all other private UFO investigators. Richard Doty's assigned duties were disinformation, intelligence, security, and espionage investigations while he was with AFOSI.

(2) What was the reason or necessity for this and what was to be gained from having Moore do this, and was all or some of his ~~MUFON~~ talks and ~~MALIGHAN~~ **MUFON** on UFOs and alien crash retrievals a product of this disinformation?

Answer: Yes, Bill Moore was used to distribute disinformation on the subject matter. Bill Moore was strictly used by AFOSI, and a brain child of Richard Doty and Agent Steven Atwell, authorized by Richard Doty's supervisors. However, there were other Federal Agencies also involved in disinformation. The agencies were CIA, DIA, NSA, and FBI. The FBI was not involved so much in disinformation as the other agencies. The other agencies were constantly involved in counterintelligence with each other.

(3) Was the disinformation strictly concerned with alien crash retrievals, the Roswell 1947 crash, etc?

Answer: Yes, the other agencies were involved in the Roswell Incident, however while with the **AFOSI** ~~AGHAST~~ he was not involved personally with the incident. He became involved with the emergence of Paul Benewitz.

(4) Who (person and/or government agency) ordered the Bill Moore disinfo operation?

Answer: **AFOSI** through Richard Doty and Steven Atwell.

(5) Can they be contacted for confidential interview? If yes, can you please provide their contact information?

Answer: Richard Doty is willing to have a personal interview with you, providing his confidentiality is protected as far as other witnesses, they would have to be contacted personally.

(6) Who gave you the information on the July 1947 Roswell crash (about the recovered bodies

and wreckage, the live alien and its 1952 death, Area-51, and the disposition of the wreckage at top secret locations for subsequent R & D), and was it official information?

Answer: Richard Doty's dad was an investigator with NSA during the era of the Roswell Incident, also through co-workers in the above listed Federal Agencies. Mr. Doty was aware of the whereabouts of the dead alien which was taken to Los Alamos, NM at the National Laboratory at Area 34 and was kept there until its death (late 1951 or early 1952). A military General was involved with the project. Linda Howe managed to track down this General to his private residence, possibly through information received by Linda Howe through a female CIA agent, working out of the Kirtland, Albuquerque area. The dispersement of the wreckage was that

it was sent to Federal laboratories and private organizations all over the US. Part of this wreckage was evaluated at Los Alamos by a scientist who discovered electrical isotopes in a small black box which was recovered from the wreckage, the isotopes are able to distribute enormous amounts of electrical power to support a populated city. This information was gained through other colleagues with whom he worked. He wasn't aware of any information related to area 51.

(7) Can we contact the individual(s) who provided you this information for confidential interview? If so, can you please provide their contact info?

Answer: He does not want to disclose names at this time, pending further interviews.

(8) Can you explain your lengthy interaction with Linda Howe in the past regarding the UFO-landing film footage you promised her, and was this a disinformation and discrediting action taken against her?

Answer: They were very concerned as to where Linda Howe was getting her information and part of their communication was to gather further information in an effort to ascertain where Linda Howe was obtaining her information. Of course, disinformation was passed on to her.

(9) Who ordered this and what was the reason for it?

Answer: It was ordered through his superiors.

(10) Can we contact the individual(s) for confidential interview? If so, Can you please provide their contact info?

Answer: At this time no, until further trust is developed.

(11) ~~ACIAST~~ ^{AFOSI} conducts disinformation operations verbally and not using documents (or anything in writing, in general). Can you explain why you presented Linda Howe with AF documents or letters or agreements regarding the UFO-landing film? Why this deviation from ~~ACIAST~~ ^{AFOSI} practice? Who ordered the deviation?

Answer: The information passed on to Linda Howe was disinformation. Any official investigation done by ~~AFOSI~~ ^{AFOSI} is documented, for example, case of abductee from Springer, NM in 1983 that I was aware of.

(12) Did you know of Leonard Stringfield from Cincinnati, OH, who was the prominent ~~MAUGHAN~~ ^{MUFON} member investigating crash retrieval coverups or did you personally know or meet

him?

Answer: Her knows of him but has not met him. It is possible that other agencies could have been involved in this information.

(13) Were you personally involved in officially or unofficially conducting disinformation and/or discrediting operations against Stringfield during the course of his investigations?

Answer: No.

(14) Do you know Frank Kaufmann or who he is?

Answer: No, Has heard of him. No personal knowledge.

(15) If so, what is your opinion of him and his story about the Roswell crash and his personal involvement (re: being at the crash site, conducting disinformation management to coverup the truth for the past several decades since the crash, etc.)?

Answer: He believes this to be true because of his personal knowledge of disinformation passed on over the years relating to this subject.

(16) Do you have knowledge of the present whereabouts of the current sites handling the Roswell crash retrieval research?

Answer: He is aware that Los Alamos is being used (area 34) and some other research at Kirtland.

(17) If so, can you provide the names of the locations and the government and corporate organizations involved in the project?

Answer: Not at this time.

(18) Can you provide the names of contact persons we can reach for confidential interview who are involved at these sites?

Answer: He knows the names of agents with CIA, DIA, NSA, and OFSI, however, he is skeptical about releasing their names.

(19) What is your opinion or understanding of the official reason behind perpetrating this very long 50-year coverup of the Roswell crash into the present time, well after the end of the cold war?

Answer: He still believes there are some secrets involving National Security, such as nuclear weapons research, etc.

(20) Who is gaining from keeping this all a secret from modern science and human history, keeping it from our world knowledge?

Answer: Advances in military technology.

(21) Why was the SETI Institute not officially briefed after formation in the 1980's on Roswell since their mission is contact with Ets?

Answer: He doesn't know why.

(22) What is your knowledge regarding other ~~SECRET~~ ^{AFOSI} personnel who were operating with you?

on the Bennewitz and Linda Howe affair? How many individuals to your knowledge were involved in this program?

Answer: Steven Atwell worked with Richard Doty throughout the Bennewitz investigation.

(23) Where were the orders coming from? Was it your immediate superior or how far up did you know about?

Answer: From Security Director of Kirtland Air Force Base and Washington DC

(24) In general, how deeply was ~~AGHAST~~ ^{AFOSI} involved in spreading disinformation about UFOs? How big a program was it? How widespread was it? Where was it headquartered?

Answer: It was headquartered in Albuquerque, NM at Kirtland Air Force Base and started with the Bennewitz case and was mostly concentrated in New Mexico

~~AFOSI~~ ^{AFOSI} (25) Is there still an ongoing active program of spreading disinformation about UFOs at ~~AGHAST~~? If so, can you give us details?

Answer: He is not aware of it. He has no information on that.

(26) Are you still in contact with ~~AGHAST~~ ^{AFOSI} personnel in an official capacity? If so what? Do you still report to ~~AGHAST~~ ^{AFOSI} or other government agencies?

Answer: No contact, official or unofficial

(27) Are you aware of any files or records at ~~AGHAST~~ ^{AFOSI} on UFOs? Are you aware of the location of those files?

Answer: He is aware of the files and of the location, but he still has a 25 yr. Non-disclosure agreement

~~AFOSI~~ ^{AFOSI} (28) Do you have any knowledge regarding intimidation of UFO eyewitnesses in the past by ~~AGHAST~~ personnel? If so, please give details. Is this program still continuing?

Answer: He was involved in a lot of disinformation but not intimidation.

(29) Are you aware of other agencies involved in disinformation spreading regarding UFOs? If so which ones?

Answer: Yes, the CIA, NSA, DIA. ~~AFOSI~~

MY NARRATIVE:

Richard Doty's involvement in the UFO investigation started when he was assigned to investigate Paul Bennewitz in the 1980s. Mr. Paul Bennewitz, owner of Thunder Scientific Corporation, accidentally, while working on UFO research and doing surveillance of the Kirtland Air Force Secret Weapons Research Area, managed to break a secret Defensive Code at the storage bunkers

where the nuclear weapons were stored. These bunkers apparently have a sophisticated electronic defensive cover to protect against intrusion and air bombardment. He became involved with Mr. Bennewitz after the Air Force believed that Mr. Bennewitz was working as a spy for the KGB and the Russian Government. All of the before mentioned agencies were involved in monitoring Paul Bennewitz's activity. Therefore, Paul Bennewitz was awarded a research grant of \$125,000 to do UFO research. During this time Paul Bennewitz and ~~AFOSI~~ agents flew numerous times to the Mt. Archuleta location near Dulce, NM to monitor counter intelligence on a research project that the Air Force was involved in northern NM. The project was a cloaking device using the F117 Stealth Aircraft. The Aircraft supposedly disappeared from sight for seconds and therefore was never successful in making it invisible for a prolonged period of time. During this time the Air Force developed sensors to monitor and track down the source that was monitoring the project. There was a source of low radio frequency activity in the area and they did extensive research on the communication radio towers located on top of Archuleta Mesa. He was also aware of the Delta Force using explosives to bomb the openings to crevices at Mt. Archuleta. He gave me exact details of where the explosions took place. ~~AFOSI~~ was able to obtain some pictures taken by some Jicarilla youths showing a huge saucer shaped craft and 2 smaller ones. Agent Doty and other Agents had the pictures at ~~AGHAST~~ ~~AFOSI~~ until agents from the NSA obtained them. This caused

friction between the agencies. Agent Doty and Steven Atwell both witnessed Paul Bennewitz's computer communication with the alleged alien (reptilian) aircraft. He described the observance of the communication exactly as I saw it. He also identified the person working with Bennewitz on the computers to be of Oriental descent (Taiwanese Nationalist). He also witnessed the small balls of light moving around in the Bennewitz home. In 1964 the dead aliens from the Roswell, NM crash, the Magdalena, NM crash, and the one that died at Los Alamos, NM in 1951 were returned to aliens on spacecraft from their place of origin. This exchange took place 13 miles south of Trinity site at White Sands, NM. About 6 years ago Mr. Doty was hired by a Japanese filming crew. He flew them to the Dulce area, over Mt. Archuleta. They later went to Roswell, NM where the Japanese retrieved barrels of dirt from the Roswell crash site. They were able to pick up debris from old Army blankets where supposedly two of the aliens were buried. He has further learned that the Japanese crew were able to extract DNA samples of bone, etc from the dirt. Mr. Doty was very surprised at the knowledge the Japanese crew had pertaining to the Roswell Site including the coordinates of the crash site.

In conclusion, he explained the Roswell crash. He said that the 1947 crash at Roswell was caused

by lightning striking one of two UFOs when they were in the process of approaching the bigger ship. One of the aircraft was hit by lightning from the bottom at which time that aircraft hit the other one. One crashed near Magdalena, NM and the other one first crashed near Corona, NM and bounced about 30-34 miles to it's Roswell location.
