I ASKED BY A PHONE CALL TO PAUL GILMAN FOR A HELICOPTER, EXPLAINING THE SITUATION. SAID HE WOULD CHECK AND CALL BACK - HE DIDN'T; THAT WAS ON A FRIDAY. SO I CALLED HIM MONDAY, NOV 18, 1985 - HIS ATTITUDE HAD CHANGED TOTALLY. HE SAID NO - COULDN'T DO IT - AT THIS TIME; A STRANGE WAY TO PUT IT.

I AM TRYING THROUGH ED ERANZAK AND DOE TO GET SOME ASSISTANCE AND A HELICOPTER BUT FRANKLY AT THIS TIME I DO NOT EXPECT ANY SUCCESS. DARNED IF I WILL FINANCE A CHARTER AT \$2500. TO DO IT MYSELF.

IN THE OVERVIEW, IT IS QUITE OBVIOUS WE ARE BEING STONEWALLED AND DELIBERATELY DELAYED TO PREVENT ANYONE FROM FINDING THE TRUTH OF THIS MATTER BEFORE IT CAN BE COVERED UP. AGAIN - NO MORAL JUDGEMENT, APPARENTLY PEOPLE ARE EXPENDABLE. THERE IS NO GUESSWORK ON MY PART AT THIS POINT - I KNOW WHAT THIS IS BUT I HAVE A FEELING PERHAPS THAT YOU DO NOT.

IN THIS MODERN DAY AND AGE WITH OUR SUPPOSEDLY SOPHISTICATED GOVERNMENTAL SYSTEMS IT APPEARS THAT IT IS NO DIFFERENT NOW WHEN PEOPLE ASK FOR ASSISTANCE IN THE FACE OF A FAR MORE DEADLY AND LONG TERM HAZARD, NUCLEAR RADIATION; THAN IT WAS WITH THE SETTLER FACING MARAUDING INDIANS, ASKING FOR HELP THAT NEVER CAME.

NOW - NO MATTER IF CLEANUP WAS ATTEMPTED - INSIPID SEEPAGE INTO THE COUNTRY SIDE AND THE NAVAJO RIVER WILL CONTINUE FOR MANY YEARS. WE WORRY ABOUT ONE SMALL CRACK IN ONE ROOM AT THE PROPOSED WIPP SITE NEAR CARLSBAD BUT APPARENTLY WE DO NOT IN THE CASE OF DIRECT AND PERMANENT CONTAMINATION BY PRIMARY SOURCES IN THE OPEN COUNTRY SIDE. THAT IS A PARADOX.
