Request of United Nations action to
prevent humanity's Space War suicide.
RE: your letter on December 1, 1988

Dear Mr. Jasentuliyana:

On behalf of the ICUFON Memorandum's undersigned UFO research organizations, I express our deepest appreciation for information of His Excellency Secretary General Javier Pérez de Cuellar, that the Committee on the Peaceful Uses of Outer Space could act only when our Memorandum-Proposal is submitted by the government of a Member Nation.

We suppose so, it escaped His Excellency's esteemed attention, why the Memorandum was directed to Him, and to His Excellency Peter Jankowitsch, Chairman of the Committee on the Peaceful Uses of Outer Space. — It was on the strength of the United Nations Charter, Chapter I/1., relative to its Chapter XV/99 and 100, which empowers Him in person on

"...ANY MATTER WHICH IN HIS OPINION MAY THREATEN THE MAINTENANCE OF INTERNATIONAL PEACE AND SECURITY, THE SECRETARY GENERAL MAY BRING TO THE ATTENTION OF THE SECURITY COUNCIL."

The Article 100 specially discloses any governmental involvement when states:

"In the performance of their duties the Secretary General and the staff shall not seek or receive instruction from any government or from any other authority external to the Organization." (Enclosure # 1.)

ICUFON's above Memorandum in four Dossiers, exposed hundreds of classic declassified evidences regarding the military established POTENTIAL THREAT of the Extraterrestrial Forces facing all the nations. Official Releases of the White House, and the USSR's Central Committee have proven the Geneva Summit (Nov.1985) secret accord between President Ronald Reagan and General Secretary Mikhail Gorbachev when agreed:

"...if the earth faced an invasion by extraterrestrials, the United States and the Soviet Union would join forces to repel such an invasion."
