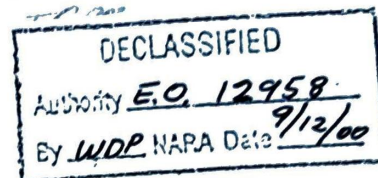

Dear Mr. President:

I just want you to know what a memorable experience sharing so much of your time was for me last week.

I was very thrilled to be at your home in Key Biscayne and to swim and eat and relax with you and Mrs. Nixon and Julie. And even though you were going through a pretty rough time, I want you to know I was proud and pleased to be with you on Grand Cay for the weekend.

On my return here I naturally became the focal point for comments about you since the radio and television and newspapers had all indicated that I was with you.

No one has lost faith with you! All of the people who have discussed the tragedy of Watergate with me have been concerned with what these men have put you through. I am not just saying this to make you feel well because if I were wrong you would know otherwise and think me a fool, but I do want you to know of the great concern for you and of the many people who are rallying to you.

When I called James Cagney to tell him how much you enjoyed "What Price Glory" at Key Biscayne, all he wanted to make sure of was that I would get word back to you and express his faith in you and the faith of his friends and their great concern for your well being.

I will be in Washington again starting May 20th and remain there through the May 24th dinner for the Prisoners of War.
