This is in response to your June 25, 2001, Freedom of Information Act request (NW01-0716) about files dealing with UFO's or extraterrestrial intelligence among the Records of the Office of Science and Technology in RG 259 for January 20, 1977, to January 21, 1981. We received your request on July 10, 2001.

We searched a finding aid for the Director's Subject Files, 1977-1982, and found neither of those topics mentioned. You may also wish to contact the Jimmy Carter Library at 441 Freedom Parkway, One Copenhill Ave., Atlanta, GA 30307-1498 (404-331-3942), for classified records and records of the President's Science Advisor.

We do not consider this response a denial under the Freedom of Information Act because the records in our custody do not include the information you requested. If you consider this an adverse response, you may appeal by writing to the Deputy Archivist (ND), National Archives at College Park, 8601 Adelphi Road, College Park, Maryland, 20740-6001, and explain why you think our search does not meet the requirements of the FOIA.
