U. S. NATIONAL SECURITY COUNCIL ACKNOWLEDGES THREAT FROM
UNIDENTIFIED FLYING OBJECTS - BUT RELUCTANT NEGOTIATE ON
INTERNATIONAL UFO AUTHORITY, AND BAN ARMED CONFRONTATION.

On November 21, 1981, on behalf of the National Security Council and its Chairman President Ronald Reagan, the Chief Military Adviser, Major General Robert L. Schweitzer stated to an international authority on UFOs that "The President is well aware of the threat you document so clearly and is doing all in his power to restore the national defense margin of safety as quickly and prudently as possible." This admission by a top military adviser on behalf of President Reagan came in response to massive UFO documentation sent to the President by Major (Ret.) Colman S. VonKeviczky, an internationally recognized authority on UFOs, and director of the UFO research organization, ICUFON, based in Jackson Heights, N.Y. VonKeviczky's documentation included some twenty declassified government documents on UFOs and hundreds of pages of military material gathered in two Memorandums, also forwarded to President Reagan. Thus, President Reagan's response, sent via his military adviser, General Schweitzer, constitutes the first official admission, and at the highest governmental level, ever issued to any UFO investigator, that UFOs constitute "a threat" to the security of the United States.

"It took a great deal of courage for President Reagan and the National Security Council, through Major General Schweitzer's statement to me, to admit that we have a security problem because of the
