Your letter of December 11, 1953, concerning a document, presumably signed by an Agent of this Bureau, in the possession of George Adamski, author of "Flying Saucers Have Landed," has been received.

For your information, the March 13, 1953, issue of the Riverside, California, "Enterprise" quotes Mr. Adamski as stating in a talk the previous day on space travel before the Corona, California, Lions Club that his "material has all been cleared with the Federal Bureau of Investigation and Air Force Intelligence." Since it is not the function of this Bureau to issue clearances of any type to any organization or individual, and it had not done so in this matter, an Agent of this Bureau and two Agents of the Office of Special Investigations of the Air Force on March 17, 1953, interviewed Mr. Adamski with reference to his reported statement.

At the time of the interview, Mr. Adamski denied making the statement. In the Agents' presence he wrote a letter to the Editor of the Riverside "Enterprise" pointing out the incorrectness of the article with respect to FBI and Air Force Intelligence clearance of his material. This letter was mailed to the Editor. At the same time, Adamski, in a statement to the interviewing Agents, advised he had not made and did not intend to make statements to the effect the United States Air Force or Federal Bureau of Investigation have approved material used in his speeches.
