

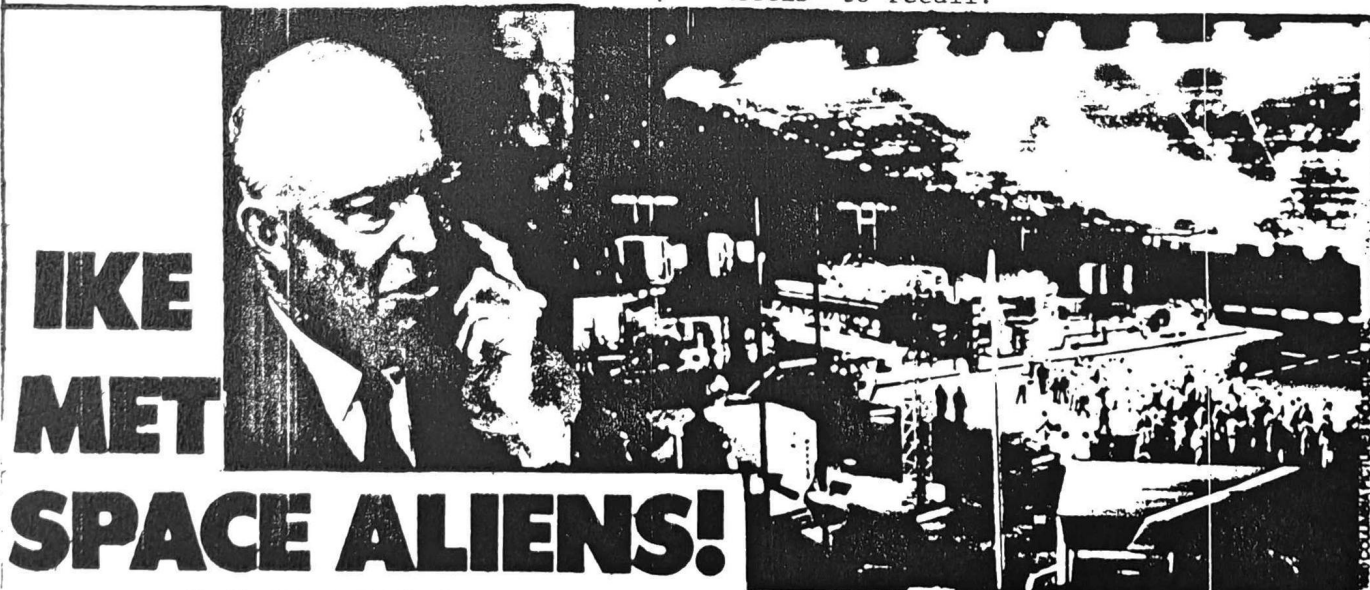
The beings seemed puzzled at my reaction when I jerked away and I remembered saying something to the effect that, "This is not right. I can't do this!" or, "That's not supposed to happen!" They again instructed me to place my hand into the image. When I did the second time, I became aware of a mild tingling in my temples and a rush of "giddiness." Later on when I tried to relate what I saw in regard to the "drawing" my mind could not function. Meaning, I felt as if I were controlled with regard to what I would be allowed to repeat to others. A very severe pain not unlike an electrical shock went through my neck at the base of the head. From what I have heard the effect resembled the product of a "cattle prod" that is used to keep stray cattle from drifting too far from the area. This is something else that I cannot understand. If I can put all this together and conclude that I am supposed to learn something or do something as a result of this experience, WHY SHOULD TOTAL RECALL OR AT LEAST PARTIAL RECALL BE DENIED ME?

In conclusion, there are a few other "side effects" that I have carried with me since the sighting. While uncertain that this was a direct result of the sighting, there is, in the lower left hand quarter of my left eye, a discoloration of the iris. I had not had

this previously to that time. I used that eye to sight through the viewfinder when taking the photo. A split second before I tripped the shutter I noticed a "flash" or "pulse" of light coming from the direction of the craft if not from the craft itself. I reflexed at this by blinking my eye lid several times, then I snapped the photo. The only other trace is that (what appears to be) the numeral "17" on my lower right fore arm. Recently I became so agitated at the marks that I employed an X-acto knife to remove the "7" from my arm. In just two (2) days time, there was no scar and the tissue was completely healed over. The dark shadow of the "7" returned five (5) later.

Today, the marks have taken on the shape of a diamond with a "clear" area in the center. This came after experiencing a DREAM several nights prior. (DREAM: I was held, though not physically, in such a way as to expose my right arm and a shaft of what looked like half chrome and half glass was placed against the marks. After what seemed like many minutes, the rod was removed and the diamond-shape remained. It was bright pink at first then it started to fade, the "clear" center became visible.

At this time I am feeling "PUSHED" to accomplish something but as yet I do not know what. I am still waiting... Up to this date, this is all the information that I have been "PERMITTED" to recall.

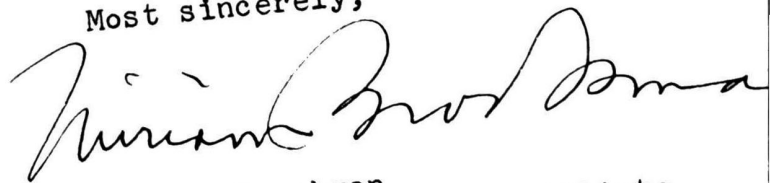

Dear Mr. President:

Please permit me a little of your busy time to ask on behalf of my organization several questions on matters of concern to us all. On the brink of bursting the erstwhile limits of our spatial horizons, we seek simply the truth about these matters.

1. The official publication of NICAP (National Investigations Committee on Aerial Phenomena, of which Donald E. Keyhoe, Major, USMC, Ret., is Director) refers to an Air Force statement which is contrary to Federal Aviation Agency reports.

The AF-FAA confliction concerns the alleged sighting of an unidentified flying object (UFO) on September 24, 1959 near Redmond, Oregon. NICAP states that FAA proof of the facts of the sighting, proof which is officially logged FAA evidence, includes: details of a chase by four AF F-102 jets, a description of the UFO and an AF report of tracking the object by radar for over one hour. These FAA reports were signed by L. E. Davis, Chief, Redmond Air Traffic Communication Station, and William F. Zauche, Jr., Chief, Air Route Traffic Control Center, Seattle. The reports, sent to NICAP, were accompanied by a confirming letter from Eugene S. Kropf, Assistant to the Regional Manager, FAA Region 4, Los Angeles. NICAP states that the FAA reports are at NICAP headquarters in Washington, D.C..

NICAP states that on January 19, 1960, it received the following statement, which was signed by Major Lawrence J. Tacker, Pentagon Public Information Officer handling UFO information: "The ATIC account of the sighting fails to reveal any evidence of radar tracking or any success of the attempted intercept. It is the ATIC opinion that this object was probably a balloon..."

Mr. President, do you think that the Air Force should be requested to make, immediately, a complete and public explanation of this case?

MEMORANDUM FOR THE RECORD

SUBJECT: White House Inquiry

The purpose of this memo is to close out SAFLL 84780 which is an inquiry from Mr. Lee R. Munsick of the North Jersey UFO Group to Mr. James Hagerty concerning UFO's.

Mr. Munsick has on numerous occasions inquired through Congressmen and general officers of the Air Force, Director of Legislative Liaison and Information Services about UFO's. His main pitch is an allegation that the USAF is withholding information concerning this subject from the American people.

Mr. Munsick has received all of the DOD press releases covering the 11-year study of UFO's made by the Air Force. He has received numerous letters through Members of Congress refuting the allegations of censorship. During the past several months, all inquiries from Mr. Munsick have been closed by memo for the record except those inquiries through Members of Congress to which Mr. Munsick receives a stock reply, and it is estimated that he has received at least 5.

The action officer called Colonel Draper's office and explained this situation to Mrs. Willyce Crucioli, Colonel Draper's secretary, and suggested that this inquiry be closed by MR. Mrs. Crucioli agreed and asked that a copy of the memo closing the case be furnished her. No further action required. CASE IS CLOSED.

Baltimore (M)—A group of Baltimoreans claimed yesterday they have been able to utilize gravity in circular motion machines capable of powering everything from hearing aids to space cruisers.

Otis T. Carr first announced his claim in a news conference called by OTC Enterprises, Inc., of which he is president. He further detailed his claims yesterday in an interview and demonstration of a crude model of a circular motion machine which he said is the principle of a "free energy circular foil" space craft he can build, if someone puts up the money.

He said the machine can be adapted to devices of any size to produce continuous power absolutely free of dissipation.

Its immediate application, Carr said, would be in a space craft—either manned or remote controlled—which would be able to hedgehop among the planets in controlled flight. It could land or take off as desired on the earth, the moon or any planets in the earth's solar system, he said.

Neither Carr nor any of his associates has any formal education in science or engineering. They said their claims are based on the most simple practical applications of natural laws and discoveries of the "giants" of science and mathematics.

A 52-year-old native of Elkins, W. Va., Carr says he has financed his research with his own modest funds and through private funds supplied by friends. He claims to have built "thousands" of working models. His professional experience, he said, has included a dozen different jobs ranging from operating a locomotive, to working as a night desk clerk in a hotel, a job he resigned two years ago when OTC Enterprises was formed. Carr said the jobs were merely sources of income to keep him going on his research.

Carr and his associates said they are withholding full disclosure of their claimed developments, including proof in the form of refined working models. They added this is not from a desire for "secrecy or monopolistic control" but only to avoid any suppression of what they consider concepts which could revolutionize the technology and economy of the world.

Carr said copies of a 16-page copyrighted brochure outlining his claims in general terms were sent last Thursday by registered mail to President Eisenhower, members of the Cabinet and the Atomic Energy Commission.

He promised full disclosure of designs, principles and application of the discoveries he claims as soon as the government, industry or anyone else comes forth with the funds to produce them and guarantees the information be made available to the world.

Carr said his project represents 16 years of research and application, inspired principally by Albert Einstein and based on the discoveries of Einstein, Newton, Bacon, Archimedes and others.

He said the same "free energy" which causes the earth to rotate on its axis and orbit around the sun, will turn a machine he described as two cones joined at their circular bases. When the rotation of such a machine reaches a certain velocity relative to the earth's orbital velocity, Carr said it will take off.

The space ship Carr claimed he can build for the cost of a passenger airliner, could be flown to the moon or anywhere else in the solar system within six months of the time construction is started, he said.

Carr said the core of such a space ship would be a huge battery which would spin at the velocity of the external craft and which would be recharged, he said, by its motion.

Such a battery, he calls a "nutron electric accumulator." Carr declared such a device, built to any size, could be designed to power the largest electric generator virtually any conceivable machine or device.

The principle on which Carr said such circular motion machines would operate is that "any vehicle accelerated to an axis rotation relative to its attractive inertial mass (the earth) immediately becomes activated by free space energy and acts as an independent force."

He described gravity, magnetism and electromagnetism as example of what he calls free energy. All exist without any energizing force set up by man, he said. All, he said, are regenerative, undissipated energies.

Since all three are joined together is space, he said he considers space itself the prime energy.

Carr said his space vehicle would not have to blast through the earth's atmosphere as present day rockets do. It would not have to neutralize gravity to escape from the earth, he added, because it would utilize the force of gravity as energy.

Your telegram reminds me that in public affairs most of the time you're damned if you do and damned if you don't.

The satellite effort, it happens, is completely non-military. There are no security aspects to it whatsoever. To deny the press access to it, therefore, would be to invite violent criticism for withholding nonsecurity information. My opinion is that the criticism would be right.

The fact is, arrangements were made about two years ago to assure full press coverage of America's part in this scientific experiment. Naturally enough, an experiment in science is just that -- a test that might succeed on first try, or it might at first fail. All the key scientists in the world were privy to our participation in this effort when it began in 1955 -- and every nation agreed that its efforts would be made fully known to the world's scientific community.

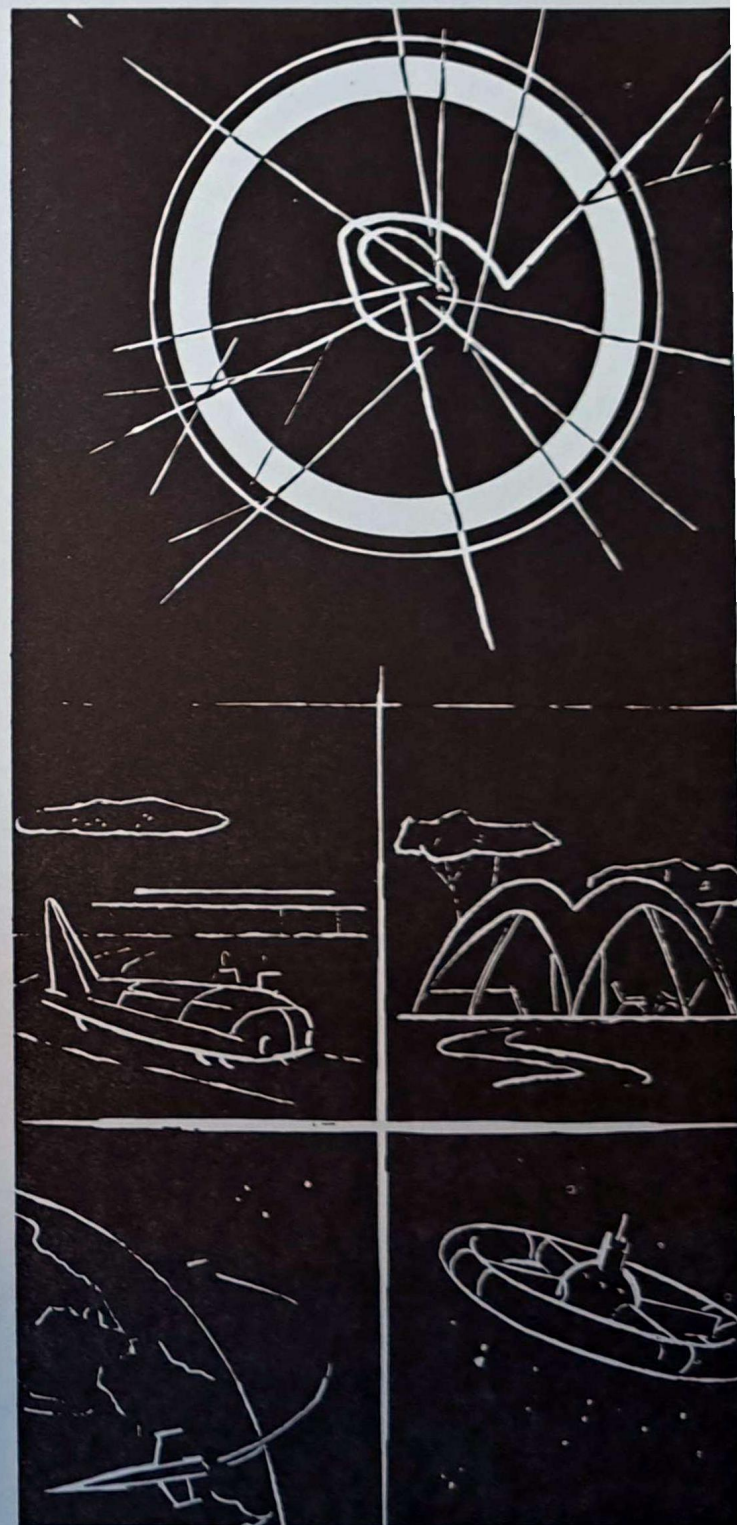
