Abstract: 'STAR WAR' vs STAR PEACE

Dear

The President of United States, Ronald W. Reagan, and the General Secretary of the Soviet Union, Mikhail Gorbachev, have agreed and recently warned the entire world:

"...IF THE EARTH FACED AN INVASION BY EXTRATERRESTRIALS, THE UNITED STATES AND THE SOVIET UNION WOULD JOIN FORCES TO REPEL SUCH AN INVASION."
