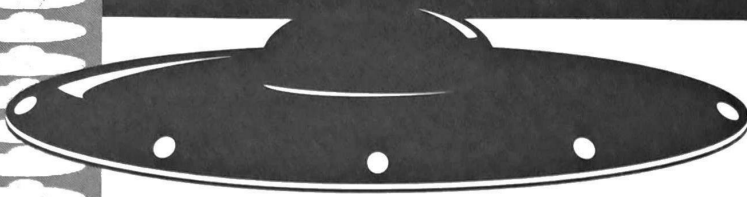

Holiday, July 4, 1947, about 11:50 pm

Mac Brazel, rancher on the Foster ranch (75 miles NW of Roswell), heard a loud noise, different from the thunder.

Two nuns at St. Mary's Hospital in Roswell saw what they believed was an airplane crash. The tower at the base tracked and reported a "descending flash" that they tracked on radar.

July 5

Brazel was routinely riding/working the ranch property with his neighbor's son Dee Proctor (age 7) and discovered the debris field 30 hundred yards wide (3 football fields) and 3/4 of a mile long. He picked up a sackful of the "stuff."

July 6

Brazel takes his sackful of stuff to Sheriff Wilcox in Roswell; Wilcox calls Intelligence Officer Jesse Marcel at the base and Marcel comes into town to investigate. Marcel decides to follow Brazel back to the ranch and they stay in a cabin that night.

July 7

Brazel and Marcel investigate the debris site on the ranch. Marcel stops at his house and shows his son (age 11, Jesse Jr.) some of the stuff. Marcel shows the stuff to his boss, Col Blanchard.

Glenn Dennis gets a call from RAAF about the number of child-size caskets he has in stock, and when could he get more; the base also called other times on how to preserve bodies that had been exposed to the weather—strictly for future reference. Glenn Dennis took an airman who had been riding on a motorcycle and hit a cattle truck to the base hospital and saw strange stuff in the back of ambulances.

Glenn went into the hospital and saw his nurse friend who said to get out of there immediately. He was escorted out of there by the military, with threats to his life.

July 8

Col. Blanchard, head of RAAF (Roswell Army Airfield), told his PR officer, Lt. Walter Haut, to issue the press release (2 PM) about the UFO recovery. The military philosophy was to inform the public that the craft was not there anymore so the public would not attempt to explore the Brazel site.

Marcel takes some of the debris to Ft. Worth to Gen. Ramey. Gen. Ramey spreads the debris on the floor of his office, tells Marcel to step out of the room for something, and when Marcel returns, the debris has been replaced with weather balloon debris. Ramey tells Marcel not to speak and the disclaimer photo is shot (4 PM, for the July 9 newspapers).

During the period of July 9–12, Brazel is held by the military so they could "inspire" him to modify his story to that of a crashed weather balloon. Brazel died remaining silent on this event.

Glenn Dennis met the nurse (per appointment) and she drew what she saw—big eyed alien—on the examining table; she was taking notes. She was transferred the next day to England and was declared dead soon after that (by the military).

July 9

Gen Ramey issues a press release to the AP that the saucer story is just a weather balloon. "Pappy" Henderson, pilot, flies the alien bodies (that he saw) from RAAF to 1) Wright Patterson AFB in Dayton, OH, or 2) Denver, CO, or 3) Ft. Worth, TX.

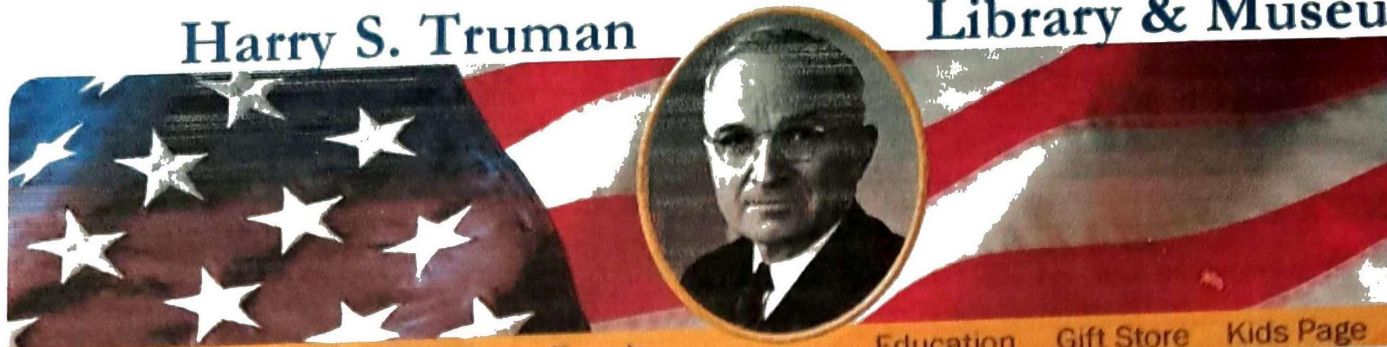

MR. ROSS'S
PRESS AND RADIO CONFERENCE
JULY 7, 1947
AT 10.35 AM EDT
MONDAY

MR. ROSS: The Message on displaced persons about which I have received so many inquiries lately will go up today and be ready shortly.

Q. Do you know how long it will run, Charlie?

MR. ROSS: No, I don't. Do you, Eben? Have you seen the text?

MR. AYERS: Runs about two pages -- full pages.

MR. ROSS: 600 words?

MR. AYERS: More than that -- perhaps a thousand.

MR. ROSS: You mean two mimeographed pages.

Q. Does it have to do with the RRO or the whole question?

MR. ROSS: You will have it in a very few minutes.

Here are two nominations, both re-appointments, for release when delivered to the Senate: Joseph T. Botava, of Nebraska, to be U. S. Attorney for the District of Nebraska, and Joseph E. Proudfit, of Nebraska, to be U. S. Marshal for the District of Nebraska -- both re-appointments.

The President has just signed an Act for the establishment of a commission on organization of the Executive Branch of the Government. That was the bill regarding which Senator Lodge and Congressman Brown of Ohio, came in to talk to the President the other day.

Q. Do you know that number?

MR. ROSS: Joint sponsors of it. H.R. 775. Also H.R. 3611, an Act fixing and regulating the salaries of teachers, school officers and other employees of the Board of Education of the District of Columbia. That's all I have.

Q. Charlie, do you know when the President's next economic report will go up? Is that imminent?

MR. ROSS: I shouldn't say it is very imminent, but it is in the works. The economic council is working on the report. Just what program they have followed, I don't know. I suggest you talk to Director Nourse about his plans.

Q. Charlie, the law ---

MR. ROSS: (adding) I know they are at work on the reports.

Q. The law doesn't require another report to Congress itself at this time, does it?

MR. ROSS: It is my understanding it will be a report to the President, but again I suggest you consult with the council itself.

Q. I believe that Brown-Lodge bill calls for appointment of members of the commission, part of them by the President?



MR. ROSS: That is correct.

Q. Has he made any decision on appointments?

MR. ROSS: Oh Heavens, no. The bill has just barely been signed.

Q. How about the labor board?

MR. ROSS: None today.

Q. That is Brown of ---

MR. ROSS: (interjecting) Ohio.

Q. Ohio.

Q. Can you tell us about some of these people coming in today?

MR. ROSS: Webb is coming in on budgetary problems. He is now with the President. Vice Admiral Lockwood, retiring voluntarily from the Navy, coming in to say farewell.

Q. Do you know what his assignment is now, by any chance?

MR. ROSS: I don't.

Q. Judge Advocate General?

Q. No, Inspector General.

MR. ROSS: The Secretary of State is coming in for his regular Monday appointment at 12.45. At 12.30 former Ambassador McNutt is coming in, and at three o'clock Gordon Clapp, Chairman of the Board of Directors of T.V.A., and Lieutenant General Wheeler, Chief of Engineers, and Major General Pick of the Army Engineers, coming in to discuss problems of flood control, with particular reference of course to those recent floods in the Missouri and Mississippi valleys.

Q. Any White House angles on the flying saucers?

MR. ROSS: On what?

Q. On the flying saucers?

MR. ROSS: Flying saucers?

Q. Three columns a day they have been printing?

Q. That's the new serpent of Lochness, Charlie.

MR. ROSS: I thought you meant the flying trip back from Charlottesville. I read that he came back at 65 miles an hour, which would have landed the President, in the time taken, somewhere in the vicinity of Annapolis, I take it.

Q. Well, Charlie, if you touch 65 occasionally you don't necessarily average 65, isn't that ---

MR. ROSS: (interposing) "President maintained a steady speed near 65 miles an hour."



Q. I didn't see that one.

MR. ROSS: Do a little simple arithmetic. It took two hours and 45 minutes to get back. If you maintain a steady speed of 65 miles an hour, you would have got here in a little under two hours, instead of two hours and 45 minutes. As a matter of fact, the speed was about 50 miles, except occasionally in passing, under the direction of the police, he hit 60, slowing to 35 through built-up places.

That's all.

AT 10.40 AM EDT
WEDNESDAY

Q. What's the latest on the discs, Ross?

MR. ROSS: I have heard nothing this morning.

The President has signed the appropriation act for the Departments of State, Justice and Commerce, and Judiciary, together with other - - -

Q. (interposing): What's the number of that one?

MR. ROSS (continuing): -- Acts. That is number -- H.R. 3311. There will be a press and radio conference at 10.30 tomorrow.

Q. Do you know how much that appropriation is for, Charlie?

MR. ROSS: Not at the moment. I will find out. Any questions about this list?

Q. Just why are they all coming in? (laughter)

MR. ROSS: I don't know why Senator Hatch is coming in. Msgr. John Patrick Carroll-Abbing is the founder and director of Boys Town of Italy, and acting representative in Italy of American relief for Italy. He is an American citizen. I have something about him here. He is on a tour of the United States. He is acting foreign representative of American Relief for Italy, Inc., which organization has forwarded more than 60 million pounds of vitally needed supplies for free distribution to destitute people in Italy.

Q. 60 million pounds?

MR. ROSS: 60 million pounds. He has also worked toward the rehabilitation of homeless and orphaned children in Italy with various projects including the Boys Town. That seems to be about all.

Q. Do you know what Burton Wheeler is coming in for?

MR. ROSS: No, I do not. He simply asked for the appointment.

Q. Is there any stunning political significance in the visit of the New York Herald Tribune publisher?

MR. ROSS: No stunning political significance, no.

Mrs. Reid, I understand, has lately returned from Europe and wishes to tell the President about her observations over there.

Q. What about Secretary Snyder and Webb?

MR. ROSS: That has to do with problems of the Budget.

Q. What's troubling the Democrats down in the southwest?

MR. ROSS: Nothing, particularly, just one of those series of meetings with party leaders.

Q. Dewey is getting them roused up down there, isn't he?

MR. ROSS: I don't know where he is. This is one of a series of meetings arranged by the Democratic Committee.



Q. Been going on for four months now.

MR. ROSS: One of several groups that have been here.

Q. I don't think but one or two sections of the country are left.

MR. ROSS: I think the country has been pretty well covered.

Q. Series of ten from the start.

MR. ROSS: Yes.

Q. Charlie, the Democrats started out with a program of ten of these meetings. Do you know whether this is the last one or not?

MR. ROSS: I don't know. John Redding can tell you about that. I think this is near the end.

Q. Thank you, sir.

Q. Thank you, sir.



Congress to be called back, it will be called. I don't anticipate that there will be any necessity for it.

[8.] Q. Mr. President, have you seen any flying saucers?

THE PRESIDENT. Only in the newspapers. [Laughter]

Q. Any explanations of them from over here?

THE PRESIDENT. Only the explanations I have seen in the newspapers. Did you ever hear of the moon hoax?

[9.] Q. Mr. President, do you have any comment on the contract signed by the United Mine Workers and the owners of the coal mines?

THE PRESIDENT. No comment. That is a contract strictly between the owners and the miners. I have no comment on it.¹

Q. Is there a study being conducted within the Government, sir, as to the effect that might have on the general level of prices?

THE PRESIDENT. None that I know of. Mark Sullivan probably can tell you. [Laughter]

[10.] Q. Mr. President, what are the prospects for a trip west this fall?

THE PRESIDENT. None.

Q. Next spring, Mr. President?

THE PRESIDENT. None.

Q. Mr. President, have you decided anything about this trip across the country this fall with party leaders?

THE PRESIDENT. I was just saying that no plans were made for any trip anywhere.

[11.] Q. Mr. President, there was a story broke yesterday about this disappearance of the atomic energy secret papers. There are still persistent rumors this morning that the—in some publications—that the White Sands—rather Los Alamos was not the only one. Have you had any—

THE PRESIDENT. I think Senator Hickenlooper very clearly explained the situation in his statement to the Senate. He is chairman of that committee, and I am perfectly willing to accept his statement on the matter. They have been investigating it.¹

[12.] Q. Mr. President, what is your attitude toward the political arrests in Greece?

THE PRESIDENT. I have no attitude.

[13.] Q. Mr. President, have you heard about Roger Slaughter's speech saying that there would be a scandal breaking on this administration?

THE PRESIDENT. All I know about it is the memorandum that you sent in to me, Tony.²

[Laughter]

Q. That's below the belt!

THE PRESIDENT. I consider the source of the remarks which you said were made in the speech by Mr. Slaughter, so it doesn't worry me any.

[14.] Q. Mr. President, Congress and congressional leaders are attempting to get away the 26th of July. Do you see any reason why they shouldn't?

THE PRESIDENT. No, I don't see any reason why they shouldn't. Congress understands it much better than I do.

Q. There has been discussion as to whether they should recess or adjourn.

THE PRESIDENT. Well, that is up to the Congress. That is none of my business. I don't intend to adjourn them myself. [Laughter]

[15.] Q. Mr. President, on this special session this fall, with the Marshall plan being discussed and probably some plan to evolve out of Europe, wouldn't that more or less necessitate some sort of action—

THE PRESIDENT. The—if the necessity arises we certainly will take whatever steps are necessary.

Wants to concentrate all expansion in a little bunch in Texas and take over fields that belong to ^{CIC} commands like Brooks and Bergstrom. General Chauncey says that it is possible we will have to give up the two in Georgia. Gen Chauncey stated he advised Gen Cannon to put his wants in writing and not to telephone as Gen Chauncey feels Gen Cannon is not too sure of himself, as two months ago he wanted to get out of San Marcos and now he wants it and also Brooks & Bergstrom.

10:55A.M. Mr. Zuckert re civilian personnel and limitations and personnel at inactive installations or installations which we are not planning to retain in our permanent structure.

- 1:10 P.M. Mr. Hicks of the Toronto Star, Toronto, Canada on phone - He spoke in regard to the "flying discs". They understand these discs are a U.S. plane that is still on the secret list. He asked Gen. Van what he thought they were and Gen. Van was quite noncommittal. Gen. Van said that some National Guard Planes were on duty on their own volition to search for the discs, but that no planes have been put on duty from Hq, AAF.
- 1:20 P.M. General Tommy Power
- 1:40 P.M. Cong. Drewry of Va. on phone requesting a B-29 be sent to Blackstone, Va. for a celebration by the CAF and volunteer fire organizations in the vicinity. Date - July 27. May be able to do some recruiting on that day. Gen. Van said he would look into the matter and advise Mr. Drewry's office.
- 1:50 P.M. Mr. Leo on phone re article on "Saucers". Said one had been found with instructions on it to get in touch with Colonel Frank Hackett in Spokane. Mr. Leo reported the matter to General Schulgen, G-2.
- 1:52 P.M. Mr. Zuckert on phone informing him with reference to National Guard that all places where we haven't squadron or group headquarters should take their people away.
- 1:55 P.M. Mr. Leo and General LeMay with reference to discs.
- 2:00 P.M. Colonel Frank Hackett, Spokane, Washington on phone - General Van informed Colonel Hackett that we had gotten a call from the Houston Chronicle saying that a flying disc had landed there with his (Colonel Hackett's) name on it. Gen. Van asked if he knew anything about it. Colonel Hackett stated that he knew nothing at all about it. Gen. Van told Col. H. that it was reported here that Col. H. said that his people knew all about it and that a statement was coming out from Washington. Col. H. said, "I have said nothing". Col. H. had the Chronicle called and told to get in touch with the F.B.I. - get photographic proof - and then get in touch with Gen. Twining.
- 2:20 P.M. Colonel Bob Warren, Ellington Field, Tex on phone. - Gen. Van informed Col. Warren that the Houston Chronicle had found a disc about 20" in diameter and 5 or 6" thick. It is supposed to have Col. Frank Hackett's name on it. We are most anxious to explode this thing. I would appreciate it if you would get in touch with the Chronicle, ask them where it is, go out and see the thing and then call me back. The line of approach is that we have nothing like that, we don't understand what it is, but we are leaving no stone unturned to be sure. Colonel Warren said it would be a couple of hours before he could call back.

July 7, 1947 (Cont'd)

2:30 P.M. To airport to meet Mr. Symington and then to Mr. Symington's office.

4:10 P.M. Returned.

4:15 P.M. General O'Donnell

4:20 P.M. General LeMay

4:20 P.M. Col. Warren called back re Gen. Vandenberg's directive that he run down the story about the flying discs. Col. W. finally located the reporter who picked up the story from another man. This man lives in Goose Creek. He now says that it was entirely a figment of his imagination and that he just made it up. Col. W. talked to a Mr. Evans who is handling this thing at the Chronicle — and they took it up with somebody up at the Air Depot at Spokane. - - - He said to them that he just made the thing up. Col. Warren said that the Chronicle seemed to be satisfied that the thing was just a cock and bull story. Col. W. is going to check with the local F.B.I. and possibly drive over to see the man at Goose Creek. If anything further develops he will call Gen. Vandenberg.
