Dear Mr. Cameron:

This concerns your November 7, 2018 request made pursuant to the Mandatory Declassification Review (MDR) provisions of Executive Order (EO) 13526.

MDR requests must meet certain standards in order to be considered valid. A valid MDR request must describe the document containing the information with sufficient specificity to enable the agency to locate it with a reasonable amount of effort (*See* EO 13526 § 3.5). Additionally, requests for broad types of information, entire file series of records, or similar non-specific requests, may be denied for processing (*See* 32 CFR § 2001.33). Based upon these standards, your request for records regarding William L Moore Jr does not meet the specificity requirements of the EO nor its implementing directive, 32 CFR § 2001.

Should you still desire to obtain records regarding William L Moore Jr, you may make a request for the information under the provisions of the Freedom of Information Act, or you may narrow the scope of your MDR request

On March 1, 1983, William Leonard Moore, Jr., was interviewed at Prescott, Arizona. During the interview, Moore provided the following information:

Moore advised that while living in Minnesota, he decided to move to Arizona. Originally, Moore wanted to move to the Tucson, Arizona area, but upon hearing several people recommend Prescott, he made his decision to leave his teaching job in Minnesota and move to Prescott, Arizona. At the time of the move, Moore was doing well financially and felt it to be a good move. However, currently he is feeling a temporary financial pinch and wishes he had moved to Tucson, Arizona, because Prescott is an economically depressed area.

Moore stated he is currently doing research in order to publish another book. When asked about the subject matter, Moore graciously declined to give that information, indicating that writers maintain such matters confidential because one's ideas tend to "pop up" in other authors' writings.

Besides working toward authorship of another book, Moore also maintains a small publishing and duplicating business. This allows him to sell his writings, including his books, as well as sell articles and documents he receives from governmental agencies. According to Moore, he requests, under the Freedom of Information Act, documents which have been declassified from many U.S. Government agencies, i.e., FBI, CIA, OSI, NSA, and NASA. After he receives these documents, and upon request, he will duplicate these declassified documents and sell them to interested parties. Moore advised that some of the documents still bear their classification, (i.e., Secret, Top Secret), however, all have been marked through indicating that they have been declassified.

On one occasion, Moore duplicated a declassified document which bore a "Secret" classification. Upon duplicating the document, the markings used to indicate that the document was no longer classified secret, did not show up on the copied document. Moore sent a copy of this declassified document to an individual in California. This particular individual worked for a government contractor, and, the gentleman from California who received the document immediately took it to his security officer, and for awhile all believed Moore had made an unauthorized

disclosure and had in his possession unauthorized classified documents. Moore stated that he now makes sure that this does not happen when he duplicates documents.

Moore declared that he has never had in his possession any classified documents from any government agency. Moore did admit, however, that individuals had made unauthorized verbal disclosures to him; however, Moore denied ever using that information or passing it along to anyone else.

During the interview, Moore expressed his loyalty to the U.S. Government and indicated that he would not like to live anywhere else in the world. However, Moore believes that U.S. Government agencies have much more knowledge about the existence of UFOs than they freely admit. According to Moore, the U.S. Government is always trying to discredit their own findings and research in this field. Moore thinks that the U.S. Government has even gone so far as to give disinformation about the topic. Moore also feels that the reason for the government's attitude in this area is for one of two reasons. The first, which Moore feels would be legitimate, is that in their research or findings, the U.S. Government has obtained information or received data concerning highly developed technology. Therefore, the government wants to keep this information secret because to divulge this information could jeopardize the national security. The second reason for the government's current attitude, is that they are actively conducting research and in the process have uncovered substantial facts indicating that UFOs do indeed exist. However, the U.S. Government is attempting to hide the fact that they have an official interest in this area because to do so would lend credibility to the existence of actual UFOs. This reason, according to Moore, is not an acceptable reason for the U.S. Government to keep this information secret. He feels such information could be sanitized and should be exposed to the general public.

Dear Mr. Moore:

You appealed from the action of the Federal Bureau of Investigation on your request for access to records pertaining to yourself.

After careful consideration of your appeal, I have decided to affirm the initial action in this case. The documents responsive to your request are exempt from the access provision of the Privacy Act of 1974 pursuant to 5 U.S.C. §552a(j)(2). See 28 C.F.R. §16.96(a) (1987). Accordingly, your access rights are limited to those provided by the Freedom of Information Act.

You are the subject of one Headquarters main file. Certain of the material pertaining to you is classified and I am affirming the denial of access to it on the basis of 5 U.S.C. §552(b)(1). This material is being referred to the Department Review Committee for its review and a determination whether it warrants continued classification under Executive Order No. 12356. You will be notified if the Committee's final decision results in the declassification of any information. Other materials were properly withheld from you pursuant to 5 U.S.C. §552(b)(7)(C), which pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties, in this instance by revealing the names of Bureau agents and employees. This information cannot be the subject of a discretionary release.

Judicial review of my action on this appeal is available to you in the United States District Court for the judicial district in which you reside or have your principal place of business, or in the District of Columbia, which is also where the records you seek are located.

WILLIAM MOORE'S "SECRET" FBI FILE!

The documents reproduced on pages 3-8 speak for themselves. For the information of our subscribers, the facts are as follows:

On February 1, 1988 a request was initiated with the Federal Bureau of Investigation under the provisions of the Freedom of Information/ Privacy Act. On March 1, an initial reply was received indicating that the request was being processed. A follow-up letter arrived on April 6th indicating there would be some delay in fulfilling the request due to a large backlog. The surprise came on July 6th when an official-looking packet arrived. Inside was a cover letter which stated that a 61 page dossier had been located, that the entire file was classified "Secret" for reasons of National Security pursuant to Executive Order #12356, and that, all but heavily expurgated versions of six pages were being properly withheld under exemption B-1 of the FOI/PA. Exemption B-1 deals with information which is exempt from disclosure for reasons of National Security-- as opposed to exemption B-7 (potential disclosure of confidential sources and methods), which is more commonly encountered in personal file cases such as this.

Mr. Moore's UFO-related activities are clearly the subject of interest here. Why 55 of the admitted 61 pages of material remain classified as a matter of National Security remains a mystery. On August 3rd, an appeal of this denial was filed by letter, and on September 27th, 1988 we were informed that "the initial action in this case" was affirmed and that the appeal was thus denied. We were also informed that judicial review was an option available to us should we choose to pursue the matter in the Federal Courts.

The material which appears on the pages that follow is reproduced exactly as it was received from the FBI. The addition of the word FOCUS with appropriate page numbers are the only changes which have been made. This is the first time we have made copies of this file available to the public. We urge you to study it carefully and consider the possible implications-- then decide for yourself what it all means. FWP takes no position one way or the other, except to note that we remain quite baffled by all of this. Obviously there is plenty of fodder for speculation here. Letters from readers who might care to express their thoughts are welcome.

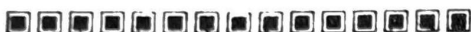

disclosure and had in his possession unauthorized classified documents. Moore stated that he now makes sure that this does not happen when he duplicates documents.

Moore declared that he has never had in his possession any classified documents from any government agency. Moore did admit, however, that individuals had made unauthorized verbal disclosures to him; however, Moore denied ever using that information or passing it along to anyone else.

During the interview, Moore expressed his loyalty to the U.S. Government and indicated that he would not like to live anywhere else in the world. However, Moore believes that U.S. Government agencies have much more knowledge about the existence of UFOs than they freely admit. According to Moore, the U.S. Government is always trying to discredit their own findings and research in this field. Moore thinks that the U.S. Government has even gone so far as to give disinformation about the topic. Moore also feels that the reason for the government's attitude in this area is for one of two reasons. The first, which Moore feels would be legitimate, is that in their research or findings, the U.S. Government has obtained information or received data concerning highly developed technology. Therefore, the government wants to keep this information secret because to divulge this information could jeopardize the national security. The second reason for the government's current attitude, is that they are actively conducting research and in the process have uncovered substantial facts indicating that UFOs do indeed exist. However, the U.S. Government is attempting to hide the fact that they have an official interest in this area because to do so would lend credibility to the existence of actual UFOs. This reason, according to Moore, is not an acceptable reason for the U.S. Government to keep this information secret. He feels such information could be sanitized and should be exposed to the general public.

In his statement, he indicated that it was his intention never to divulge any information which would do damage to the U.S. Government or endanger the national security.
