Operation White: Official UFO Disclosure Program, Early 1950s to late 1980s ?

It has been reported that Operation White was a program to release information on the UFO story to the public. It was created back in the early 50s. "The Day the Earth Stood Still" was the first movie made for this purpose. Over the years, the program involved movies, books and newspaper articles. Both "The Day The Earth Stood" and "Close Encounters Of The Third Kind" were based on real contact events that reportedly occurred in the early 1950s with Truman and Einstein the principle players (there was also another reported contact at Edwards AFB, CA in 1954 between Ike and tall blondes as well) and again in 1964 under the Johnson administration. Einstein we are told was instrumental in setting up those first contacts between Truman and the aliens. The first contact took place in the desert having the contact site surrounded by army troops with looming clouds that rolled in (no bells or whistles like in the movies) just before the "craft" landed and a tall blonde stepped out. All the army troops could see supposedly was a pin point of light but none of the contact parties. In 1983, one of my sources was briefed into a special compartmentalized program that involved the dissemination of information to the public. The slow "official" release of information continued as of the late 80s when it was cancelled by we think the elder Bush. We believe that part of the reasoning for canceling the "official" disclosure program and then proceeding to plug "leaks" reference Mj12 was to allow certain corporations and individuals to gain monetarily from all the reverse engineering efforts and that any type of "official" disclosure has been put off to 2006.....

WORRIED PENTAGON BENDS OVER BACKWARDS TO HIDE SAUCER EVIDENCE:

1954's new look was the sky-look. More people of all races became sky and space conscious ... and many thousands, looking skyward, saw something incredible! Others, scoffers back in 1948 or 1953 watched and waited, some fearfully. Most all, however, were convinced; something or someone was watching, something materially existed, and, someone of high intelligence had a purpose. While many could read something serious between the lines of official denials and double-talk, others, perhaps a handful knew the real meaning of it all. Of course, a few having made contacts with space-men, also said they knew, but most of us just guessed. Whatever the purpose, the hard core of bona fide evidence remained sealed under official lock and key, and as 1955 ushered in, most all world governments were "seriously" investigating saucers and were bending over backwards to keep the truth from the public.

THE O'MARA INCIDENT: During early 1954 with the Pentagon still smarting from the wallop of Major Keyhoe's best-seller, saucer sightings in the USA were increasing. While the Office of Public Information (AF) dismissed these with a ho-hum, representatives of major airlines met in Los Angeles (Feb. 17) with intelligence officers of the Military Air Transport Service to speed up saucer reporting procedures. According to Jim Lucas, Scripps-Howard reporter, the idea was to get the reports in the quickest way so that the Air Force could speed jet intercept.

With the public more confused than ever came the revelations of Col. John O'Mara, Deputy Commander, Intelligence, Wright-Patterson Field. Most remember his statement through CRIFO of "700 sightings a week" -- a news shot that was heard around the world. But this admission was just a part of the O'Mara Incident. It all started last June when Truman Bethurum and George H. Williamson, both having alleged contacts with interplanetary intelligences, were lecturing in Cincinnati. Challenging their stories in his effort to separate fact from fiction was Cincinnati's Thomas Eickhoff. In forcing a showdown, Eickhoff visited Dayton June 7, and, gained an interview with Col. O'Mara. Here, O'Mara implied to Eickhoff that the lecturers were fraudulent, and among other topics, said that Major D. E. Keyhoe's late book, Flying Saucers From Outer Space, was based on material not officially cleared and that the remainder of this book was a product of his imagination. The next morning this writer phoned Col. O'Mara and got similar statements, and others of significance which I conveyed in the July Newsletter.

In the months following, unknown to CRIFO readership, "inside" forces were at work. In question now was the veracity of the material used in Keyhoe's book. Keyhoe, desiring his name cleared of the calumny, asked Eickhoff and myself for affidavits of the O'Mara statements. These he would use in Federal Court, if necessary, to stand as evidence, along with other letters in his possession which proved that the material used in his book was officially cleared by the OPI and/or the Directorate of Intelligence.

On Sept. 21, this writer learned in a second interview with a cordial O'Mara that flying saucers "do exist". He said that a pronouncement would be made soon, explaining the phenomena. Then following his suggestion I asked the

Defense Dept. by letter for clearance on several cases. Meanwhile, the O'Mara admissions (see Oct. Newsletter) made the world circuit and for the first time in seven years, the AF appeared ready to take the public into its confidence. However, on Sept. 29, Major Keyhoe wrote me and said that he had called OPI and asked for "details" of the forthcoming release. He was told that they had my letter regarding sightings O'Mara promised, and, "had turned it over to Intelligence". Then Keyhoe wrote: "They said they didn't know what O'Mara was up to

On Oct. 9 came the official word in rebuttal to the O'Mara statement. In brief it said that saucers exist only in people's imaginations. Chagrined, I wrote to the office of General Samford, explaining that I could prove certain saucer evidence, and asked again for clearances on cases previously requested. Nothing happened.

Early in Nov., Major Keyhoe wrote the Defense Dept. demanding that O'Mara retract his statements or face law suit. Meanwhile, certain evidence had reached Eickhoff indicating that saucers were devices not of an interplanetary origin. Having heard nothing more on the O'Mara action from Keyhoe, Eickhoff then decided on some legal action of his own. He, in a letter to Lt. Col. Bloomer at the Pentagon chose to contest the authenticity of the cases in Keyhoe's book and the letter on Defense Dept. stationery by Albert Chop which appeared on the jacket of the book. What Eickhoff wanted to know, essentially, was who was telling the truth. On one side was Col. O'Mara who in June said that Keyhoe's material was not officially cleared; on the other, was Keyhoe who claimed the cases were cleared. For the Air Force to admit the latter was, in a sense, admitting much, and to admit less meant that Eickhoff would take the case to Federal Courts -- involving everybody in a real showdown. The Air Force could not allow this to happen. Frantically, somebody high up had to do something fast.

Following is what happened. Quoted in part is the O'Mara letter of retraction to Tom Eickhoff, copies to Keyhoe and this writer.

"Dear Mr. Eickhoff: Nov. 30, 1954

"I have been informed by the Office of the Directorate of Intelligence, Hq., USAF of a letter which you wrote on Nov. 22 to Lt. Col. Bloomer . . .

"... First of all, as you will recall, the stated purpose of your visit to me in Dayton was to request my assistance in challenging the expressed opinions of certain organizations and private individuals regarding unidentified flying objects . . . it is not now, and never has been a policy of the Air Force to comment on the theories or conclusions of private individuals or organizations on the factual data which has been released as a result of Air Force investigations in this field.

"... This book (Flying Saucers from Outer Space) does contain among other things a number of officially released reports by the Air Force related to unidentified flying objects. It also contains the opinions of the author regarding the observations reported and the right to such expression is guaranteed to him and to any other citizen . . . I did indicate to you that I as an individual might hold different opinions than those attributed to Major Keyhoe and others, but certainly not that he or others were frauds and liars . . ."

"The viewer perceived "lots of entities rushing around trying to fix things. This has to do with moving a large group of people to safety. This feels like the Earth's future and what needs to be done in order to survive. This is on a large scale."

"The viewer sensed that the event had a devastating effect on the economy. "This takes people's breath away. They are hushed as an initial reaction.

- 1) a key government leader, identified in the heading as the President, is holding a meeting to discuss the "coming arrival of something from space", something from outer galactic space.

"Soon into the session, the viewer perceived the emotions of fear, amusement, and terror at the target site, and sensed that the event involved an organized mission. There were people at the location, and the viewer perceived that a rescue attempt was

underway. The viewer deduced that the event involved Martians and a volcano. " [Again, we have the issue of Mars introduced into the scene. As we revealed in NEWS1029, "Life On Mars!? "The viewer continued: 'There is a lot of spin doctoring, bending information and misleading people.' The military is tempted to use more force than is needed, and there are some regrettable events. The government has some difficulty controlling the military." [Chaos in the streets is getting so bad that the military steps in to seize control back, causing some 'regrettable events'. Is this when our guns are confiscated and Patriots and Fundamental Christians rounded up?]

Now, let us review the fourth SRV, which will deliver the final punch to this future scene. In this fourth SRV, we are told more bluntly what is truly going to happen.

Scientific Remote Viewing (SRV) -- Session Four

"Farsight Professional 4: The ET Event

"NOTE: All SRV sessions are conducted blind. The viewer does not know what the target is until the session is over. "

"The target cue for this session was 'U.S. President/Post Election ET Announcement.' "

"Soon into the session, the viewer heard whooshing sounds. The smells associated with the site were smoky and sweet. The viewer immediately drew a sketch showing swirling energy and people. The viewer perceived that the event involved a group of people

who were hurried. The emotions at the site were those of acceptance, self deception, and resignation ..."

"The viewer then drew a sketch showing people watching a central figure, with a radio telescope in the background. (See sketch 1 below.) The viewer sensed that 'somebody doesn't know why something is happening. It is mysterious.' There were very

emotional people at the target site and in the viewer's words, they were 'going through the emotions without reasoning. People are outside, but something they need is hidden inside.'

"The viewer then deducted that the target event involved President Clinton and the government announcement that ETs were real. [Now, the true goal of this entire lying scenario is boldly stated: the objective of this Presidential News Conference was to convince people that ET's are real, that they are friendly, and to have them visibly appear]

The viewer perceived voices, clapping hands, and loud banging. There was a central figure at the site who was a leader. The emotions surrounding the event were terror, fear, excitement, and sorrow. There is a unity of some, and sorrow for the disruption of the lives of others. There is a great distraction due to changes which are inevitable. The central figure will emerge as a strong, vibrant leader due to necessity and destiny."

"The viewer perceived concepts of tolerance, solidarity, unity, purpose, destiny, and guidance. In the viewer's words, 'The surrounding people are supportive because they must have a leader. The leader is a good person and rises to the needs and desperation of the people. There are subspace beings involved and watching the unfolding of the events. They are in communication with the leader and he is aware that they are communicating. These beings are not the target, but are very intricately involved in shaping the leader's opinion, thoughts, and ultimate actions. They are influencing because it is crucial, not out of any selfish motivation. All communication is mutually beneficial and symbiotic.' " [Isn't this sweet? Now that the Aliens are here on Earth, and are exerting their influence upon our society, we now will experience a new Garden of Eden! But, wait, what is that still, small voice I hear? It is the voice of Biblical prophecy warning about Antichrist and his claims, "he shall magnify himself in his heart, and by peace shall destroy many:" Daniel 8:25. Remember this warning: by peace he {Antichrist} shall destroy many".]

"The viewer then focused on the target event, and perceived a group of people experiencing chaos and unrest. There was

division and uncertainty associated at the target site, and the emotions were those of terror and excitement. 'The event is not bad or negative, but is perceived so by many due to lack of vision and true understanding of what is happening. Many are too fearful to open their eyes and hearts.' " [Could this group of people possibly be us, the Fundamentalist Christians, who have been too often charged with having no proper vision and no understanding, and of being too filled with fear? Are these the people of whom Bill Lambert stated in his seminar, that will be snatched into another dimension because we could never accept the claims of The Christ? Read NEWS1052, "Seminar Notes: House of Theosophy, 8/18/91". This might be the Rapture of the Church!!]

"The viewer perceived a sense of loss and gain. 'The event has great and far reaching results in the evolution of the planet than any of the immediate participants feel. Evolution is at stake. A window has opened and the event is seen through it by all.' " [As we stated in our article on Mars, the real objective in conditioning people to believe on life on Mars is to convince them that Christianity is false when it teaches a uniqueness of creation on Planet Earth, and when it teaches Creation rather than Evolution]

"The viewer deducted that the event involved the government, the greys, and the Martians. The viewer sensed the target person would 'do what is necessary for the betterment of all.' There was a strong female influencing and assisting the target person. [Mrs. Clinton?] In the viewer's words, there is a 'male/female balance in leadership that brings strength.' "

"The viewer then drew a sketch showing many spaceships above a group of people on the ground. (See sketch 2 below.) [This scene sounds suspiciously like the scene reported in New Age author, William Cooper's book, "Behold A Pale Horse", where he said UFO's and Aliens would physically manifest themselves to aid the Christ in his appearing.] The viewer perceived that there was 'activity and celebration of the event in both the physical and subspace realms.' " ["Subspace realms" refers to the minds and inner being of people. In other words, just like Bill Lambert said, when Antichrist arises, people will sense him with all five of their physical senses, plus their souls will receive some kind of 'psychic shock' that will reverberate their souls like a tuning fork reverberates!]

"The viewer sensed that the target event involved an announcement, chaos, and upheaval. The event allows 'a minority of

evolved people's views to emerge.' " [What kind of person is described here, the "evolved people"? It is none other than the New Age adherent who has been working and praying and meditating **for this event** for such a very long time. Finally, their occult vision is going to be realized!!

Pentagon by a source who claimed that sensitive UFO data originating with the US government was to be turned over to elements of the media. This provoked some concern on the part of the military, and a copy of the letter was made available to the FBI for action. The letter revealed:

In approximately seven months or January, 1972, certain copies of top-secret documents shall be sent to the New York Times as well as two other newspapers. These documents are related to and will be an ostentation of the involvement of the Pentagon in the controversial 'Unidentified Flying Objects' or 'Flying Saucer' subject. It will show that not only the US Air Force was involved in UFO research but the other military branches as well.

Analysis and the actual conclusions of the classic UFO cases shall be revealed. This shall be accomplished by zeroxed documents and photographs that General Wolfe had reviewed when he was head of the Army's UFO support program in the Pentagon during the Eisenhower years.

Sorry, but it is concluded here that this is the best course to take because we feel that the secret UFO investigations are parallel in nature to the Times-Pentagon-Vietnam controversy. If we are wrong in taking this action, time will tell.

With little evidence to go on, the Bureau simply filed the curious letter, but it is worth noting that in the early to mid-1970s, rumours were rife that the American government was contemplating the release of sensational hitherto-unseen UFO data. The investigator Leonard Stringfield recalled one such occasion in 1974:

I knew that a report was quietly circulating among responsible researchers in late 1974 anticipating such an announcement, perhaps jointly by the US and France . . . I was alerted by Walter Andrus, Director of [the Mutual UFO Network], to be prepared as Public Relations Director, to rush to Chicago, joining he and Dr [J. Allen] Hynek of CUFOs in a press conference if official word was released.

On the suggestion of Andrus, I prepared a tentative press release, got both his and Hynek's approval, and we waited. In my UFOlog entry for December 16, 1974, I noted, 'Wonder what President Ford and Giscard d'Estaing, President of France, are discussing in Martinique beside the oil problem?'

If UFOs were on the agenda we can only guess. The Martinique meeting ended with nothing said about UFOs. The biggest story ever, was never told.¹³

The 'biggest story ever' may not have been told; however, a decidedly unsettling, even macabre, issue was waiting in the wings to task the FBI, as we will see in the following chapters.

Documentation generated by the Bureau in 1977 suggests at first glance that meaningful involvement in the UFO subject on its part was by that time practically nonexistent.

On 14 June 1977, Jay Cochran Jnr, Assistant Director, FBI, Technical Services Division, was contacted by Stanley Schneider of the Office of Science and Technology at the White House and asked about the Bureau's procedures for handling information received which related to UFOs. In a memorandum generated for internal use, Cochran wrote:

[Schneider] advised that Jody Powell of the President's staff has raised the question as to whether or not there is any coordination within the Executive Branch relating to information concerning [the UFO] subject. He stated that the US Air Force had closed their investigation of these matters several years ago and currently does nothing but refer such information to appropriate local authorities.

I advised him that as far as the FBI is concerned there appears to be no conceivable jurisdiction for us to conduct any inquiries upon receipt of information relating to a UFO sighting and, in the absence of some investigative jurisdiction based upon the information furnished, that information would be referred to the Department of the Air Force without any action being taken by the Bureau.
