Dear Sir:

On April 14, we were astonished when as result of your telephone conversation with Major General Robert L. Schweitzer, then with me, your "spiked" our previous Press Release (encl.# 4.) at the media, because the general declared that the National Security Council's response to our Presidential Memorandum - signed by him - and which stated THE "UFOS THREAT" - was a MISTAKE.
