STEVE MICHALAK'S UFO ENCOUNTER EXPLAINED THROUGH MARK-AGE

Since touching an interplanetary spacecraft on May 20, 1967, Steve Michalak of Winnipeg, Canada twice has suffered recurrences of the burns and other symptoms resulting from the initial exposure. The first recurrence was September 15th, when he required hospitalization for less than a day. The second was in mid-January, 1968.

On both occasions, Mark-Age in Miami was asked for assistance. Yolanda, Mark-Age interplanetary and interdimensional communications channel, succeeded each time in establishing mental telepathic contact with, and evoking healing aid by, the occupants of these spacecraft in our atmosphere.

On January 14th, Tukari, commander in chief of the fleets of physical spacecraft in the western hemisphere, gave Yolanda the first explanations and suggestions concerning Michalak's experience. This was in reply to her urgent call for such assistance. Tukari's communication follows.

An hour earlier, Ron Wickers, Mark-Age representative in Winnipeg who has figured prominently in varied media coverage of Michalak's story, telephoned headquarters in Miami to request help during the second recurrence of Steve's ailment.

Steve Michalak's story had received international attention via radio, television, newspaper and magazine coverage. Included in this exposure was the tape-recorded interview Steve gave Ron Wickers for Mark-Age, which was the basis for a syndicated

radio program and a feature article reaching many in the U.S. and Canada.

Additional information about and contacts from Tukari and numerous others are to be found in the enlarged version of the Mark-Age publication, "Visitors From Other Planets", now ready for release in a book and a syndicated series. The following communication is included in these presentations.

TUKARI'S MENTAL COMMUNICATIONS THROUGH YOLANDA

Tukari, answering Yolanda in reply to her emergency request for aid for Steve Michalak, gave the following information.

"He came in contact with one of the scout ships, remotely controlled, for Operation Show Man project. It was not the intention for him to be burned. It was not purposely exposed for his sighting. We were in the process of distilling some minerals in that area for future works in healing and contact work on the physical apparatus of mankind. "It is true we can use many kinds of laser-type beams, ultrahigh frequency sound and light, but these primarily affect the higher bodies of man, the invisible parts of his being. When in contact with the physical apparatus, elements of the physical man must be used. You are properties, in the physical, of the physical elements of your own planet. We cannot use our elements on you but must use your own. This is part of the law of the universe, fundamentally, anyway.

"Tell Steve Michalak that he is in the right area for finding ore of value. Uranium, also, is not far from the spot, although that is not what we were after at that time.

The other substance is of more value to us in our experiments in making crystals from which we can manufacture clothing and jewels with healing qualities and resistance to heat and ultramagnetic waves of the sun, when it comes time for the transmutation of the planet Earth.

"In other words, when the period of transfer is closer to higher, fourth dimensional frequency, many on your Earth will not be able to sustain themselves in the present physical vibratory level. They will have to have assistance, either in the form of covering, through special clothing, or through the assistance of jewels, with healing properties, made of crystallized substances from these metals. Steve may be able to tune in and work with this later.

"Now he must get assistance, himself, to counteract the radiation exposure. First of all, he should burn or bury all clothing and metal objects which he had when in contact with the ship, and within a radius of four kilometers then. These retain the vibrational force emitted from the ship at the time of departure; which was an emergency plan, and not our usual exhaust.

"If he insists, he can bury or secure them in a metal container which should be buried at least six feet deep. As long as he is in physical reinforcement — locked in the radius of the vibration from the equipment — he will be seething from continual exposure.

"This does not affect others, who were not in close contact with the ship. Know and understand this: once an individual has been exposed to the force field, physically, he is charged. This may or may not affect his liver and other functions. But as long as he has other objects continually emitting similar vibratory rates en rapport with

the one he carries with him, the one with which he is charged, it accelerates the effect.

"Later we will explain what he heard on the ship. For the time being, let it be sufficient to know that we were experimenting with vocal commands to the equipment via long distance relay from the monitor ship. Every sound at that time reacted on certain experimental equipment concerning our project of Operation Landing Light, to become effective after June 21, 1967. His interference with the experiment triggered off a mechanism that closed down the project there and caused the sudden departure.

"From this you are right to assume that there is much to be gained in the understanding of vocal or sound remote-control appliances. These already are used frequently in your own computer activities on Earth, but not nearly as much as they could be; and perhaps will be in time, as we get to exchange further equipment and knowledge with you later on in the program.

"You are right to be cautious. We must be, at all costs, for human life. We cannot land without adequate preparations of land, people, animal life, and the vegetable kingdoms that sustain your higher forms of living now.

"You should value our caution and our interest in your highest welfare for now. And we respect you for your intunements with us and whatever cooperation you can give in this soon-to-be-effected landing plan. Love in action, Tukari. Over and out."

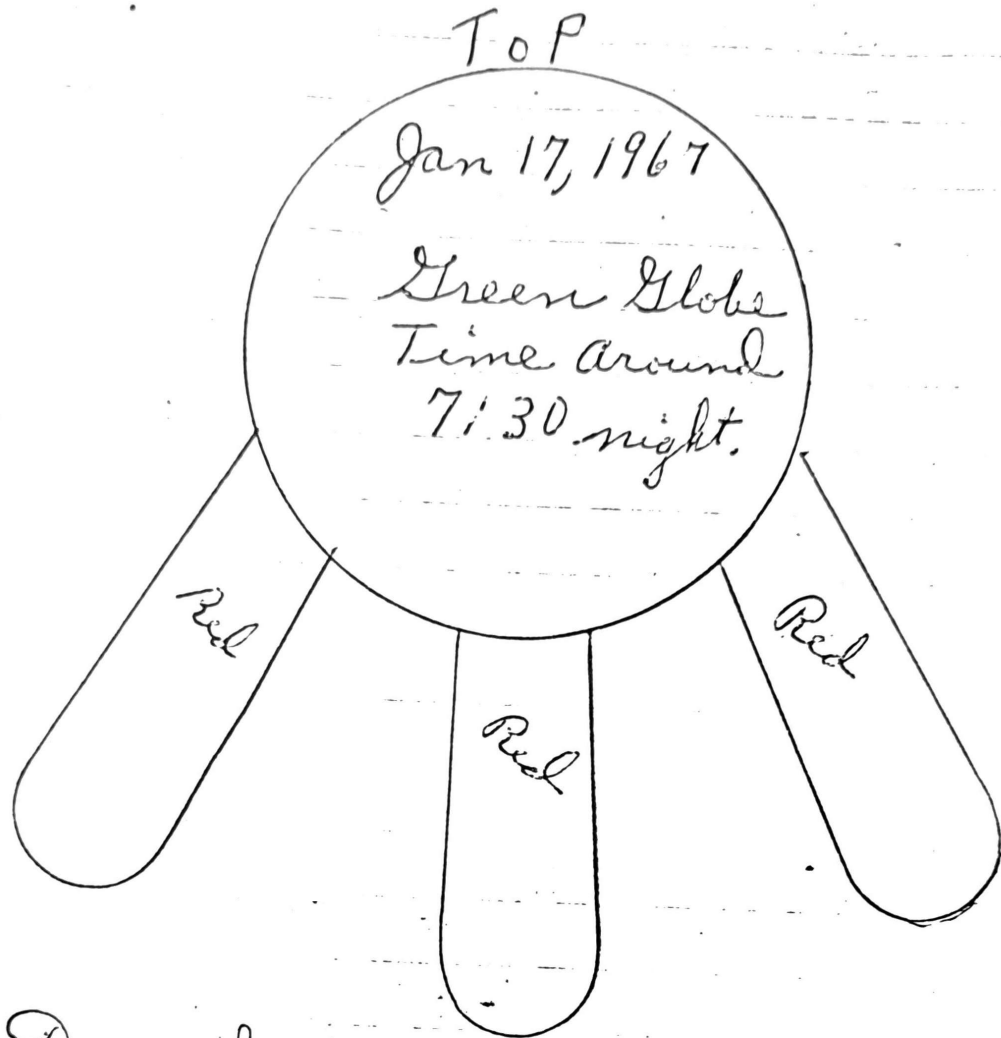

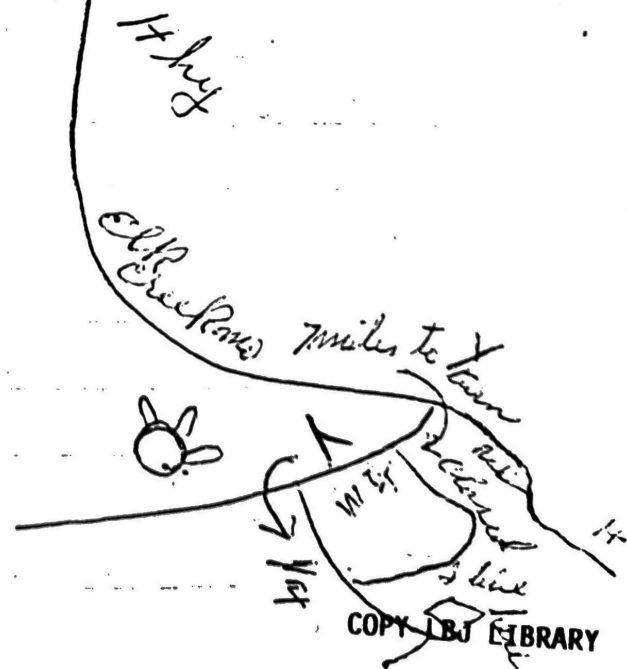

Dear Sir;

We are under invasion by extra-terrestrial beings. As I

watched a fireball hovering at the top of a ridge a mile from my home, I marvelled at the absence of fear, at my almost commonplace acceptance of that phenomenon. Such is the attitude of the American people; except that they are more apathetic than me.

Our leaders have a responsibility to an America greedily grazing like sheep in the shadow of the abattoir, indifferent to the sights and sounds presaging their fate. The question is, are the leaders bell-wether goats leading the flock to slaughter or are we to sound the alarm and steer at least a sizeable portion to safety?

I have been reading about some of the goats: H. Allen Hyman's discrediting of detailed descriptions by reputable observers with a wave of his hand, declaring the Michigan UFOs to be "swamp gas"; David Moody and Hector Quintanilla's echoing "amen"; the work of D.H. Menzel and L.G. Boyd in discrediting bona fide observations... Goats! Deliberately misusing their reputations as men of science to lull a people who want to be told "all is well" so that they can complacently gaze on.

But often the recent articles in "Look" and "Life", and some other publications, the people are dimly aware that something is going on - only, no one has stepped forward to tell them what to do about it.

The space ship that swooped upon the harbor at Perth, Australia (Life, April 1) may have deposited an atomic mine which can be detonated at will. The flying objects hovering over our swamps and lakes may have cached

payload of 100 tons of some mind-distorting chemical of such potency as LSD (one ounce could affect 300,000 people) could send the whole population on a "trip" into madness for several months if that chemical were distributed and released in controlled amounts in our sources of drinking water. (I believe that we are already under some sort of chemical attack; that is why crime and obscenity are increasing so much and why we are so apathetic concerning alarming happenings.)

This is to suggest that the government officially acknowledge the presence of extra-terrestrial flying objects and candidly assess the menace of invaders who have not deigned to establish diplomatic relations or to communicate in any way with us.

I expect that they intend to issue an ultimatum with the threat of destroying our cities unless we comply; when they do officially reveal their presence. Perhaps they will negotiate with the government secretly, threatening destruction if the people are informed. In that case I would pray and ask God for a stay of execution; then inform the people anyhow — they have the right to decide whether to resist or capitulate.

These invaders are probably of the Nazi type, and it would be better to die fighting than to be tortured and exterminated eventually in pogroms.

They may pretend to ally with any or all of the major powers. Their true affinity will probably prove to be for the Chinese Reds. Pacification is out of the question.

Personally I don't think America has a ghost of a chance unless we truly repent of all the wickedness we have done and can prevail upon God to save us.

The government could at least reorganize Project Blue Book, removing the old goats; and could have our harbors and swamps searched and scanned by electronic metal-detecting gear to remove any mines or Trojan horses.

Perhaps you fear a panic. It is almost impossible to

Dear Mrs. Conger:

The President has asked that I reply to your recent letter regarding unidentified flying objects (UFOs), and that I express his gratitude for your support.

I understand that a study of the recent UFO reports from Kansas indicates that these observations were a misinterpretation of natural or conventional objects such as satellites, aircraft, meteors, and astronomical bodies.

The Air Force does not withhold or censor any information on unidentified flying objects. The results of all Air Force investigations have always been made available to bona fide news representatives and scientific researchers. In view of your interest, a copy of a recent report on this subject is attached.

I am told too that in 18 years of investigating over 9,000 reports of UFOs, the evidence has proved almost conclusively that reported aerial phenomena have been objects either created and sent aloft by man, generated by atmospheric conditions, or caused by celestial bodies or the residue of meteoric activity.

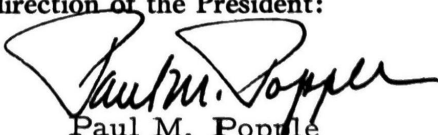

In response to your inquiry, we have searched the White House Central File Name File for correspondence between Lyndon Johnson and Jackie Gleason. There were no letters exchanged. After the death of Nat King Cole, Mr. Gleason called the White House and asked to speak to President Johnson to gain a statement for his tribute to Mr. Cole. There is no evidence that any further contact took place. There are no records of White House visits or telephone conversations between the two. The only other item in the Name File is from a third party who sent a copy of a letter he wrote to Jackie Gleason in response to a derogatory statement made on Mr. Gleason's television program.

Dear Mr Cameron

I thank you for your letter of the 6th. I first started to correspond with G.A. when I was a member of the British Flying Saucer Bureau in Bristol England that I joined in 1952. I had read THE ORIGINAL EDITION OF F/S HAVE LANDED for about a year without thinking of the Portholes reference to this item in an American Publication. Prompted me to study it, so that you will understand my view on this point I shall explain something. Before the war I was in the St Johns Ambulance for 10 years where some knowledge of Anatomy and Physiology is taught. During the war I served as a Nursing Orderly for over 15 years. In the R.A.F. 3½ years overseas, I have one certificate as a Massageur, played various sports, Rugby, soccer, Boxing and Physical culture for the past 43 years so that I am not unaware of the Physical Aspects of the Human species. In the First British Edition of F/S Have Landed written by George Adamski and Desmond Leslie the photographic reproduction was excellent. In the first Photo in two Portholes the faces of a very real Human crew can be seen, naturally after so many years I can see them without the aid of a glass, also in another Photo between pages 112-113, another Human face can be seen looking out through a Porthole. There are very real Human faces and not anything else.

Have enclosed a letter from the former Brazilian authority off on VECs. Don't know if you have seen this.

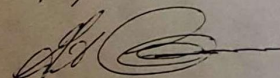
Couple items of interest.
