Dear Arthur:

You received a copy of the NSC letter, because in Canada I believe in your person only, who represents our efforts that first of all the UFO problem must ^{be} solved, then investigate. It reason was your courageous step at your government and at the United Nations, and your favor to trust in our hand these documentations.

I believe with our Second Presidential Memorandum you could make a reasonable action at your Prime Minister Pierre Trudeau, emphasizing your definite aspect in cooperation with President Reagan being in full military coordinated defense with the US in continental defense. You should refer the recent dangerous and provocative action of the UFO forces (Moscow, Brazil, England, Texas etc.) which urge to place after all the UFO cards on the floor of the nations conference table.

Please do not mention yet the positive answer of the NSC, because WE ARE IN ACTION AT THE NSC. Jerome Eden, president of the PPCC (Planetary Professional Citizens Committee) requested for both of us "personal conference with the distinguished members of the NSC to explore the possibilities for taking concrete steps in initiating a Global Security UFO Congress under the aegis of the United States. Such a step would be in harmony with President Reagan's courageous concern for human liberty and security, opening new vistas of mutual cooperation on critical problems far exceeding political interests. The issue is the survival of the human race itself!" (Unquote)

You must know that Gen. Schweitzer's letter signed on behalf of the NSC represents the view of the NSC members! They are: chairman: Pres of USA., members: Sec. of State, Sec. of Defense, Chairman Joint Chiefs of Staff, etc. We must be very careful, and you should wait with it to the Green Light, what we will issue at appropriate time depending from the answer of the NSC. We keep you permanently posted.
