

UFO researcher says governments quash saucer evidence

Says saucers are military threat

There are many different theories regarding the nature and intentions of reported UFOs. The following article does not purport to represent the editorial stance of The News World or anyone associated with it. It is printed in the interests of living discussions of UFOs.

Unidentified Flying Objects, which could also be called the GALACTIC POWERS' TASK FORCE, have created with their earth operations a potential threat to all the nations since the Second World War.

For reasons of national and international security, the national military leaders have concealed the UFO activities from the public since that time.

Between 1942 (when on February 25, over Los Angeles, CA, the 37th CA Brigade's 4th Anti-Aircraft Command fired 1430 rounds of ammunition against a UFO Wing Force), and 1952 (when during June and July, Washington DC and the neighboring areas were subjected to an invasion-like UFO operation), the following alarming facts were definitely established by the Pentagon:

- * The UFO Forces are of extraterrestrial origin;
- * armed confrontation had proven that the spacecraft are equipped with more sophisticated armament compared to those that exist on the Earth;
- * the UFOs exploratory activity is strategic reconnaissance for unknown extraterrestrial powers which is concentrated on "off limits" areas such as military and industrial installations for research and improvements in nuclear power, lasers, guided missiles, space explorations, etc.

* finally, the USA and the USSR both realized the strategic and tactical position they were in when we compare the primitiveness and inefficiency of their strategic arms against the science and technology of the Galactic Civilizations.

In July of 1952, with the United States already in possession of nuclear power and perfected German "V" rockets, the Joint Chiefs of Staff issued JANAP-146 with its basic order to INTERCEPT AND FIRE ON UFOs! To cover up this "undeclared warfare" against the Space Powers, the National Security Council instructed the CIA and its joint intelligence agencies to distract public attention and to establish a governmental policy that would minimize the risk of panic in case of any UFO-related trouble such as landings, armed engagements, invasion, etc.

On the other side of the coin, regarding the obvious character of the UFOs' operation, the private UFO research organizations became the most dangerous problem to the governments policies. To neutralize this unwanted research, the CIA and other government agencies infiltrated the UFO organizations and discredited their valuable research. As revealed recently by Jerome Eden in his TESTAMENT OF FOOLS — UFOs VS PLANET EARTH, serious research became associated in our society with what he calls a "UFO

CULT OF MAGICIANS". Parallel realities, ghosts, spirits and space brothers commuting aboard the UFOs or communicating telepathically with "chosen" elements of our society are some of the bewildering features of this multi-prolonged "UFO Cult of Magicians". The "JANOS" SPACE PEOPLE are a good example of this kind of group. According to the Englishman Frank Johnson, he was requested by the "JANOS" to secure them a seat at the U.N. General Assembly since their spacecraft were about to land on earth to teach the nations peace.

UFOs have been here for the past thirty years to help solve the pressing problems of Earth, but up to this day not a single problem has been solved! This is despite the fact that in England alone 20 people claim to be the reincarnated Jesus Christ.

It is my conviction that every planetary citizen is, deep inside, firmly convinced that the recent political and military tensions amongst the nations demand that the governments speak the TRUTH! It is time to stop the deception of the public and the activities of the UFO magicians.

TIME FOR THE TRUTH

ICUFON's factual military analytic research and that of its contemporary organizations in the USA, the PCCC and SBI, have led me to feel an obligation of opening the eyes of skeptical governmental authorities, as well as that of the public at large, by revealing the following evidence of silenced and suppressed facts:

1/ Declassified UFO documents from the U.S. Joint Chiefs of Staff, the State Department, the National Security Council, the National Security Agency, the CIA, FBI, Atomic Energy Commission, etc., are a definite sign of the internal disapproval in the government leadership to carry out responsibility for planning any preparation of warfare against the UFO forces!

2/ The validity of the Joint Chiefs of Staff and NASA's planned war readiness facing the Space Forces' potential threat was confirmed in June 1978 when the Deputy Director of the State Department office of international security, Dr. Michael Michaud, made the following warning:

"ALIENS FROM OTHER SOLAR SYSTEMS ARE A POTENTIAL THREAT TO US. AND WE ARE A POTENTIAL THREAT TO THEM."

Undoubtedly, the enclosed documents from various nations are indications for every one that the investigation of the UFO forces is under the exclusive jurisdiction of the military of these nations, and that reports of certain UFO encounters are strictly confidential and kept from the general public and private organizations. A sample of evidences follows:

1. UNITED STATES: Secretary of the Air Force: "within the Department of Defense the Air Force has the responsibility of investigation reports of unidentified flying objects and of evaluating any possible threat to our national security that such objects might pose."

2. NASA: "reports of unidentified objects entering United States air

space are of interest to the military as a regular part of defense surveillance.

3. CANADA: "It has not been the practice to allow the general public to study these (UFO) FILES."

4. FRANCE: Ministry of Defense: investigations conducted have not permitted [us] to find the answers supplied to these questions."

5. SPAIN: Chief of Staff of the Air Force: "...since the joint chiefs of staff declared as 'classified material' all matters related to UFOs."

6. ITALY: Defense and Air Attache: "...according to our national Security Policy, no request from private citizens or associations can be processed at this office." Fernando Buttelli, Brig. Gen. Italian Air Force.

7. UNITED KINGDOM: Ministry of Defense: "Unidentified Flying Objects reports are examined in the Ministry of Defense by experienced staff. They have access to all information available to the Ministry of Defense. In accordance with this principle full details of UFO reports received by the Department cannot be released."

8. UNITED KINGDOM: Ministry of Defense: Department of Aerial Studies:

Coded and classified information on UFO activities in England issued in 1978 to the U.S. CIA and NORAD constitute evidences for the existing world-wide reporting system and alert against the UFO forces.

We must realize finally that non-governmental (private) UFO scientific research, lacking the classified data and evidence in the military's possession, are shooting with harmless words when they try to establish the theoretical existence or non-existence of UFOs during their debates or conferences. But the military forces, on the other hand, are with strategic arms at the UFOs' disposal which at any time could trigger a disastrous space war for the world. Furthermore, we must realize that

according to the history of the world, humanity lived in peace only to prepare herself for war! Over the past three decades, the UFO forces never attempted to communicate their aims or objectives to humanity. Consequently, to accept their operation with an 'open minded' military attitude that determines that their global surveillance does "not present a threat to the world's security" and to suppress these facts from the public, bears all the marks of what the mighty powers codified as CRIMES AGAINST HUMANITY, on December 11, 1946 by the 58th plenary Meeting of the United Nations General Assembly.
