



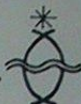

CONCERNED RESEARCHERS WARN ALL NATIONS:

"CEASE FIRING AT UFOS OR RISK A WAR IN SPACE!"

The heads of two international UFO organizations issued a warning to all
nations of Earth that continued attacks upon UFOs (Unidentified Flying Objects)
by terrestrial military forces might well provoke a Global Pearl Harbor.

Major (Ret.) Colman S. VonKeviczky, director of Intercontinental UFO
Galactic Spacecraft Research and Analytic Network (ICUFON) and Jerome Eden of
the Planetary Professional Citizens Committee (PPCC) said in a joint statement
directed at the Superpowers as well as all national leaders, "An Interplanetary
War is not science fiction, it is scientific fact. Many nations have already lost
military aircraft and personnel as a consequence of military confrontations with
visitors from outer space. Unless we immediately stop such senseless provocations,
the whole world may soon witness stunning retaliations which will make the recent
Falklands war look like a Sunday picnic!"

Both organization leaders back up their grave warnings with the following
documentations:

1/ A letter from the U.S. National Security Council admitting the reality
and urgency of the UFO threat, and later branded a "mistake";

2/ An affidavit attesting to the fact that the Deputy Director of the U.S.
State Department, Office of International Security acknowledged the "UFOs
potential threat" from outer space;

3/ Massive UFO documentation in the form of Memorandums and declassified
Pentagon files proving the seriousness of the UFO problem - material sent to
