Many thanks for your letter and interesting enclosures of 21 January.

I saw the NASA 'pass' projected on to a screen and no-one has shown me it at closer quarters, so I can only recall the 'Aeronautic' bit.

I didn't get much more information from Hesemann, but did learn that there are many suspicious aspects involved. I also met with Dr James Hurtak, who had been to S. Africa and Botswana to check out the case. He could find nothing to substantiate it, and informed me that Van. G's credentials are almost certainly bogus. Furthermore, Van. G. apparently set up a bogus UFO conference in SA, with big names advertised, and went off with the money for tickets.

Henry is continuing to blacken my name all over the place, and is claiming that he has a letter from a source to me, with my response, indicating my collusion in a CIA/MJ-12 disinformation scheme. This has to be fabricated, so I may be obliged to take legal action.

I have also been focusing some of my research on Lazar since July of last year, and am grateful for the copy of Stan's letter, which helps a lot. Actually, Stan told me much the same when we last spoke on the phone a couple of weeks ago.

Thank you very much indeed for your letter and enclosures of 21 March. Please forgive ~~me for~~ having taken so long to reply, but, as usual, there is a massive build-up of correspondence here.

I am very grateful for the time and trouble you have taken in sending the material and information, all of which is essential to my research. I would be deeply grateful if you could continue to send anything you get which relates to the R & D Board, Smith, Bush, etc. etc.

Re Paul Bennewitz. I had several phone conversations and exchanged a number of letters with him, and believe that he has uncovered a lot of important information. All this was back in 1985. I also checked on him (with his permission) by talking with his friend Col. Edwards, who confirmed a number of interesting things. The only adverse thing I have to offer is that I arranged to make a special trip to Albuquerque to visit him in 1985, but at the last moment he cancelled it, and didn't seem put out by the fact that I had already made elaborate arrangements and bought my air ticket. He said I wasn't "ready" to see him. Maybe I'll have better luck next month: I've written and asked if I can come and see him during my promotional and research trip to the States (and Toronto, I hope) during July.

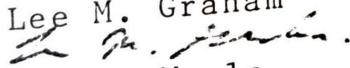
I would like to know the truth and just how you came to obtain a copy of the document?

Many thanks indeed for your letter and interesting enclosures on "Stealth" developments. But for heaven's sake, you don't need to address me as "Mr Good"!

ABOVE TOP SECRET is due to be published in its entirety - plus some important amendments and corrections - on 28 June, by William Morrow & Co. of New York, at \$19.95. I hope it will be widely available. I'm enclosing two stickers which I have autographed for you and Mr Ron Regehr.

Regarding MJ-12, what you say is accurate, to the best of my knowledge. However, there is nothing I can tell you - or anyone else - about how or from whom I obtained the document. I was given permission to reproduce the document in my book, which was first published in July last year. Since copies were available to the press at the end of May, it was impossible for me to stop them from publicizing the MJ-12 story.

I don't know any more about Stealth than you - and probably a lot less. The most interesting information I have read about the fighter/reconnaissance version appeared in the February issue of GUNG-HO. If you don't have this, I'll gladly send you a copy. I'm enclosing two very recent clippings about the Stealth bomber - the B-2 - from the International Herald Tribune and Time Magazine. The existence of this aircraft is, as you know, officially confirmed.

The clippings on Stealth that you sent me are most interesting. I do think that you should be careful when talking about your work with the press - or indeed anybody - since it is likely that details of the U-2 manufacture are still secret. I might be wrong about this, but anyway - take care.

Finally, please give my warmest regards to your wife.

Dear Mr. Good:

Sir, this letter is in response to your letter A, regarding my FOIA request B.

At this point, I must confess, that I am at a loss, to discern how you procured a copy of that request. May I be permitted to ask-

1. Who is Barry Greenwood?

2. Who is Paul Bennewitz?

Perhaps it would be best, for me to formally introduce myself to you, and explain where I am coming from-

My name is Lee M. Graham. I am an electronic systems research technician, employed at the Space Surveillance Division, of a major Aerospace Corporation. I am also a military jet aircraft buff, and am currently researching a rather curious rumor circulating within the Aerospace Community, relative to the facility indicated in picture K. See letter C1.

I am not a Journalist, and am not, per se, a UFO enthusiast. Some years ago, while employed as an electronic technician at the Hycon Mfg. Co. (now McDonnell Douglas Aircraft Corporation- MDAC), in Monrovia, Calif., I met a fellow technician (field representative at Wright-Patterson AFB) who indicated, to me (and others), that he had been privy to information, about the existence of crashed Flying Saucer artifacts, sequestered at Wright-Patterson AFB. He related, that Senator Barry Goldwater, had in fact, been denied access to this facility, where these artifacts are sequestered. I did not believe his story at the time, but a query to Senator Goldwater, resulted in response D, and my quest for the truth. I have since acquired a number of letters from Senator Goldwater, affirming the truth of the rumor found in E, arrow, underlined. See D, through, D5.

When a friend of mine (researcher Bill Moore) acquired a copy of document F, I came to the conclusion (unwarranted?), that there must be some kind of connection, between the "Blue Room", and- "Have Blue" (See G, arrow, underlined). I reasoned, that perhaps, our government had succeeded in reproducing the material out of which the Roswell Disc was made (See H), and used it (See I, arrow, underlined), to build the USAF/Lockheed stealth fighter, which has become known as the F-19. See J, arrow, underlined.

Being an aircraft (SR-71) buff, and a former Lockheed U-2 employee (1955-56), I was intrigued and determined to know the truth as to the existence of the USAF/Lockheed F-19 stealth fighter. That is what most of my FOIA requests have been about. I had (for example) a friend (a specifications writer, Mr. Ron Regehr) formulate letter D3, to Senator Barry Goldwater, for which I gathered the names (of fellow workers), for this petition. Senator Barry Goldwater (See D4) does not deny that we may have used pieces of a crashed Flying Saucer to advance our Aerospace Technology. It was Mr. Ron Regehr, who wrote the FOIA request B.

While our newspapers are prepared to acknowledge the existence of the F-19 (See L, arrows, underlined), the Air Force is not. See M.

In the midst of doing this research (to prove that the F-19 exists), I was approached by an individual (not Paul Bennewitz), ostensibly acting on behalf of the United States Air Force, and shown a copy of document N. Seeking to acquire a copy of same, I made a (spoken) agreement with its source, to pass a censored copy of same, on to one in

the Aerospace Community, who is an expert at authenticating U-2, SR-71, and F-19 "leaks". I thus acquired a copy of what I have begun to call the- "Snowbird" document, i. e., with respect to the rumor that such a vehicle is being flown. So far, none of the agencies to whom I have made FOIA requests about this document have (with the exception of C) pronounced it a fraud. They have not, in fact even answered my questions as to the identity of the- "Air force air base", indicated in K. See responses D, and P.

Sir, you related- "He certainly gave me a lot of details on the Snowbird,". I would be happy to relate the Majestic-12 story, i. e., how I came to see it, in exchange for the information you have on- "Snowbird".

Thank you for your time, Sir.

Dear Mr Graham

Thank you very much indeed for your prompt response to my letter - I was delighted to receive yours of 14 September.

The information you have sent me is very useful, and I am pleased to enclose an IMO for \$20 to cover costs of photostating and postage - this sum will probably cover any additional expenses in the immediate future, should you be kind enough to send me a few more photostats.

Barry Greenwood is a highly-regarded UFO researcher who has co-authored an excellent book on the cover-up, together with Lawrence Fawcett, entitled CLEAR INTENT, published last year by Prentice-Hall Inc. Many declassified documents obtained under provision of the FOIA are contained therein. Mr Greenwood's address: P.O. Box 176, Stoneham, Massachusetts 02180. He will be publishing an article on the MJ12 material in the next issue of JUST CAUSE (about November/December I imagine), so perhaps you should get in touch with him as soon as possible!

Paul Bennewitz is a physicist who runs an electronics firm, and who seems to have acquired a great deal of material about the alleged Snowbird Project, as well as many movie films of alleged UFO activity near Kirtland AFB, N.M. He makes some rather dubious claims, e.g. that he has established contact via computer with the ETs, and he has kindly confided much material with me. Although I find much of what he says spurious, I am intrigued by some of the information, and for this ^{reason} organized a special trip this year to visit him. Unfortunately, as I said in my last letter, he suddenly decided that I wasn't 'ready' to meet with him. I think this was because I expressed serious reservations about a certain document (see enclosed) which he claims is genuine, but the USAF OSI HQ at Bolling AFB and NASA have told me it is a fraud. It could be genuine, of course, and I'd like your opinions on it. (Although (No.) I am breaking his confidence by revealing the following,) I think you should know about some of these items of information: also, his rather unreliable behaviour - confirmed by others - has made me less inclined to accept what he says at face value. I would normally never break a confidence in any circumstance, and so I would ask that you should be circumspect with this information by not letting him know that I have told you. (I would like to re-establish correspondence with him in the near future.)

Bennewitz claims that the Snowbird is a joint US/ET venture, and that the nuclear-powered craft is flown by NSA pilots. (I didn't know that ^{the} National Security Agency had its own air force, however small, but it could of course be true). He claims it was this craft that irradiated the three witnesses near Houston, Texas, in December 1980 (the Cash/Landrum case, which has resulted in the witnesses suing the Government for \$20 million damages). The Snowbird has two pilots, he claims, and flies by view-screen. He hints that he has seen it on the ground from an aircraft, at a certain secret base; or has at least seen a photo of it taken from the air. Bennewitz is a qualified pilot, by the way, so I assume he can't be completely nuts.

The Snowbird is shaped like a Manta Ray, he says. There are Vietnam-style helicopter pads and "ground code marking" at ~~the~~ base.

In reviewing carefully my letters from Mr Bennewitz, I note that he has not asked me to keep this information confidential. So...you are welcome to do what you like with it. I suggest that you contact Paul Bennewitz, Thunder Scientific Corporation, 623 Wyoming S.E., Albuquerque, N.M. 87123: tel. (505) 265 8701. He claims that he is closely monitored by both the NSA and USAF OSI. Whether this is true, I don't know, but I do know that when I contacted his number once a very loud shrill tone prevented me from speaking with his secretary. It may interest you to know that Mr Bennewitz gave me the name of USAF Colonel who has witnessed some of the alleged computer display contacts, as well as the movie films. The Colonel is now at Hahn AFB, West Germany, and I had a chat on the phone with him - he seems to be a very decent, intelligent man, and told me that he thought Bennewitz was certainly on to something, and that he wasn't a nutter. By why did he cancel my arranged trip, with hardly an apology for having to put me to so much inconvenience? Anyway, I'd certainly like to meet him one day.

I'm also an aircraft enthusiast, as you will have noted from my brochure, and so I was extremely interested in all the information you so kindly sent me about the F-19. I had a letter today from Mr Philip J. Klass, the well-known UFO debunker, who is Senior Avionics Editor of "Aviation Week" (Aviation Leak!). In response to my request for info. on the F-19, this is what he had to say:

"I know relatively little about the F-19 Stealth fighter, built by Lockheed, or about the B-2 stealth advanced technology bomber built by Northrop. Aviation Week has carried relatively little on either of them. I doubt that either is being tested at Nellis AFB for there are too many 'prying eyes'."

Thought you might find that useful.

Thank you very much, too, for Document N. I must say that it looks like a forgery to me, but obviously I could be mistaken. We have to be on our guard for disinformation in this business, as I'm sure you will appreciate, even if your source seems reliable.

I am delighted to have the transcript of the interview with Jesse Marcel, the Barry Goldwater letters, the Blue Room material, and everything else, which will be of great assistance in my research. I take it that you don't have a photostat of the actual Majestic 12 document? Naturally, if you do ever secure a copy, I'd be delighted to have one, too, but that's asking too much. Anyway, perhaps some time in the future...I wish you every success with your FOIA requests on the matter, and would appreciate being kept updated. (I've had a letter from Ms Ann Turner, by the way, in response to an FOIA request.)

You will note in the enclosed document that MJ12 is referred to. Other documents (which are definitely genuine, and were released via the FOIA) refer to Bennewitz's films, and the sightings at Kirtland AFB, but of course there is no mention of MJ12, nor Project Aquarius etc. etc. I'll send you them all, though, if you'd like. Do let me know what your source says about the enclosed document: just because the OSI and NASA tell me it's a fake doesn't mean it is!

Thank you so much for your letters and enclosures of 22 Feb. and 2 March. I am absolutely delighted to have the Smith material, as well as everything else.

I enclose the copy of the UFO Contact article by Ronald Caswell, as requested.

Regarding Linda Howe, I'm not quite sure which letter you refer to, *
'tho I recall having read something, and certainly we discussed some of these matters during meetings last year. But as to how I reconcile the apparent inconsistencies, my feeling is that the MJ-12 group did not tell Eisenhower everything: as far as they were concerned, it was sufficient to let him know that alien bodies (in a poor state of preservation) had been recovered. It would have simply been too much to tell him that there had been other recoveries, with bodies (and craft) in a good state of preservation. Perhaps they gave him further information at a later date. I really don't know what happened, and this is just guesswork on my part.

I would naturally be glad to hear of any developments in your research into the R&D Board, and am intrigued to learn that Hynek was in some way connected. I regret that I haven't learned anything further at the moment. In your last letter you mention that you had been told that the National Archives have 927,000 pages relating to the 1947-53 period, but it's not quite clear whether this figure relates to the R&D Board files, or files in general (on UFOs). I'd be glad if you could clarify this for me.

(since none exist, as such)
I don't have copies of the Marshall/Alexander interview, and what I published in ATS was taken from a couple of FSR articles. If you want these articles I will gladly send copies to you, but in the meantime I can provide the following biographical details (such as are available, as published in FSR): From New Zealand, Rolf Alexander went to Prague where he graduated in medicine, and then to many other European universities where he did post-graduate work in analytical psychology, neurology and biochemistry. There is a bit more than this in FSR, but not much. I will write to Derek Dempster and try and obtain more information.

I thought you would like my MJ-12 press release. More information has been forthcoming since I wrote this in December, but I haven't put it all together yet.

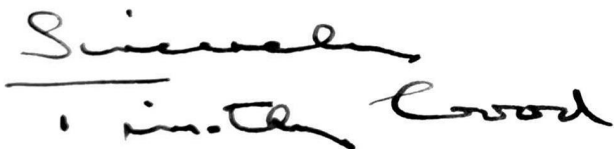
Thank you very much for your letter of 16 January last.

Dear Timothy,

Many thanks for your letter and enclosures. Please appreciate it. First a couple of additions and comments on the enclosures.

Caswell is highly accurate in his description of the Canadians around Smith lacking "guts". I know who most of the unnamed people are, but try to get them to talk! Still no word from Mrs. Smith who has the answers to most of the rumors. I have gone to Arthur for any help he can provide.

A correction to Caswell's article should you ever use it in your future writings. As to the people in Smith's group. I followed up on each and found that these are not the high level people you will see referred to as "the group" in the Smith Embassy documents.

Caswell refers to Dr. James Whit a physician. This should read Dr. James WAT, a physicist. I approached him with the MS-12 documents and his relationship to Smith and have enclosed his return letter.

Couldn't find John H. Thompson. The D.O.T. told me there were 152 people by that name. Dr. G.D. Cardano's response is also enclosed. Dr. J. Tuzo Wilson didn't respond, but was interviewed by Mr. Larry Fawcett from ECFER on my behalf. He was very upset about being questioned about "UFOs", something he said he wasn't interested in. He stated he knew Bush, Brunk, and he spent a month in the Arctic with Beckner (something I know away) but didn't discuss UFOs with any of them. He stated Smith had come to him to get something. He did not go to Smith. He refused to identify what he had given Smith.

Wilson was with Navy R & D and my guess is that he

provided the electromagnetic detector used at the "Elving Sauer Observatory." Smith's Defense Research Board associate told me this item was the latest technology at the time and had been used to track subs in WWII.

Re comment on your MS-12 release as it deals with Jackie Gleason. I followed up on this story and wrote anyone who could possibly confirm the story except McKittrick who I couldn't find. No one responded.

Harve James Bacon in his 1985 biography of Gleason stated Gleason had discussed UFOs with four presidents and that he had the power to get a president on the phone any time he wanted. I will send copies of the appropriate pages once I get the "files" reorganized.

On other matters I have sent along some more of the Smith Embassy material I have obtained. You will note the "Research and Development Board" and "the scientists" are directly mentioned. More importantly you will note the Smith Jan 15, 52 and Wright 18 Jan, 1952. Smith has what appears to be two file #s on the bottom of his letter and he has added this number to the bottom of the 18 Jan 52 Wright letter. These numbers are similar to CSS file, and DOT file numbers but they never appear in the Magnet or Second Story UFO documents released by the Canadian gov't. The case is on and an access to Information Request is already in, requesting this file or files. The D.O.T. file will have been destroyed but there are good odds on the CSS file still being around.

Lewie Clark in his Crashed Part III has the Sanlocher Smith meeting taking place by accident. I'll bet my last dollar it was set up by the CSS who it is now apparent knew off the "American Scientists."

Finally have enclosed a letter to me from Duplantier
1978. Read this this go. & Simmons took PSS1 and read
lines 10-14. Since I have only returned this letter in the
past few weeks Bernweitz could not have been familiar
with Smith's claim. Above written Smith's son to see if Bernweitz
was ordered Smith's book.

Bernweitz has been contacted by me on this and a number
of other bizarre similarities he raises to research we did here
in 1975-1985 during the massive flap that occurred in Manitoba.
Have you an opinion on Bernweitz? Don't him to review Smith's
scientific writings but because of the nature of some of his
claims I am checking with as many researchers as possible
on Bernweitz's character.

Talked for two hours with Linda Howe who was very
interested in Smith's contact material as it refers to
the "good" vs "evil" aliens long before others. She will
be checking out some of the material's sent and some might
be included in her new book.

Finally related to the R4 DB. There are 927,000 pages
on the Gracie activities. Some beyond this is still classified.
If they have a good finish and I will come up with something
based on what Salschner stated and further material I have
discovered which hasn't release yet.

Salschner according to the Just Cause interview stated he
had handled 100 documents but that these remained at the
 Pentagon.

Further he mentions Karl Compton as the head of
R4DB. However Compton was only the head from Feb. 8 - Nov 4, 1949.
We have a good date area. Why was the guided missile committee

invited? Von Neuman and Van ^{Subcommittee} Braun who stated had probably
attended were on the committee. Karl Compton whose discovery
was the head of the guided missile committee in 1947 and it was
taken over by Millican in 1950. Therefore Compton was the

AN ALIEN- U.S. GOVERNMENT LIAISON - A MATTER "ABOVE TOP SECRET"

A CANDID INTERVIEW WITH BRITAIN'S TOP UFOLOGIST TIMOTHY GOOD

English ufologist and professional violinist Timothy Good has undoubtedly become one of the world's top UFO experts. As far as we know, he was the first Western ufologist to appear on a live interview in a Soviet TV program in Leningrad. His near 600-page massive tome, *Above Top Secret — The Worldwide UFO Cover-Up*, published originally in the U.K. by Sidgwick and Jackson in May 1987, became a controversial instant best-seller on three continents.

Filled with official documents from the U.S., Great Britain, Australia and elsewhere (which included those of many British public celebrities like Lord Mountbatten and Sir Winston Churchill), "Above Top Secret" became the subject of a heated debate among reviewers. Perhaps the most extreme view was that of Adrian Berry of *The Spectator*, who denounced it as "an evil book" written by "a maniac," while Paul Roberts hailed it in *The Toronto Star* as "the most significant book ever written about unidentified flying objects." Not surprisingly, *Above Top Secret* climbed to number two bestseller for non-fiction in the U.K. and number one in Australia. It was also published last year by MacMillan in Canada and William Morrow in the U.S., and was recently released in paperback by the same American publisher.

As far as the British scene was concerned, Good's main scoop was revealing the existence of a secret 30-man Ministry of Defense (MoD) UFO tracking station and research center at RAF (Royal Air Force) Rudloe Manor in Wiltshire, which is manned 24 hours a day. Robert Beaumont reported in the 'Yorkshire Evening Press' that MoD "denies that RAF Rudloe Manor is a UFO tracking station or receives UFO sighting reports from the public. So I rang up Rudloe and asked if I could report a UFO sighting. They were only too happy to take down all the details."

I first met Tim Good in July 1988, at a press conference in New York City sponsored by Mike Luckman's local group NYCUFOR, where I had a chance of interviewing him briefly. Good was born in London in 1942 and became a professional violinist; beginning in 1963, he played and toured the world for 14 years with the London Symphony Orchestra, as well as with the London Philharmonic Orchestra with Mantovani. "In 1976 I left the London Symphony," Good told us, "to concentrate on light music, mostly black and pop groups, television films, ordinary films and commercials, that sort of thing." He has worked as a session violinist on the records of Paul McCartney, George Harrison, Sade and others, as well as in the film music

for *Batman* and *Dangerous Liaisons*.

Like the Roman god Janus, Good alternates his life of accomplished musician with that of UFO investigator, writer and lecturer. He first gained some notoriety in the international ufological field when he wrote with Lou Zinsstag, *George Adamski — The Untold Story* (Ceti Publications, 1983), a defense of the colorful contactee, who has been the subject of relentless attacks over the years. In that book, Good claimed that he had two experiences of telepathic communication with human-looking ETs; the first time in 1963 with a beautiful blonde girl while at a bus stop near Desert Center, California — site of Adamski's famous 1952 Venusian contact. The second was with a man in the lobby of the New York Park Sheraton Hotel, during a tour of the London Symphony in 1967. Good acknowledges that both experiences were "intended as personal proof and encouragement, and as such of no value to others."

Tim Good has a knack for attracting the cooperation of high figures in officialdom. His Adamski book, for instance, had a forward by Lady Falkender, Personal and Political Secretary of former Prime Minister Harold Wilson, while that of *Above Top Secret* was written by Lord Hill-Norton, G.C.B., a former Chief of Defense Staff and a member of the House of

Lords. But Good somehow has also managed to develop successfully over the years a number of unnamed sources in the shadowy world of both British and American intelligence. Good will not give details about these figures, yet it was one of these informants — reputedly a CIA agent — who gave him a copy of the now-legendary "Majestic-12" briefing paper. The document was included at the last minute in the 1987 English edition of *Above Top Secret*, where it proceeded to blow the whistle on the MJ-12 affair for the first time.

Tim Good visited New York City last July, following his lecture at the 1989 Symposium of the Mutual UFO Network (MUFON) in Las Vegas, and a research tour of several American cities. Las Vegas was the scene of a stormy and packed UFO conference; among several other hot presentations, famous crashed saucer investigator Bill Moore admitted that he had worked as a unpaid informer for a certain unit of the U.S. intelligence community. Moore would keep tabs on "certain" ufologists in exchange for leaked secret UFO data from a number of agents with birds' code-names.

This reporter talked at length with Tim Good about the enigmatic case of Dr. Paul Bennewitz — who is at the center of Moore's "spook" activities — as well as the controversial allegations of John Lear and others regarding alleged secret deals between the Government and some alien force. We shifted from possible underground alien bases in the West, to the opinions of British officials and researchers, and Russian ufology. A large portion of that material is contained in this exclusive interview for 'UFO Universe', but others had to be omitted due to lack of space. Some of the latter portions include Good's comments on abductions and the highly-publicized photographic case of Ed Walters in Gulf Breeze, Florida. Having spent some time with the Walters, MUFON investigators and local witnesses, Good supports wholeheartedly the validity of the case.

Let's proceed to review now, with Tim Good, the possibility of "alien liaisons" and other sensitive data from today's global ufological scene. Draw the curtains!

Antonio Huneus: Let's begin with how you got started in UFO research.

Timothy Good: I first became interest-

ed in 1955 when I read a book by Major Donald Keyhoe — it was *The Flying Saucers Are Real* — and I was immediately impressed by the quality of sightings from commercial airline and military pilots, air traffic controllers and so forth. In short, high caliber witnesses whose testimony would be taken seriously in any other circumstances. Very often their jobs were threatened because of reporting these things, so that's really how I became interested. But it wasn't until 1961 when I read Edward Ruppelt's *The Report on Unidentified Flying Objects*, that I began to do my own independent research.

AH: But obviously since you have already written about the late contactee George Adamski, you must have been interested in him around that time, or was it later that you became interested?

TG: No, I would say about the same time. In 1961, I became interested in Adamski and similar contactees, and in 1963 I made my first visit to the United

States where I was able to speak with a number of people who were interested in similar things.

AH: What was the subject of your presentation at the MUFON Symposium in Las Vegas?

TG: It was a presentation based on *Above Top Secret*, but with some new information that I had acquired since publication of the book.

AH: Information from England or the U.S.?

TG: Both! For example, in 1987 I spoke with the wife and daughters of a man who had been in Roswell in 1947.

AH: This was in Leonard Stringfield's last report, right?

TG: Yes, I gave that to Len Stringfield, I passed on the witnesses to him.

AH: So you discovered these people?

TG: Yes, or they discovered me. And this man was stationed at Roswell in 1947 when the [UFO] wreckage came in and he was ordered to stand guard over it. At a

later date — we don't know what that date was — he was involved in a recovery operation, again when he was stationed in Roswell. It might have been days later. It could have been years later, there is a rumored second recovery operation somewhere near Roswell, New Mexico.

AH: But this is not the one we know, I mean, the famous one?

TG: Well, we don't know because there is no date given, but he was at Roswell for a number of years, including 1947 and 1949. We just don't know, but he apparently was sent into the desert together with a team with a truckload of ice, and they couldn't imagine what on Earth this ice was for, but they got out into the desert and there they discovered these bodies. They put them on the truck apparently and he described them as having yellowish complexions, rather Asiatic features — Chinese, he thought — and smallish. No further details are available because, you remember, this was gleaned over a series of years, culminating on his deathbed in 1986 that he shared this information with his wife and daughter.

AH: So its second-hand information, but you would say reliable?

TG: I would say reliable. The sincerity of the family is beyond doubt. I have all the man's military records. He has some very impressive credentials, medals and so forth — various campaign medals.

AH: Did he know Major Jesse Marcel?

TG: Yes, he knew Marcel. In fact, Marcel's name appears on quite a number of these military records that I have, and his credentials include the American Defense Service Medal, the American Campaign Medal, the Good Combat Medal. I am assured these aren't particularly spectacular, but nonetheless they testify to the man's integrity, I think, up to a point.

AH: Since you also mentioned in your paper given at the MUFON Conference a story about the first well-known mutilation of Skippy the horse, what is your opinion about cattle mutilations? Do you think they are definitely related to UFOs?

TG: The fact is that the mutilations — as you know there have been thousands of them — have involved many sightings of unmarked helicopters, which would lead one to suppose that this is a military operation. I heard from some source that there are highly sophisticated lasers which are not yet in use medically, which could be responsible for the type of the incisions that we see in cattle mutilations; and yet as you know, the so-called "cooky-cuts,"

— the actual incisions — still represent a technology that I feel sure we haven't attained yet. Furthermore, you have to consider the sightings of UFOs in the areas where these mutilations are occurring. So I found it impossible to avoid the conclusion that UFOs are involved in some way with the cattle mutilations.

AH: So you would generally agree with researcher Linda Howe?

TG: Absolutely! I have had many discussions with Linda about this, I think she has written a superb book. I am so glad that she produced it herself because it is so beautifully done, and I think the fact that the blood has literally been vacuumed out of some or most of these cattle — and there were no traces of blood anywhere near — is surely indicative of something beyond our technology... But there isn't a question in my mind that this is related to the UFO phenomenon, and its obviously very disturbing. Now, where do we go from there? I mean, there are so many theories, and even if you have a viable theory, for example, that they need sustenance or they need genetic material to improve their stock, what is the purpose of that? Is it because they are a dying race, or is it because they want to adapt more, I mean, adapt to our own environment? This is disturbing in a way. I tend to support the genetic theory, although some skeptics have said, you know, if aliens are thousands of years ahead of us, they should be able to manipulate DNA in a less brutal fashion. So I keep an open mind, I am absolutely open to hybridization, and if Budd Hopkins' abductees are to be believed, this is what's happening.

AH: Let's move to the new revelations concerning Dr. Paul Bennewitz, the engin-

eer, and Bill Moore who wrote the book on the Roswell crash.

TG: Basically what Bill Moore is saying, is that Bennewitz stumbled across something — possibly to do with electromagnetic pulses — some kind of super secret military experiment, which may or may have not been UFO related, and the result of that was that Bennewitz had to be fed false information — disinformation. Bill Moore acknowledges that he was required by his counter intelligence sources to keep track of Bennewitz — what was he up to and so forth — and report back. He has admitted this, but he insists — and I believe him — that he was not part of the disinformation campaign per se.

AH: So he has admitted that he was acting as an informer to the government?

TG: Yes, absolutely.

AH: But not as a disinformation agent?

TG: Yes, yes, and also that because Linda Howe was going to include this highly controversial material in her documentary about Bennewitz — which Moore suggests would have alerted the Russians to the fact that your government was doing something of interest in the Kirtland Air Force complex — she herself had to be disinformationed to a certain extent. Now, I understand that AFOSI Sgt. Richard Doty... Well, I've seen the letters from Doty where he denies the whole interview he gave here when she was putting together a special for HBO.

AH: Yes, I've seen them too and I believe Linda.

TG: Doty is lying about it. He did show her a document, it may have contained — and I am sure it did — disinformation, but he showed her a document. Linda is not lying about that. Furthermore, I spoke to Colonel Ernest Edwards at Albuquerque only the other day. I was in touch back in 1982, at the same time that I was communicating with Bennewitz.

AH: Have you met Bennewitz?

TG: I have never met him, I've spoken to him on the phone, I've corresponded with him. What happened back in 1982 is that, following communications with Bennewitz, he [Col. Edwards] suggested that I come out there and visit some of these areas such as Dulce (where there is said to be an underground alien base), to fly over and he would allow me to take photographs and he suggested I bring certain types of filters and lenses. In fact, I cancelled work, I bought an airline ticket and at the last minute he cancelled the visit, which left me in an awkward position and he never even apologized for the inconvenience.

AH: Now, let's retrack this a little bit, because I want to get to the bottom of this. I guess you were alerted to Bennewitz

through the Kirtland Air Force Base documents released under the FOIA, which had come out around that period of 1980-81?

TG: Yes, I contacted him and he suggested I get in touch with his friend Colonel Ernest Edwards, who was with the Security Police attached to Manzano. Edwards feels that Bennewitz was essentially sincere, that he had probably filmed some unusual objects, but he fails to see anything in the photographs of, for example Dulce, which is anomalous. Having studied these photographs myself...

AH: Oh really? Have you seen them? They've never been published anywhere to my knowledge.

TG: Edwards showed them to me, and I must say I failed to see what Bennewitz claims was there. I haven't seen his movie-films, so I can't comment on those.

AH: Can you describe the photos?

TG: It was of the Archuleta, the Mesa near Dulce, and some of them showed a number of trees which had apparently been knocked down, and I think Bennewitz claimed that one of these nuclear-powered UFOs had crashed-landed there.

AH: Did they show lights as well, or objects?

TG: No, but I did see a couple of color photographs, which were taken in Col. Edwards' presence, of some anomalous objects, which neither Bennewitz nor Ed-

wards saw at the time. Edwards feels that they are anomalous, he can't explain them, but its possible... to me they look as if it could have been some kind of bird; but they are certainly rather strange, I must admit.

AH: So you flew to Albuquerque in 1982?

TG: No, I didn't, that's the whole point, he cancelled the trip.

AH: So when did you meet him?

TG: I met Edwards a week ago in Albuquerque [following the Las Vegas July 1989 MUFON Symposium] and spent a very pleasant afternoon with him. He is very keen to be kept abreast of developments... He feels too — and this is interesting — that Linda is being honest about her recollections of the Doty meetings.

AH: One thing that I was disturbed about Moore's involvement in this, was the rumor that Bennewitz had been interned in a mental hospital, which his son denied in a phone interview with "UFO" magazine.

TG: Well, Bill [Moore] said in his speech in Las Vegas, I'll quote, "his health had deteriorated, he had lost considerable weight, his hands shook as if from palsy, and he looked terrible. I tried to counsel him to drop the entire UFO thing before his health was completely destroyed. He said he

knew things were getting bad and he was trying to cope with it. Not long afterward, I heard he had been hospitalized and was under psychiatric care." So, I don't know for sure whether he was actually hospitalized.

AH: Because you realize that this would be an excellent way of casting a shadow on someone's credibility.

TG: Well, that was the whole idea, of course, I mean its most unfortunate — and I discussed this with Bill — and he thinks it was most unfortunate that it got this far, but Bill did try to warn Bennewitz not only that his health was deteriorating but that, you know, he should stay clear... that he had stumbled upon something.

AH: Having been in Albuquerque and talked to Col. Edwards and Moore, what is your tentative conclusion with regards to Bennewitz's concept of an alien base in Dulce?

TG: I believe Bill Moore's version of events, but nobody knows precisely what it was that Bennewitz stumbled upon, which led to the disinformation program.

AH: So you don't believe that there is an alien base in Dulce, although I imagine you're open-minded.

TG: Well, I honestly don't know, but its for sure that there have been a number of interesting sightings around the Dulce area, and even Bill Moore in one of his latest bulletins, in fact lists Dulce as one of the areas to go to if you want to look for UFOs.

AH: I am also curious about the fact that Moore or Jaime Shandera had received the MJ-12 documents before you did...

TG: Jaime Shandera received this envelope...

AH: Yeah, I know the story, and yet you were the one that blew the whistle, because they were playing games with the documents, I mean, they were even releasing copies of them with half the page censored.

TG: Absolutely true. Their idea was to try to smoke people out who might have been involved, to try and fill the missing gaps, just to see whether this was a credible document.

AH: How did Moore react when you published the MJ-12 document in the first British edition of *Above Top Secret* in May of 1987?

TG: I think he was pretty surprised. As you know, I received the document from a CIA source in March of 1987.

AH: In Britain?

TG: In Great Britain, but not from a British source, from an American source in America...

AH: Who contacted you?

TG: Who contacted me, yes. Obviously I can't go into details, my lips are sealed

for life, so I can't really discuss that.

AH: As far as you know, did this source have anything to do with the people who were involved with Moore?

TG: I am sure. Oh absolutely.

I am convinced and from what I was told, that this is an inspired leak, and that its just one of a series of documentary items which will be released gradually over a period of time. I am totally convinced — I shouldn't say totally, that's unwise — but I am almost totally convinced of its authenticity, based on a lot of research work by Stanton Friedman and a number of others. I've shown them to a number of intelligence contacts in Great Britain, and as far as they are concerned, it looks authentic. The only thing that really bothers them is that they weren't in on the secret. There's actually nothing really concrete that's being raised by the skeptics to indicate that the MJ-12 documents are not authentic.

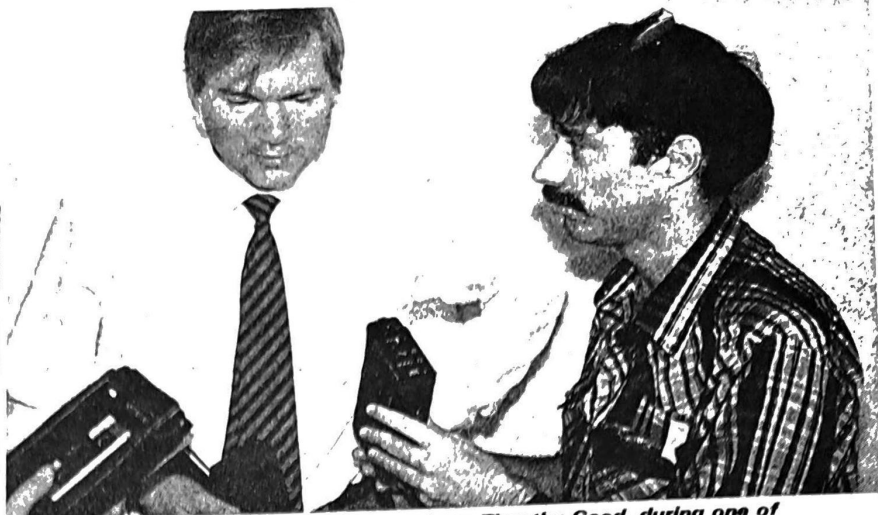
AH: Let's move now to what I consider the second phase of the Bennewitz theory, which is John Lear and Area 51. Most people call it the John Lear theory when, in fact, the same concept was already being proposed by Bennewitz way before Lear.

TG: Well, again, I've had several meetings with John Lear; I like him, I think he has been a little gullible in accepting at face value a lot of these rumors, but he assures me that his sources are reliable.

AH: Had you met him before this last conference in Las Vegas?

TG: I met him last year, and there is no question in my mind that something pretty sensitive is going on at Groom Lake [part of the Nellis AFB complex and test range]. I've been within 10 miles of it, by the way, I never got any closer, its not wise to get too close. . . . As you know, there are a number of rumors. The most recent source is a scientist who allegedly worked there, who was given the code name Dennis by Channel 8 in Las Vegas. Earlier this year he had contacted John Lear, and Lear had him on this television program with his face like shaded. Actually he was filmed, I believe, outside John Lear's house. He claims that he was working on actual recovered UFOs. He claims that there are nine discs at Groom Lake, some of which are in perfect state of preservation, and that a number of them have been and are still being test flown by pilots. He wouldn't comment on any alien liaison at Groom Lake. Now in many respects, this scientist comes over as a highly credible witness. What bothers me is that on this television program he said that his wife had been threatened and his family and so forth — apparently he has lost his job — but I am slightly baffled why he allowed his real voice to be used on this program, unless by coming out with the story, if anything happened to him, it

would alert the media to the fact that something was going on. I know the man's real name and inquiries are being made as to his authenticity; but he certainly won't discuss it anymore now, he's keeping a very low profile. So there are these rumors.

AH: As you know, when Bill Moore came up with what James Moseley refers to as "the bird people" — Falcon and Condor — I was flabbergasted that they were proposing basically the same theory than John Lear — that there are aliens in Area 51 — except that in the TV show the aliens were presented as good — or at least as not bad — whereas Lear presents them as definitely bad. So why was Moore saying that this whole thing was crazy just shortly before that time?

TG: Well, Bill Moore says in his speech that he feels that part of Falcon's and Condor's material [revealed] on the program, was disinformation. I don't know precisely what is the truth.

AH: I guess none of us know, but what is your feeling about this whole business of the alien bases?

TG: From my own independent sources, I am satisfied that there are alien bases on this planet, whether they're manned by the grays or the other types of beings, I am not absolutely certain, but I know that there are other types of beings coming here, those who most closely resemble our own species, and I would go so far as to say I know that they have bases on this planet. Now, that type of alien is not very fashionable. . . .

AH: You mean the 'blonds' or whatever?

TG: Well, they're not all blonds, but you know what I mean. The types that are more similar to our own species, they're not fashionable anymore, yet I am convinced they exist, not only from various highly reliable sources, but also from my own per-

sonal experiences, such as in 1963 and 1967 in the United States. I've published them, so there is no secret about them — I published them in *George Adamski: The Untold Story*, so you can get the two stories from there. The last occasion was 22 years ago, in 1967, in what was then the Park Sheraton Hotel in New York, when I was doing a series of concerts at the Carnegie with the London Symphony Orchestra. Every time I'm in New York I go back to that hotel. . . .

AH: What's important about these new allegations is the slant that a supposed agreement was made with the United States. There has been talk, of course, about alien bases in the Andes, under the oceans and in many places, and it does make sense that if they're here, they would have bases. Normally, these were purely alien bases, but now there seems to be a new factor.

TG: About the agreement, I have no independent confirmation of that. It strikes me as rather peculiar that giving their advanced technology — advanced mental abilities and so forth — that the aliens would need to get a signed agreement with any Earthly government.

AH: In exchange for what they need they are supposed to give us advanced technology. And according to this scenario, they wanted to conduct abductions on people.

TG: I don't have independent confirmation; but what I can say based on highly reliable information, is that a liaison has been struck between a group of extraterrestrials and some scientists.

As a matter of fact, it was George Adamski, that much maligned person, who I think actually came out with a lot of very important information, even though he was discredited later on. Adamski was the first person, to state publicly that there was

liaison with these beings, and that it took place at certain underground bases in the United States and elsewhere, which is interesting.

AH: What about the fascinating story of the landing at Holloman Air Force Base, the one that was told to movie producer Bob Emenegger by a government official?

TG: I have had a number of conversations with Bob Emenegger last year and this year, both at his home in Los Angeles. As you may know, Emenegger and Paul Shartle, the former security manager and chief of [the Audio-Visual] requirements division with Norton AFB, confirmed that he had seen this film. Its interesting that Bob Emenegger confirmed to me, as he had to John Lear sometime ago, that part of a documentary that he was associated with, which is called *UFOs: It Has Began*, actually contains a small clip of the original Holloman AFB landing film.

AH: It does?

TG: Yes, but it shows just background of mountains and this white — I mean on reproduced copies you don't get much detail — but its an object just coming down like that towards the ground, and Bob Emenegger told me that that was just about the only piece that he saw.

AH: The USAF was supposed to give him much more footage, but in the end that was all he got?

TG: Right, and Linda Howe was also promised the Holloman film. There is still confusion about the actual date — Bob Emenegger insists that it was 1971 when this incident took place, others say it was in 1964 — but I am convinced that film exists, and I am equally convinced that we'll be able to see it one day.

AH: Based on all the research you've done, do you think that there is any chance — as it has been proposed by some peo-

ple like Attorney Peter Gersten — that a lot of this is disinformation? Its an old theory that was proposed by researchers like Renato Vesco and Marcello Coppetti in Italy, you know, the Nazi secret technology hypothesis, which maintains that the alien deal was just a curtain while the government was working on this technology, something they've been doing for the past 40 years. Do you believe this is a credible scenario? In fact, there is that book written by an Englishman, *Genesis*, which presents this idea as fiction.

TG: Mr. Harbinson, yes, I read that, he did a lot of research. There is no question that some Germans were working on flying discs. The question is how far they got. Some of the people that came forward in America, I think, were making rather elaborate claims regarding the performance of these discs. I find it absolutely incredible that the Germans could have produced during World War Two, a piloted vehicle that flew from Czechoslovakia several thousand miles an hour. What I do think its possible, is that the Germans flew a radio controlled disc, that is feasible, and I am trying to find out more about that, and so is Bill Moore. Incidentally, he is intrigued by the possible that the [1952] Spitzbergen [UFO crash] story might be traced to a German radio controlled disc that crashed, but we don't know for sure.

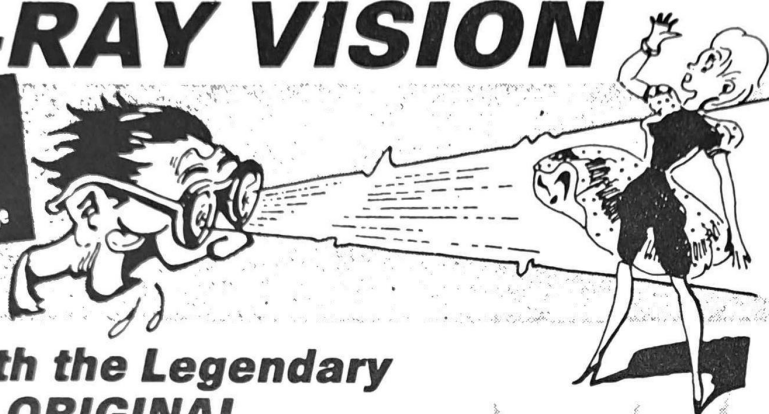
AH: In fact, I don't know if you've read the book by Vesco, 'Intercept — But Don't Shoot,' which does contain quite a bit of tantalizing information. He claims that the whole thing was basically a British conspiracy in Canada...

TG: And that John Frost's AVRO hover car was just a cover for the real thing. Its possible, but you have to look at the facts, and you only have to look at Roswell. I know that Peter Gersten claims that this was some sort of highly secret German-American vehicle that crashed. I don't believe it. I don't believe we could have possibly had such advanced metals, as Jesse Marcel described for example, which couldn't be dented with a sledgehammer nor scratched, which had strange hieroglyphic symbols on it. Furthermore, I believe that one of the people who was involved in the flight testing of the experimental flying wing, actually saw a UFO himself which he believed was not from this planet — its in Stanton Friedman's paper [in the 1989 MUFON Symposium Proceedings], so you can get the facts from there. I mean, look at the occupant reports... You've only got to look at the variety of different species that have been seen coming from these craft — you can't discount all those.

The only explanation is extraterrestrial, unless we have hidden civilizations on this

planet that have been here for thousands of years. To me that's the only remotely plausible hypothesis other than the extra-terrestrial one to explain all the facts.

AH: Let's talk now about the British aspect, which I found quite fascinating in your book. Have you come up with anything new in this area?

TG: Since publication of *Above Top Secret*, I had some confirmation for the involvement of [the Royal] Air Force intelligence in UFO investigations, which is highly secret.

AH: Basically, I guess your biggest scoop as far as the British go, is that you came up with a governmental UFO office which is current, right?

TG: Rudloe Manor, a secret research unit of some size which is located at Rudloe Manor in Wiltshire.

AH: Which before your book nobody knew about?

TG: Well, they knew about it, but it was the first time that it was published. Interestingly enough, it was confirmed for me by two independent sources, and its now being confirmed by a third. I am constantly weary of disinformation, however, because my new source happens to have been a counterintelligence specialist.

AH: Given the close alliance between the U.S. and Great Britain, shown in things like their support for the Libyan air raid, what do you think is the level of sharing information on this matter, beyond what is officially acknowledged?

TG: There is no question in my mind that the British were kept out of the great secret, certainly from 1947. I don't believe they were told about the Roswell incident, they might have been told something, but they weren't told the full story, because as you know, reproduced in the book is the Churchill documents, and Churchill asked his Air Staff to give him some answers, and he was told that is was a lot of rubbish. Furthermore, that the Americans had come to the same conclusion, that there were no really, truly, unexplainable sightings, and so on. We know from the CIA documents that the contrary was true at that time.

AH: I understand this as a public position, but they were informing the Prime Minister!

TG: They were briefing the Prime Minister. Its my opinion that they weren't disinforming him, they were misinforming him because they didn't have the facts, they genuinely believed that. However, following the incident at Topcliffe Royal Air Force in Yorkshire in September 1952, [USAF Capt. Edward] Ruppelt confirms that a RAF intelligence officer went to the United States and Liaised with your Air Force people, and demanded to know the answers

to a lot of questions that he brought with him. So I think there has been more liaison since 1952 — to what extent I truly don't know.

AH: Let's move to the Soviet Union. Obviously, you covered it in your book, but things are changing there very fast.

TG: Yes, I've visited the Soviet Union, now on three occasions. The first time was 1969, on a holiday, at which time it wouldn't have done to have broached the subject, although I did speak to a young Communist Party official who told me that the subject created tremendous interest in the Soviet Union in a sort of underground way. And in 1971 I went with the London Symphony Orchestra, and I didn't make any inquiries at that stage because relations between Britain and the Soviet Union were very shaky at that time, and it wouldn't have done to rock the boat. But in January of 1989, I went out for a week to Moscow and Leningrad, and the first interesting thing I noticed was in the Exhibition of Economic Achievements in Moscow, where in the Space Exhibition they had a UFO exhibit. They had photographs of UFOs. They had photographs of the cosmos. They had a number of books and magazines, including one of Frank Edwards' books, and the British *Flying Saucer Review*. That exhibit generated a greater deal of interest than anything else in the Space Exhibition Center there. It was fascinating, quite a pleasant surprise that was.

AH: What happened during your visit to Leningrad?

TG: The main contact there was Nikolai Lebedev, who has contributed a chapter on Soviet sightings in 1988 and 1987 to the *UFO Report 1990*, which is coming out published by Sidgwick & Jackson in November, and hopefully next year by Norton in the United States, if its successful. I was very impressed with him. We corresponded for a while, and he gave me a lot of fascinating valuable research material from the Soviet Union. Most of the sightings appear to be concentrated in the Vladivostok area, on the Pacific side near Japan, Dalnegorsky. There has been an awful lot of activity there, some truly impressive cases with good witnesses.

AH: Great, so this time the chapter on Russia is written by a Russian?

TG: Yes, indeed, and to go on with the Leningrad visit, I was invited by Leningrad Television to appear on the air thanks to Nikolai, and a few other researchers whom I met in Leningrad. I was interviewed on a program called "Open Door," where Soviets can air their grievances against the state, and I was given a free reign and some of the interview I gave was transmitted live and the rest a few weeks later.

AH: This was done through an interpreter, I guess?

TG: It was done through Valery Ubarov, I think his name was, who is a keen ufologist, so it was a delightful experience. I spoke about MJ-12 and the cover-up and then I was asked if I had a message for the Russian people, and I reiterated what was said by Dr. Felix Zigel and Major General Porfiri Stolyarov back in November 1967 in Moscow Central Television, when they said this is a very serious subject and appealed to Soviet citizens and so forth [to report UFO sightings]. It was a remarkable experience. I think probably I was the first Western ufologist to give an interview on the subject. . . I was asked when my book would be translated to Russian, and now I have a letter from the group which has replaced the Commission for the Investigation of Atmospheric Anomalous Phenomena.

AH: Oh, there is a new department?

TG: Yes, its called FACT and its attached, as before, to the USSR Academy of Sciences. A member of that team has written to me and said that they would like to translate my book to Russian. However, they wanted to make certain changes and I left that in the hands of my literary agent, so we'll see what happens. But things are, you know, progressing, things are happening.

AH: I guess we're finished with Russia.

TG: There is one more thing I can tell. Apparently, there is a tremendous amount of rivalry and bickering and jealousy among ufologists in the Soviet Union, just as in the United States and in Britain.

AH: In South America it is the same.

TG: Its the same all over the world, you know, people's egos get in the way.

Dear Grant

Thank you very much indeed for your letter of 28 Dec. last.

In my opinion, the SAAF document is a complete fabrication. I regard both James Van Greunen (the alleged SAAF officer) and Henry Azadehdel as charlatans. I understand that Van G. has obtained considerable sums of money from various researchers, so that he can travel around the world and escape from South African 'harassment'. Henry was imprisoned in Britain last year for smuggling rare orchids, but was let out after about six weeks. His background gives rise to the gravest suspicions. He claimed to me that he was a doctor of physics, for example, but has never been able to prove it. To others he has presented himself as a 'geophysicist'.

I understand that the taped conversations between Henry (posing as a USAF officer/general) and Wright-Patterson AFB etc. are impressive, and if those at the other end of the line are genuine - and not set up by Henry - there are some important question marks about the case. My friend Tony Dodd knows a great deal more, but he doesn't keep me informed, mostly because he is under the influence of Van. G. and Henry, and has been rather gullible in accepting their information at face value.
