Esteemed Mr. Chairman:

It is my obligation to present to you for your deliberation and explanation a copy of our letter addressed to US Army Maj.Gen. Robert L. Schweitzer regarding his November 21, 1981 issue to our Network. (Consult Encl. # 1.)

General Schweitzer informed me that in his statement "The President is well aware of the threat you document so clearly..." - in the "threat" he interpreted the USSR's strategic superiority over the United States. - I am sorry, but in our Memorandums to the President - filed with the NSC and mailed also to him, we "DOCUMENT SO CLEARLY" solely the potential threat of the UFO forces, without mention or document anything about the USSR military potential and build up.

He excused that the NSC letter was a "mistake", which is hard to believe in the consideration that the National Security Council as the highest level leadership of the United States, and resultant force of decisions in effect to world-wide significance, - could issue such a cardinal misinterpretation on a pressing problem, which would be long time due for the Council's decision.

In the deliberation of our Press Release (Encl. # 5.) we respectfully request your definite explanation in this baffling official affair to:

1/ Why our Memorandums addressed to President Ronald Reagan, and request to the Council (Encl. # 3.) dealing after all with the solution of the UFOs pressing problem were suppressed and unanswered over 15 - 7 and 3 months?

2/ Why President Ronald Reagan and the Council are reluctant to clarify before the nations, the militarily verified and officially admitted (Encl. # A, par.2) planetary "POTENTIAL THREAT FROM OTHER SOLAR SYSTEMS"? - And why U.S.A. over three decades as a leading mighty power was contended against any rational and initiative action on the UFOs created national and global security problem?

If your explanation on the above matter within 20 days will be disregarded, we shall assume that the case is not own confidential nature and may be published.
