

the President's Office, gave me and my colleagues hope that at long last President Reagan might take the appropriate steps to defuse international tensions, which mount every day, by calling for world-wide cooperation on the possibility of an Interplanetary War. Like the American Pioneers who may or may not have liked their neighbors, all joined together to fight a common forest fire or any other danger threatening the very survival of all.

Thus, as a consequence of your response on behalf of the Chairman of the National Security Council, my associate, Jerome Eden, President of the Planetary Professional Citizens Committee, and with my concurrence, sent his thoughtful letter of January 18, 1982 (Encl. # 3.) with a copy to you personally, to explore the possibilities of establishing an International UFO Security Conference under the aegis of the United States which would be a bold and sterling act on the part of our President in defusing world tensions. Enclosure # 4* shows that this letter was received by the Office of the Chairman of the National Security Council on January 25, 1982. On the telephone you said that you never saw either the original letter sent to the Chairman, nor did you receive the copy addressed personally to you. You will note in the attached copy that Mr. Eden's letter clearly refers to your November 21, 1981 response. This entire matter was kept confidential while we waited a further response. Three months elapsed - certainly sufficient time for clarification or correction of the issue. Meanwhile, UFO activity has increased world-wide, and international frictions continue to intensify. Thus it was decided to take the recent step of publishing the press release. (Enclosure # 5.)

Frankly, General Schweitzer, I am hard-pressed to find a rational explanation for the entire matter. Some of the major points that concern both me and my colleagues are the following:

1/ How is it possible that documentation and personal letters dealing with both national and planetary security are (a) unanswered, or (b) are "not delivered" to Government officials? Who is blockading such communications or sequestering the top-level officials for whom they were meant?

2/ Why is our great nation and our courageous President so reluctant to reveal to Americans and all mankind that the UFO problem is a grave threat to the entire human community? (If they are not so sobering a threat, why are we and the USSR shooting at them - a situation glaringly documented by every nation of the Earth, evidenced by the Pentagon and in our Memorandums?)

I feel it would be an insult to both of us for me to further try to "convince" you a situation with which you must be thoroughly aware. From one military man to another, the documents speak amply for themselves. A prepared people do not panic; it is ignorance that instigates mass hysteria. We learned this lesson on December 7, 1941. Must mankind experience a Global Pearl Harbor - after being fed on decades of evasion and deception?

Please realize, General, that our patriotism is in earnest, and that our attitude is based upon three decades of military research and findings. History is made by those who see and act in advance of coming catastrophe. We love our nation, but that feeling extends to all good peoples of Earth, as it must every-one who sincerely desires peace and security for all.
