Major William H. Casterline, AO 416 269, Base Operations Officer, was contacted by telephone by Mr. [REDACTED] Glendale, Arizona (Phone: Glendale 9993) at 1040 on 5 April 1952, who reported a sighting of 2 unidentified flying objects.

O.S.I. for this area made a follow-up investigation and accumulated the following information:

1. Three flying objects were viewed by Mr. & Mrs. [REDACTED] Mr. [REDACTED] and Mr. [REDACTED], all of the above address.

2. Mr. Ryan and Mr. Stokes were interviewed and described the objects as large and circular. No wings, flame, smoke, or other identifying evidences of conventional flying objects were visible. The color was a dull gray, resembling unpolished aluminum.

3. The first object was sighted and disappeared. Immediately, 2 more were sighted traveling in the same direction as the first. The 3 objects formed a large "V" formation.

4. The approximate altitude was guessed to be over 40,000 feet; and the speed, about half the rate of a "falling comet." The direction of flight was north.

5. The weather conditions at the time of the sighting were reported as follows: Ceiling - clear; Visibility - 45 miles; Wind - calm.

6. Two F-26s landed at this base shortly after the reported sighting. The pilots reported that they had flown their last leg from Winslow, Arizona (north of Phoenix) and had sighted no strange objects. They did report a formation of 3 F-51s reporting in over Winslow from Phoenix.
