1. At approximately 1300 hours on 6 January 1953, Andrew J. REID, Chief Agent, C-2, Fort Monmouth, New Jersey, directed William L. McKELVEY, Agent, G2, to interview [REDACTED], Meteorologist, Meteorological Element Section, Meteorological Branch, Building #56, Evans Signal Laboratory, Signal Corps Engineering Laboratories, Fort Monmouth.

2. At approximately 1400 hours on 6 January 1953, Agent McKELVEY interviewed [REDACTED] at Building #56, Evans Signal Laboratory.

[REDACTED] stated that at approximately 1155 hours on 6 January 1953, he observed a silver colored object, resembling a football in shape, in the sky. This object appeared to remain motionless for approximately 3 minutes, then proceeded in a north, northwesterly direction at a slow rate of speed until it disappeared in a haze at approximately 1200 hours.

[REDACTED] also stated that his duties in the Meteorological Branch require him to determine the height of clouds, air pressures, etc., and in his opinion, this object was approximately over Avon, New Jersey, at an altitude of at least 30,000 feet.

[REDACTED] further stated that this object could not have been a weather observation balloon, as it was traveling against the direction of the wind, which was coming out of the northwest at that time.

[REDACTED] stated that at the time this incident occurred, the weather was clear with excellent visibility.
