While flying on a ferry mission from Fort Worth, Texas to Travis AFB, California in the vicinity of Elythe, California, an RB-36 crew of the 31st Strat Recon Squadron, 5th Strat Recon Wing, observed a unidentified object. The RB-36 was maintaining a True Air Speed of 200 knots, a ground speed of 180 knots, and a true heading of 283 degrees at an altitude of 30,000 feet. The time of the sighting was 0050 GCT, 5 February 1953, and the aircraft's exact position at the time of the sighting was 33-43N 115-16W. The sighting was observed for approximately 5 minutes at which time the object disappeared from view behind clouds. It was a white round object appearing brighter than the cirrus clouds behind it. It was sighted at seven (7) o'clock high with a relationship to the aircraft the same as a star or sun while flying a straight level course. No definite movement or direction was made while observed.

The statements made were slightly conflicting due to each observers different viewing angle of the object. The altitude was estimated to be approximately 30,000 to 50,000 feet. No vapor trails were observed. The object appeared similar to a full moon and like a metal surface with reflecting sun rays. The object was not thought to be an aircraft or a weather balloon.

COMMENTS of Preparing Officer:

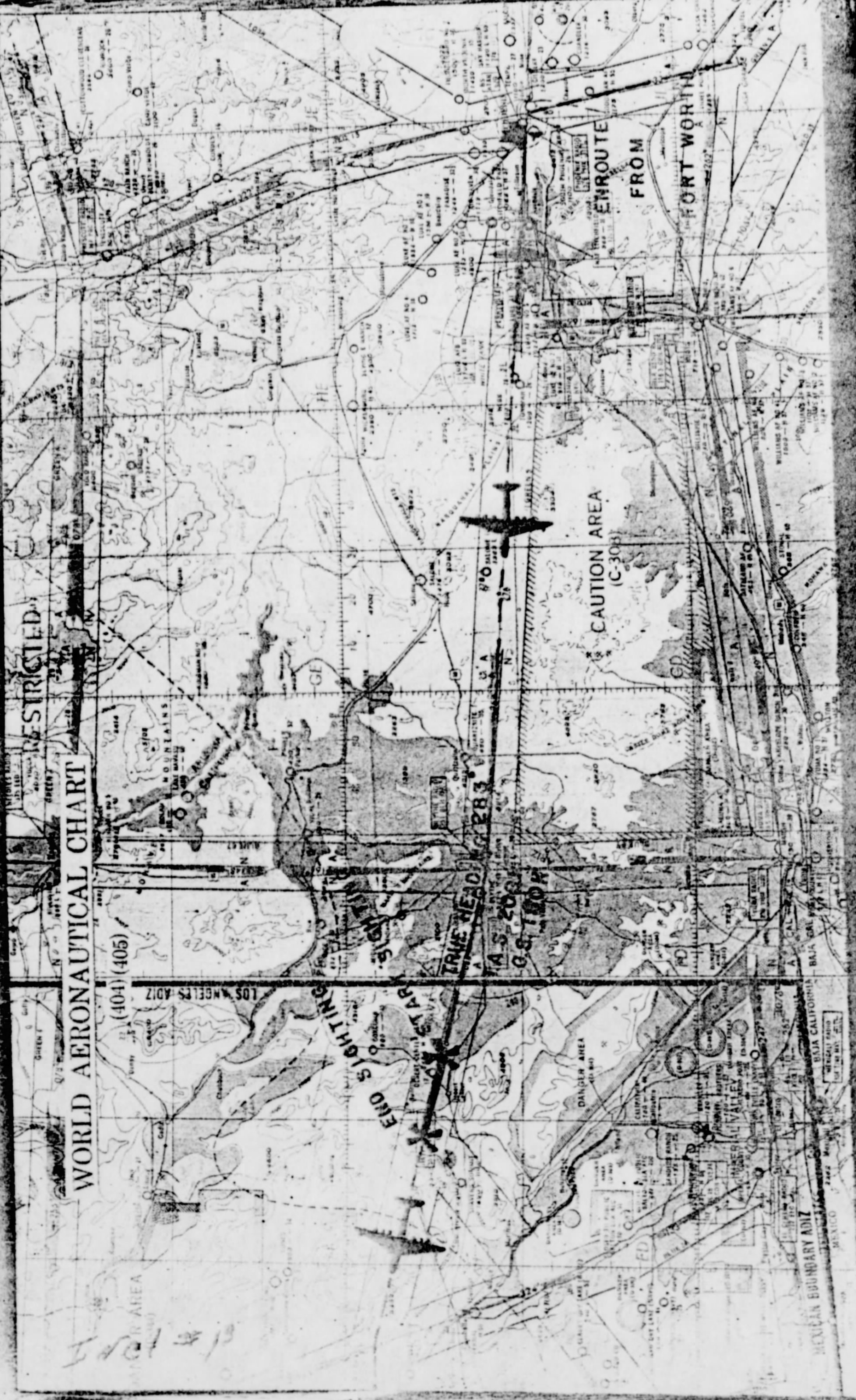
It is the opinion of the preparing officer that the sighting reported was observed as stated in each of the crew member's statements, and it is definitely worthy of a flying object report.

On the 4th of February 1953 I was scheduled to ferry aircraft 52-1372, an RB-36, from Convair aircraft company to Travis AFB, California. While flying on airways from Blythe to Riverside my pilot reported an object at seven (7) o'clock high. The time was 1650 pacific standard time and we were located approximately 5 miles East of Desert Center, California, flying at 20,000 feet. The object appeared to me the same as sun rays reflecting off of a metal surface. No vapor trails were visible from the object. It's relation to our aircraft stayed the same, for example like a star or the sun does while flying on a straight course. I could not determine the distance of this object. It disappeared behind a cloud 5 minutes after I first saw it.

On a ferry trip from Ft. Worth, Texas to Travis AFB, California on 4 February 1953 at 1650 pacific standard time, Captain David Smith the pilot sighted an object through the navigator's astradome at 7 o'clock high. He called by attention to it and I looked out the navigator's astradome and saw a white object which appeared to be round in shape. As to size and how high the object was above us I could not say; but it appeared to be about the size of an aircraft which is at 30,000 feet above the ground. The object appeared not to move while I was observing it. The exact location was 33-43 North latitude and 115-16 West longitude. The altitude of our aircraft was 20,000 feet. The true heading was 283°. The true airspeed was 200K and the ground speed was 180K. The object was sighted at 1650 pacific standard time and was observed for approximately 5 minutes.

On a ferry trip from Ft. Worth, Texas to Travis AFB, California on 4 February 1953 at approximately 1650 pacific standard time someone sighted an object in the sky at "7 o'clock high".

I looked out the window aft of the engineers station and saw a round white object similar to a full moon in every respect except size of indeterminate size at an indeterminate altitude. After flying about seven (7) or eight (8) minutes we flew under a cloud that was approximately 5,000 feet above us (our altitude was 20,000). This gave me an opportunity to judge the height of this disk as being 30,000 feet. I would estimate the size as being 15 to 20 feet across. The object made no movement while we observed it, if it ascended it was a very small amount. The exact location was 33-43N - 115-16W.

STATEMENT

On 4 February 1953 at about 1650 hours I was aboard RB-36 aircraft number 52-1372 over Desert Center, California at 20,000 feet. At that time the Navigator called my attention to an unidentified object above and behind the aircraft. I checked our position and found it to be about 5 miles east of Desert Center. I then went back to the left forward sighting blister and observed the object myself. It appeared as a bright white ball, much brighter than the high cirrus cloud behind it. I would estimate altitude at 40,000 feet and its position 30 miles ESE of the aircraft. Its motion was stationary. The sun was behind me as I looked at the object, about 15° above the western horizon. This object did not appear to me to be an aircraft or a weather balloon. I have no further opinion as to its identity.

On 4 February 1953, at 1650 on a flight from Carswell AFB, Texas to Travis AFB, California I observed a white object much higher than our aircraft. It was at approximately 6:30 o'clock high. It appeared to be moving slightly. As it moved the sun rays were reflected off of it. I observed it first with clouds as a background, then it appeared cleared as it moved out of the clouds. It was brought to my attention by the Radar Navigator. I observed it from the right upper forward blister for approximately 10 minutes.
