about 2205 hours, 28 April 1954, A/1C O'DONNELL E.
GALLAGHER, AF 18120747, 824th Operations Squadron, assigned duty
as Dispatcher, Base Operations, Carswell Air Force Base, tele-
phonically notified Special Agent PAUL A. WILKS, OSI District No. 23,
about an unidentified object over the TCU Airport, hovering at about
4,000 feet. The object was cited and reported to GALLAGHER by Mr.
Port North, Texas,
telephone WA-1347, at about 2140 hours. The description of the ob-
ject according to GALLAGHER, as related by was "T-shaped,"
with the varied colors of blue, green and white. GALLAGHER further
advised that the object was, at the time of the telephone conversa-
tion, reflecting on the Carswell AFB Weather Station Radar Storm
Detector at about 110 degrees true heading, 4,000 feet and about
1/4 mile from Carswell AFB. GALLAGHER stated that Air Traffic
Control had also alerted him reference the object; and that the Mes-
siah Field tower operators had visually observed the object. In
addition, GALLAGHER stated that Utah Radar Site had picked up the
object on their radar, positioned as reported by the Carswell AFB
Weather Station.

2. Mr. student at Texas Christian Univer-
sity, telephonically stated at 2220 hours, 28 April 1954, that he and
his friend first observed the object at about 2055 hours; that
it changed color from red to white to blue, and had a green tail of
some kind. stated he drove to the TCU Airport and talked to
two of his flight instructors, that the instructors also had observed
the object; and that the three of them watched the object for a short
period of time advised that during this period, the object
seemed to be hovering over the TCU Airport between 3,000 and 6,000

feet. Upon questioning, [redacted] stated his flight instructors did not comment on the size of the object, but that he would estimate it to have been about the same size as a Twin Beechcraft. Upon his return to his girl friend's house, 3912 Weyburn Drive, [redacted] stated he telephoned Carswell, and while talking to an officer of Carswell AFB, the object moved west and disappeared. [redacted] stated that subsequently another object appeared and remained stationary for a short period and it, too, disappeared. During the telephone conversation with [redacted] Special Agent WILES, [redacted] stated another object of the same description was at that time, 2225 hours, again visible, hovering about one mile north of the TCU Airport.

3. At 2240 hours, Airman GALLAGHER was again telephonically contacted for any additional occurrences, and he stated that the WAF tower operator, Carswell AFB, [redacted] had observed a red flashing object over Meacham Airport. However, upon request, GALLAGHER obtained information from Meacham tower through the Carswell AFB tower that a DC-3 aircraft had landed to the south at Meacham Field, just after (approximately three minutes) the reported sighting. GALLAGHER also advised that all radar trained on the unidentified object as previously described had, at intervals, lost and regained the blip on their scopes. Upon questioning, GALLAGHER stated Utah Night had vectored two jets (type and station unknown) to the area; and that Air Traffic Control had requested a T-6 on local flight out of Hensley Field to check the area for the object. At this point of the phone call, GALLAGHER stated that the Meacham tower operators reported observing another object over Meacham Field. GALLAGHER concluded by stating that Major WINSTON P. RICE, AO 671769, 436th Bomb Squadron, the Airdrome Officer, and Captain STINSON (NFI), Flight Service, Carswell AFB, had knowledge of the objects; and were at that time checking same. GALLAGHER was at this time requested to advise the OSI of any serious developments.

4. At about 0615 hours, 29 April 1954, Major RICE advised Special Agent WILES the object which had been visible on the Storm Detector Radar in the Base Weather Station the previous evening had again been visible at about 0700 hours, 29 April 1954. Upon recheck at about 0615 hours by Major RICE and Special Agent WILES, the object was visible, positioned as previously described. Special Agent WILES requested Major RICE, upon notification of 7th Bomb Wing Intelligence Office, in accordance with Base Operations SOP, to advise that office that the information obtained by OSI would be made available upon request. In this respect, RICE was advised that investigations of unidentified
