At approximately 1125 30 May 1955 I received a call
from Mr. [REDACTED] during which he stated that he had
found a very light weight rock that was colored black
with white spots and a portion of which was of a
grayish color. He stated that the rock had many small
holes in it and appeared to have been heated to
extreme temperatures. This rock is extremely hard
and he was unable to chip any of it off.

Mr. [REDACTED] expressed the belief that this rock was
of meteoric origin and said he would bring it to ATIC
Tuesday 31 May 1955 at 0715.

Received call approx. 2135 from a Gen. West of Englewood, Ohio who stated approx. 2130 he saw object going west. This object appeared as a bright blue flame with some orange coming to a point. The object was seen northwest of Englewood, Ohio and was going down at a 15° angle disappearing behind trees. The object was seen by West for approx. 3 seconds and was going at a speed approx that of an airplane.

Maj. Gilmore, Patterson Field, Airborne Officer, called (51131) who in turn called the 97th Fighter. None of their planes in area.

Airman Davenport of 97th Fighter Sqd called and said one of their pilots, Lt. Pruitt saw supposedly the same object. Said it was falling meteor.
