- (2) Description of course of objects:
 - (a) Person was watering lawn when he happened to glance at the sky
 - (b) Angle of elevation approximately 45° and azimuth approximately 340° when objects were first sighted
 - (c) Angle of elevation approximately 30° and azimuth approximately 70° when objects disappeared
 - (d) When objects were first sighted they formed a square with one object in each corner, next the object in the upper left hand corner moved down in line with the bottom two objects forming a 45° angle, next the object that moved went back to its original position, then the object in the upper right hand corner moved across in line with the objects on the left forming the letter "L", these two maneuvers were repeated approximately two times each, then the objects moved into a straight, level and evenly spaced flight path toward the East North-East until they disappeared.
 - (e) Objects disappeared by passing out of range of vision.
 - (f) Objects were in sight approximately 15 minutes
