1. The following UFOB Report is submitted in narrative form rather than following provisions of AFR 200-2 due to the nature of sightings and action taken.

2. On 7 February 1957, between 1053Z and 1232Z, the 685th Aircraft Control and Warning Squadron at Las Cruces Air Force Station, New Mexico, carried a total of 54 unidentified blips on their radar screen traveling from the north toward the station at speeds of 60 - 160 knots at altitudes of 6 - 14 angels. Targets disappeared approximately three miles out and failed to reappear north of site. Initial sighting consisted of 23 blips. At the same time the 666th Aircraft Control and Warning Squadron at Roswell, New Mexico, had a number of blips, but insufficient movement to establish track information. Four interceptor aircraft were scrambled out of 15th Fighter-Interceptor Squadron at Tucson, Arizona, and 93rd Fighter-Interceptor Squadron at Albuquerque, New Mexico. No unusual sightings were made nor was anything unusual seen. Encounter Charlie Two (15th FIW) had radar contact with four targets which were lost in ground clutter almost immediately and a fleeting radar contact with 13 targets approximately 100 miles north-east of El Paso, Texas. No other radar contacts were made by any search aircraft. The area was patrolled for approximately 40 minutes with no results.

3. Consultation between ADC Weather Detachment at 34th Air Division (Defense) and ADC showed that weather conditions in the area of targets was conducive to temperature inversion which could readily cause the type of targets indicated.

4. Visibility in general vicinity of targets was good.

5. The Controller on duty at the time of the incident has stated that his opinion of the targets is that they were caused by temperature inversions.

6. Another possibility exists in that SAC mission of 18 - 21 KC-97, B-47, and B-36 type aircraft had been in the air, and possibly the vicinity, at the time of fighter aircraft scramble. Due to terrain "dead spots" around the 685th AC&W SQDN it would be possible for aircraft to fly over the site, make a turn and fly down the Rio Grande River to El Paso, Texas, without being picked up again after initial fade out.

7. It is the conclusion of this Headquarters that due to number and speed of targets, lack of visual and definite radar contact by interceptor aircraft, Weather
