1. Description of the object:

a. Round.

b. Three of the observers, S/Sgt Simpson, A/2C Bowman, and A/2C Durham, thought it was the size of a pea, while another observer, A/1C Watland thought it was the size of a basketball.

c. All observers state that it was a bright, white light.

d. There was only one object.

e. N/A

f. N/A

g. Two observers, S/Sgt Simpson and A/2C Bowman, say there was no trail or tail. One observer, A/2C Durham, states there was a small bluish-green trail directly behind the object. One observer, A/1C Watland, saw a long red trail that faded out about one-half to three-fourths of a mile behind the object.

h. No sound was discernible.

i. None.

2. Description of course of object:

a. The two observers that saw the object first, A/2C Bowman and A/1C Watland, were watching three F-84's making a landing.

b. Angle of elevation was 30 degrees and the azimuth was 320 degrees when first observed.

c. Angle of elevation was 30 degrees and the azimuth was 140 degrees upon disappearance.

d. Straight and level flight path with no maneuvers.

e. The object gradually disappeared into the distance.

f. Estimated at 5-10 seconds from first sighting to last observance.

3. Manner of observation:

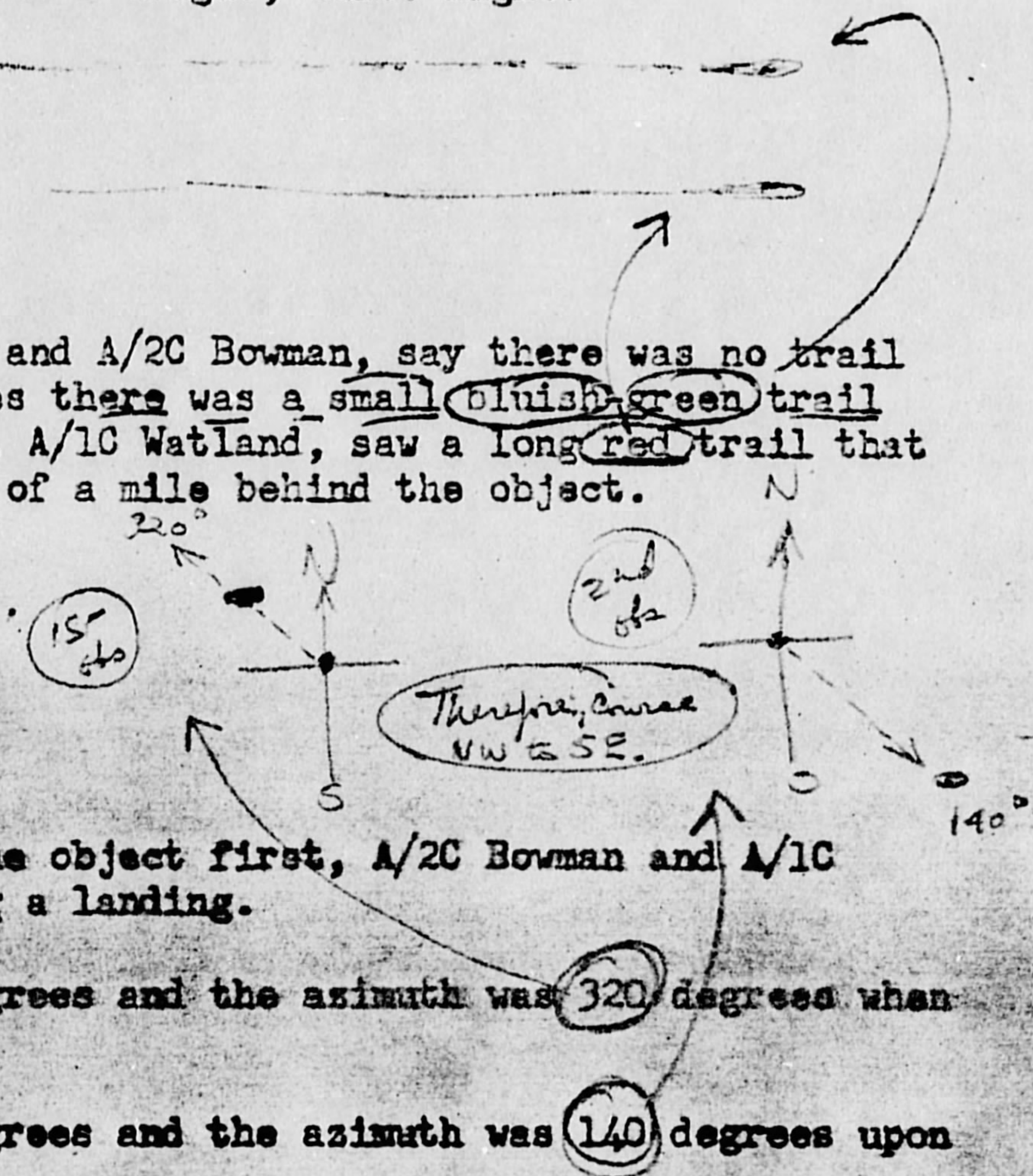
a. Ground - visual by observers, Simpson, Watland, Bowman and Durham.
Air - visual by Major Brandt and Captain Church.

b. No optical aids were utilized.

c. The air-visual sighting was made from a C-47, #24073, that was flying 2300 feet to 2500 feet on a heading of 170 degrees, at a speed of 140 knots. The aircraft was from Randolph Air Force Base, Texas.

5. Location of observers:

a. S/Sgt Simpson, A/2C Bowman, A/2C Durham were on duty in the East Control Tower, Randolph Air Force Base, Texas.

b. Major Brandt and Captain Church were airborne 5 miles north of Randolph Air Force Base.

c. A/1C Watland was on the ground about 100 yards from East Control Tower, Randolph Air Force Base, Texas.

6. Identifying information of all observers:

All of the observers are highly qualified personnel in their career field and are considered as excellent observers; and, due to their location at the time of sighting, were able to see the object from several areas in and around Randolph Air Force Base.

C-47 #24073 replied affirmative. They contacted Head Man, a radar site at Lackland Air Force Base, Texas, to see if they picked up anything on radar. Negative report.

10. Three F-84's in Randolph flight (let-down) pattern; one C-47 five miles north of Randolph.
