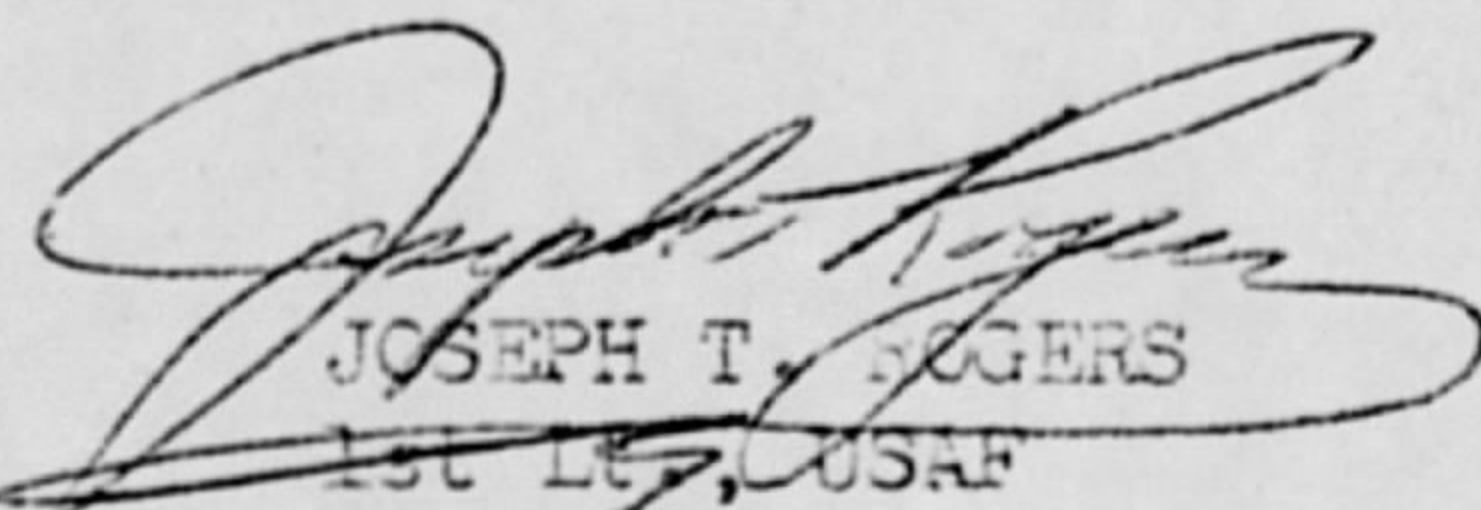

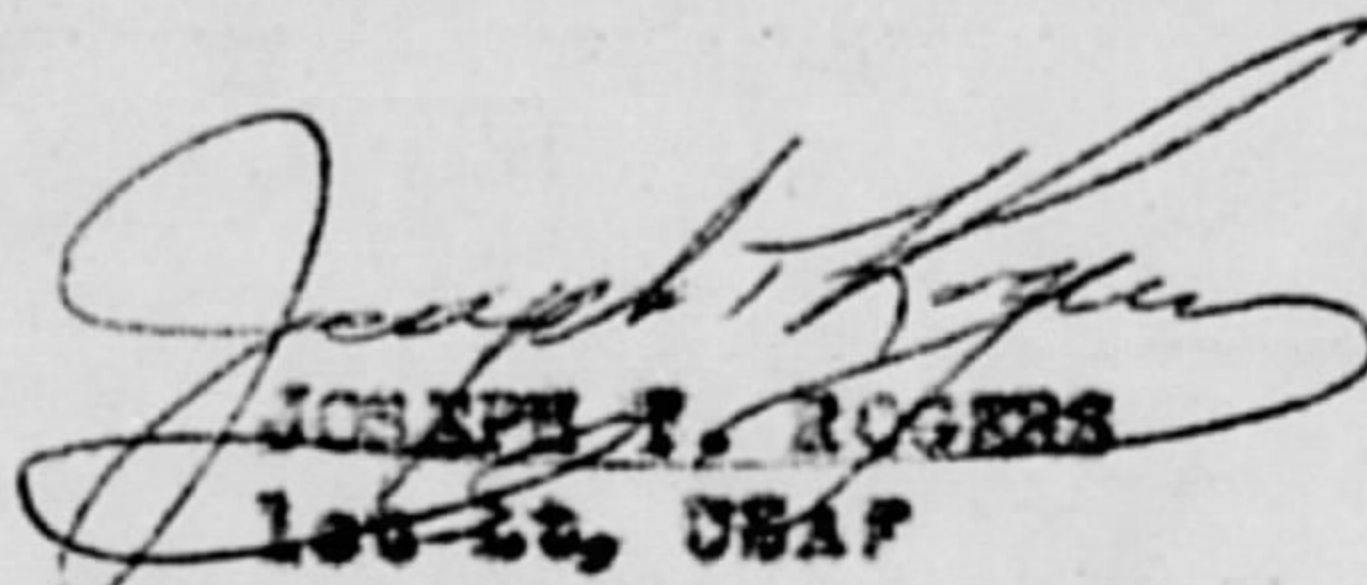
This could have possibly been a reflection from an aircraft which passed at the time of the sighting, the aircraft was heading east.
