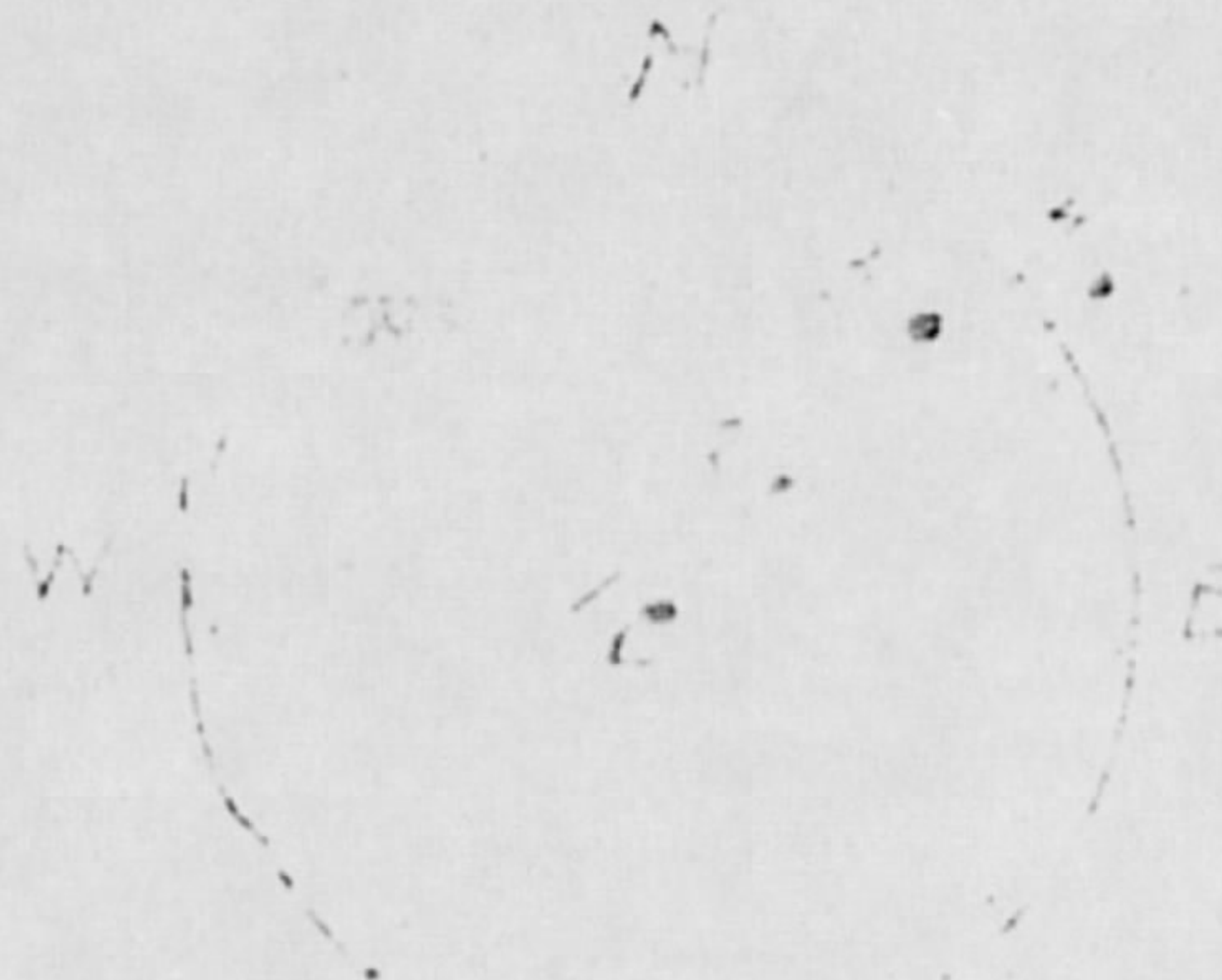
GENTLEMEN:
