ATIC Conclusions: Probably
a high altitude ~~jet~~ a/c. This is
similar to many reports for ZI of
tiny lights moving slowly in
a straight line for a number of
minutes — which have found to be
aircraft at high altitudes — and
generally confirmed by checks with
radar and flt. ops units in the
area.

Difficult to follow-up on unidentified
foreign sightings unless the local
base C.O., authorities, or others
do so. Data rather limited.

1. On 16 September 1957, source stated he and his wife observed an unidentified flying object (UFOB) while traveling in Southern Italy. The following information concerning the observation is forwarded in accordance with AFR 200-2 and BAIR 4607 for evaluation:

- a. Shape - circular.
- b. Size - about the size of the planet Mars. *← * ← Timing*
- c. Color - same as Mars, at its brightest.
- d. Number of objects - one. ✓
- e. Formation - N/A.
- f. Features or details - the UFOB reminded source of a V-1 in flight.
- g. Tail, trail or exhaust - none (just a light) *← blue*
- h. Sound - none.

2. Description of course of object:

a. Source and wife were driving in Southern Italy, from Potenza to Altamura, on Route No. 96 in a convertible. Source's wife first noticed the UFOB and called it to the attention of her husband. They stopped the car to observe the UFOB.

b. At the time of the sighting the automobile was pointed in a northeast direction and the UFOB crossed at an angle to them, in a west to east direction. *↗*

c. Same.

d. UFOB did not maneuver but maintained a straight course at apparently the same altitude. *~~~~~*

e. Manner of disappearance - after approximately five minutes, source resumed driving and UFOB was lost from view behind mountains in the area. *← Note: Long time duration*

f. Length of time in sight - five minutes. *← Important Clue*
