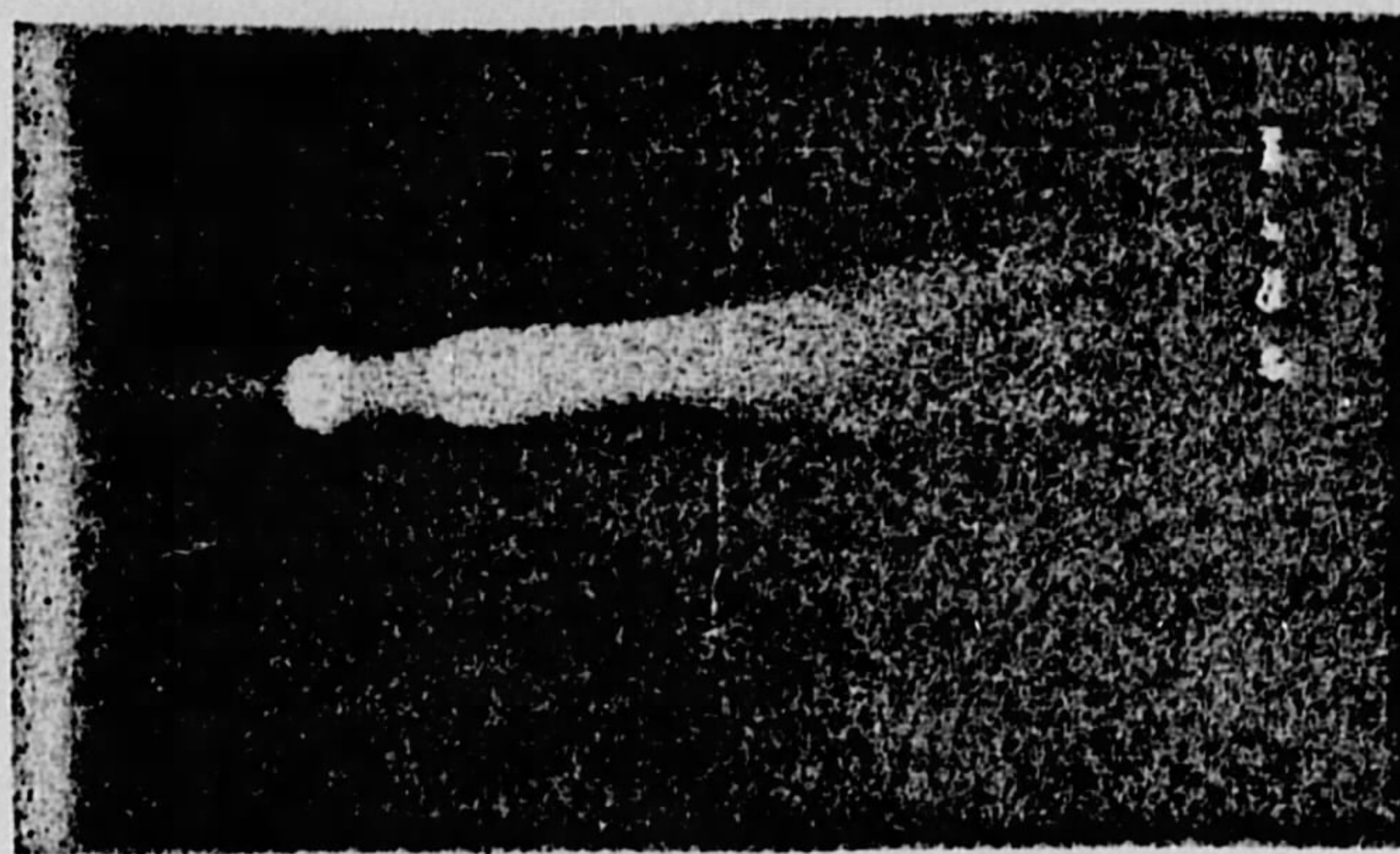

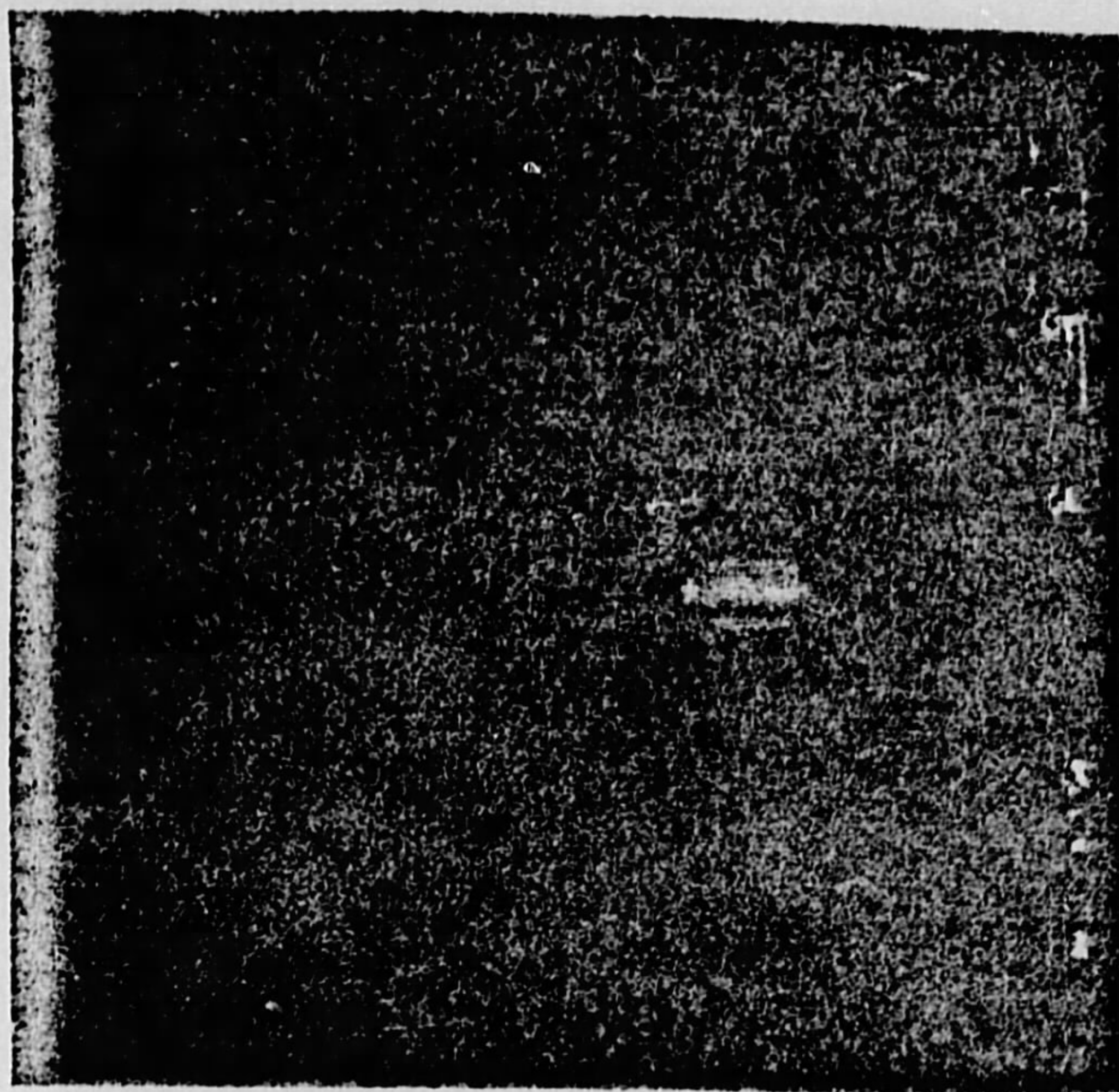

 South a bunch o f red lights flickered on and off could not coun them.

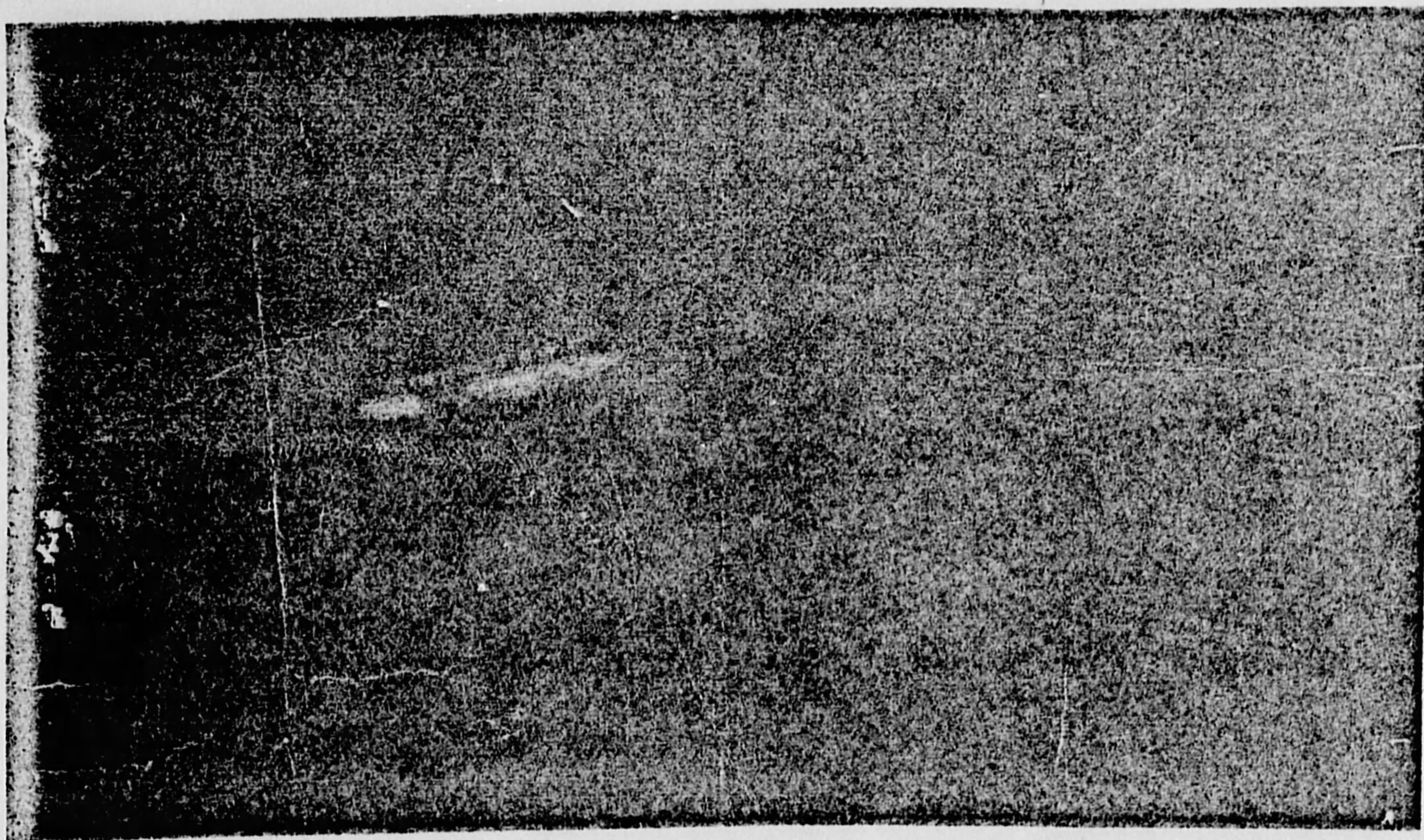
