March 2, 1958; Tampa, Florida:
As reported by Station WTVT "Late News"
the International Airport control tower
crew saw a "large silent orange-lighted
object" land on the far end of a runway
and immediately take off again "like a
helicopter." Later MacDill AFB said the
object might be a lighted weather balloon
released 30 minutes before the sighting.
NCAE Notes: Only a serious leak would
have caused the balloon to land and no
balloon with such a leak would suddenly
take off again.

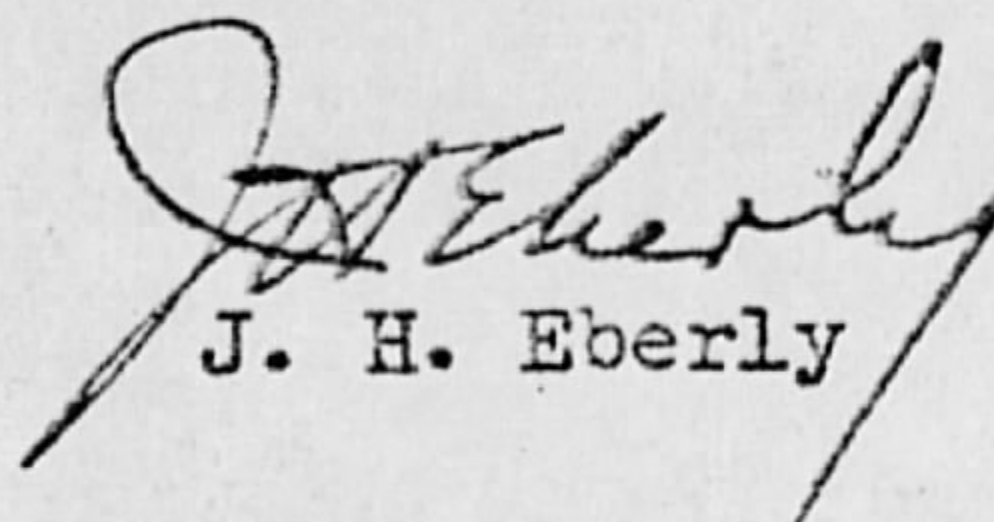

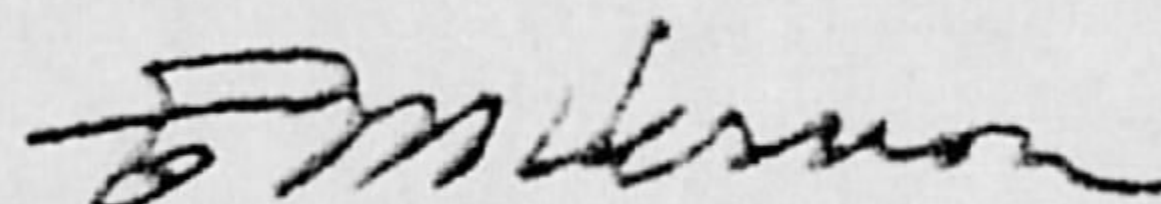

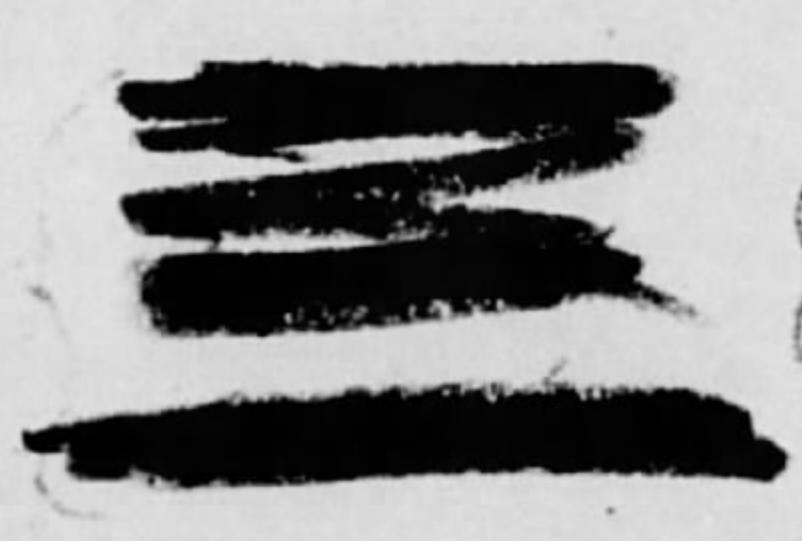
SUBJECT: RAWARC

SUBJECT: Unidentified Flying Object.

1. Date of occurrence was Sunday evening, 8:45 to 9:00 P.M., E.S.T., March 2, 1958, not March 1.
2. Meteorological factors and pilot reports indicated severe, possibly extreme turbulence over Tampa and vicinity. Turbulence in varying degree- moderate to "heavy", according to pilot's reports, occurred throughout the afternoon and evening on March 2.
The stability index, on the Tampa 0000Z, March 3, R/S observation was minus 3. This R/S was released approximately 2 hours before the object was reported.
3. This object was first reported to me by the Tampa tower. They wanted to know if we had released a large red balloon the size of the R/S balloons, with a bright light on it, adding that what appeared to be one had landed on the airport. I told them no, and was told they would send a truck out for it. Soon the tower called again and said it was rising- this time all

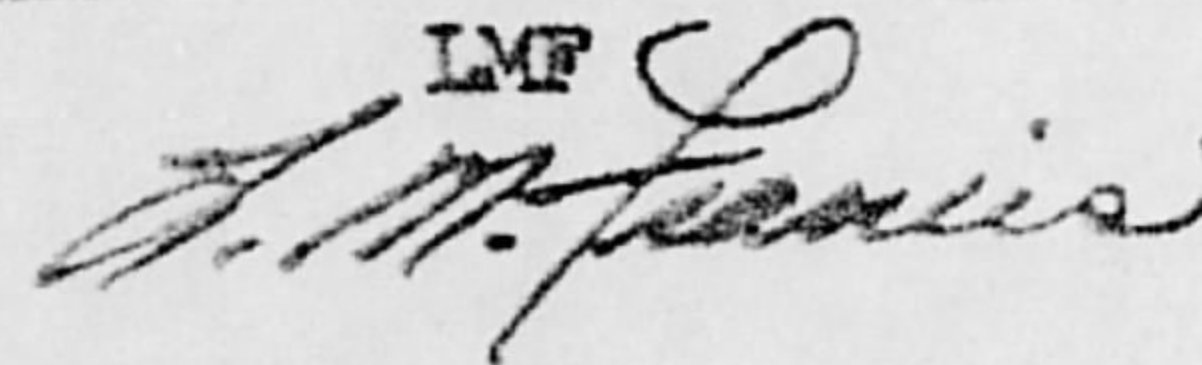

three of us on duty went outside and saw a rather bright light (white) hovering nearly stationary, just under the clouds. (ceiling was measured 800ft at 1958Z and 2058Z on March 2nd). After a short time, it moved off and disappeared.

Shortly thereafter, Mr. Burnham answered a call on the public telephone. It was from a man who said he and his girl friend, parked near the airport, had also seen the object descend and rise again. He told Mr. Burnham his girl friend was quite frightened by the incident. A short time later the Tampa tower denied seeing anything unusual.
