List inclosures, including number of copies) At 0953Z, 27 April 1958, three members of an AEW&C RC-121, spotted a bright orange-red object which passed in front of the aircraft. The object had not been picked up on the aircraft's radar and a check with the land-based ground site indicated no known aircraft flying in the area of the sighting. (Details, see Part II of this report.) COMMENTS OF PREPARING OFFICER The sighting was made by three persons, who are familiar with the area of the incident and the nature of airborne traffic in that area. The pilot conceded that it may have been an afterburner but felt a report should be made since: 1. Visibility was good but no aircraft structure could be seen; 2. The object was not picked up by the radar of the RC-121; and 3. A check with the land-based ground site reported no known aircraft in the area of the sighting.
