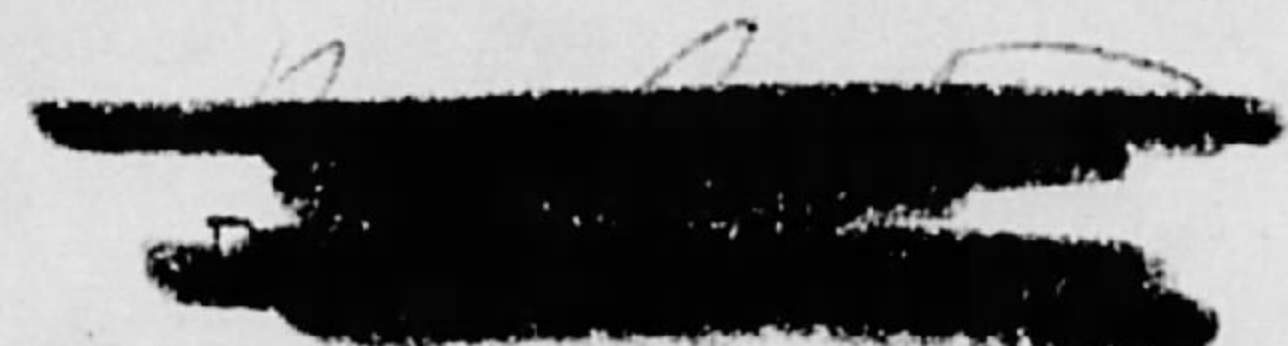
If you desire the negative for examination, I would be willing to send it to ATIC. However, its return must be guaranteed, as I do not want to risk losing it and the other attached negative.

There was nothing visible to the naked eye above the aircraft.

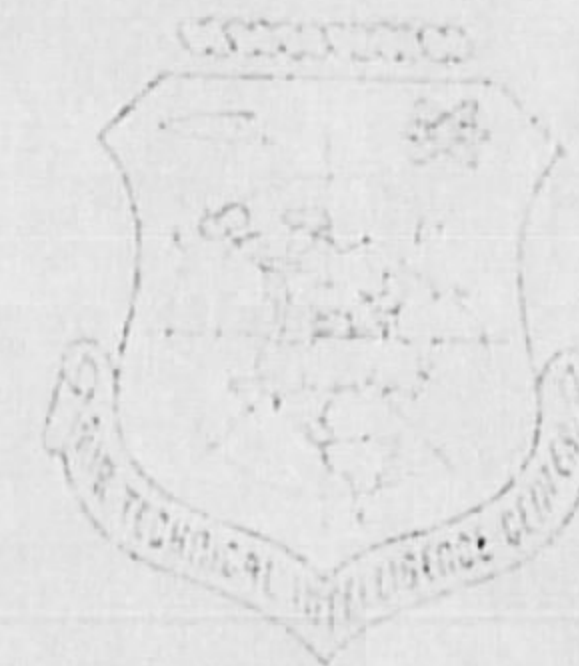
As I said in my earlier letter, I would pass it off as defective developing or something of that nature, except for that fact that the streak does not continue into the border or the other negative.
