Dear Sirs,

I am writing you to report
an observation I made on the night
of May 27, 1959. I give it to you
in my own words.

On the night of May 27, 1959
at 9:30 P.M. I looked out of the car
window. I saw four lights. The
night was cloudless and all day
there had been no bad weather.

I thought they might be reflections
on the glass so I rolled down the
window, they were still there. They
seemed to be going at a fantastic rate
of speed. I will not give my guess at what
speed they were going. It would be too
fantastic. They seemed to be moving in
a southerly direction. The lights were
in a winged V formation all perfectly
spaced. At 10:30 P.M. the brightest
light (of which was leading) began to
transmit red dots. I watched until they
faded away. At 11:00 I could see them no
longer. But at 11:30 a bright white flash

arose went about a mile up took a
ninty degree angle turn and then
went back down in the exact place
where thirty minutes ago the ~~the~~
brightest of the four lights
went down beyond the horizon. I have
no explanation of what they were. That
is why I am writing you. Could you
please give me an explanation.
