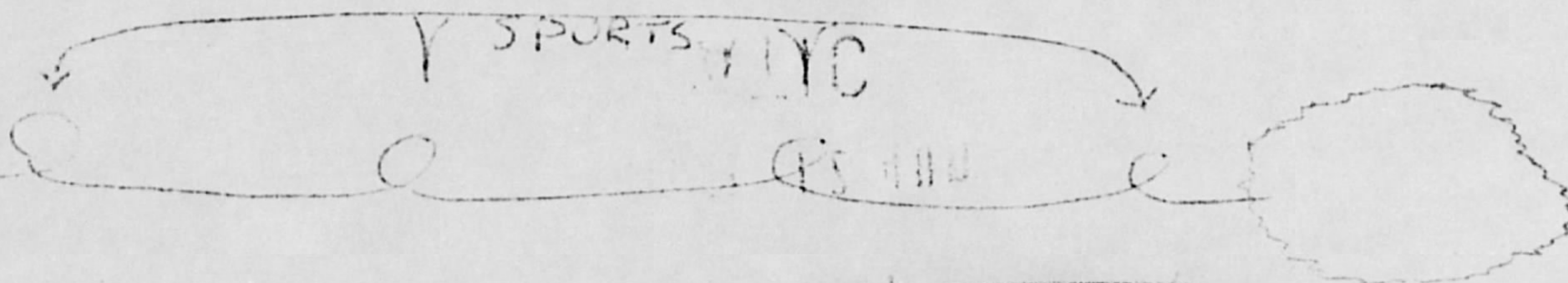
DEAR SIR:

IT WAS SUGGESTED THAT I WRITE TO YOUR GROUP EXPLAINING A STRANGE OBJECT WHICH WAS SIGHTED OVER SHELTON, CONN. AUG 19th. BY SIX ADULTS OF AVERAGE INTELLIGENCE.

AT 9:10 PM EDT, LOOKING AT THE SKY IN A SOUTHWESTERN DIRECTION, WE SIGHTED AN OBJECT MOVING RAPIDLY IN A NORTH EASTERN DIRECTION. AFTER VIEWING IT FOR A MINUTE OR SO, WE CAME TO THE CONCLUSION IT WAS NOT A SHOOTING STAR OR JET. WE THOUGHT POSSIBLY THAT IT MIGHT HAVE BEEN AN ARTIFICIAL SATELLITE OR SPENT COKE. AS IT WOBBLED OR SPIRALED AT ALL TIMES. LENGTH OF TIME SIGHTED WAS A GOOD THREE MINUTES UNTIL IT VANISHED INTO THE HORIZON. ITS BRIGHTNESS AND COLOR WAS THAT OF A 1ST MAG. STAR, AND ORANGY. AFTER IT HAD PASSED OVERHEAD THE COLOR SEEMED TO TURN TO A BRIGHT ORANGE RED.

ALTITUDE WAS HARD TO DETERMINE, BUT COMPARING TO THE STARS IT SEEMED TO BE AMONG THEM.
