REMARKS

Herewith, 3 enlargements of a photo taken on 21 Apr 1960 in the Guantanamo Bay area (Cuba) by a US soldier.

The basic photo was taken with a Zeiss Ikonette 35 mm camera, using a speed of 1/50th of a second and an "F" stop of 11 or 16. The picture was taken between 1000 and 1200 hours, aiming toward the southwest.

The soldier who took the photo did not notice the disc-shaped object which appears in the upper left of the picture.

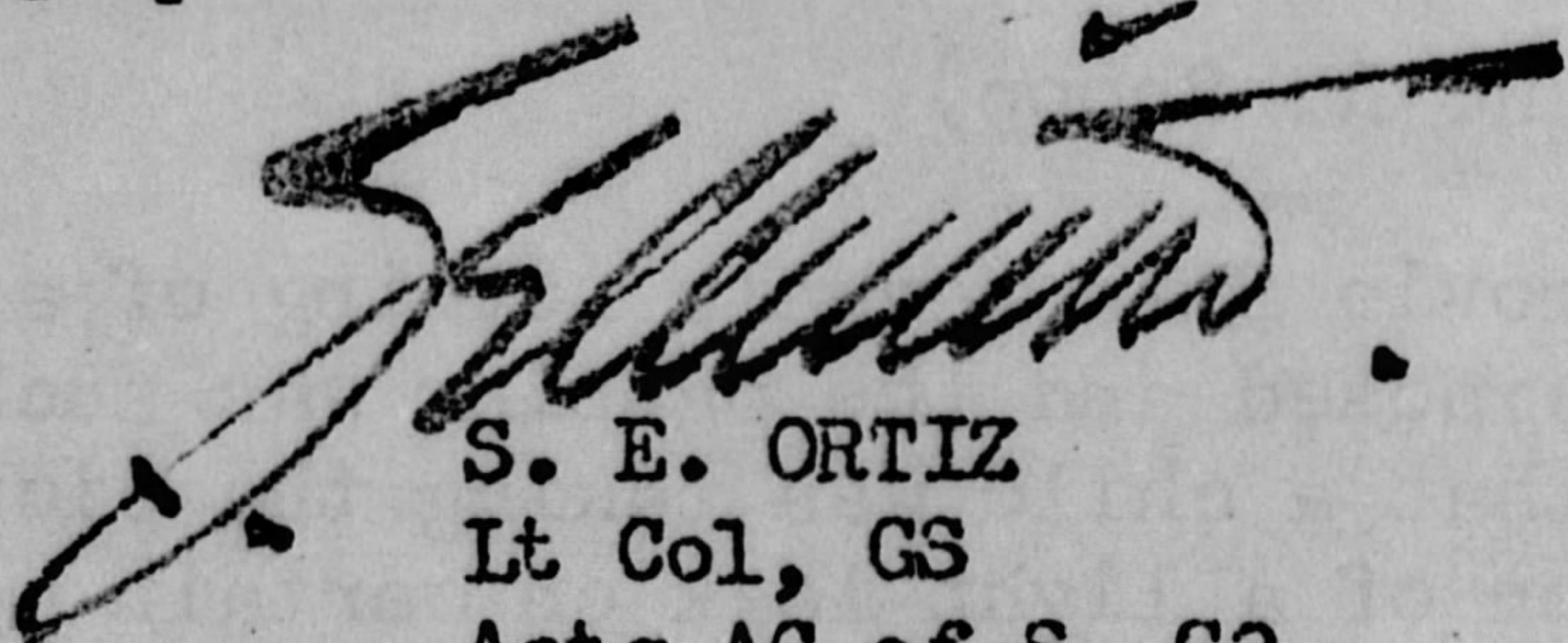

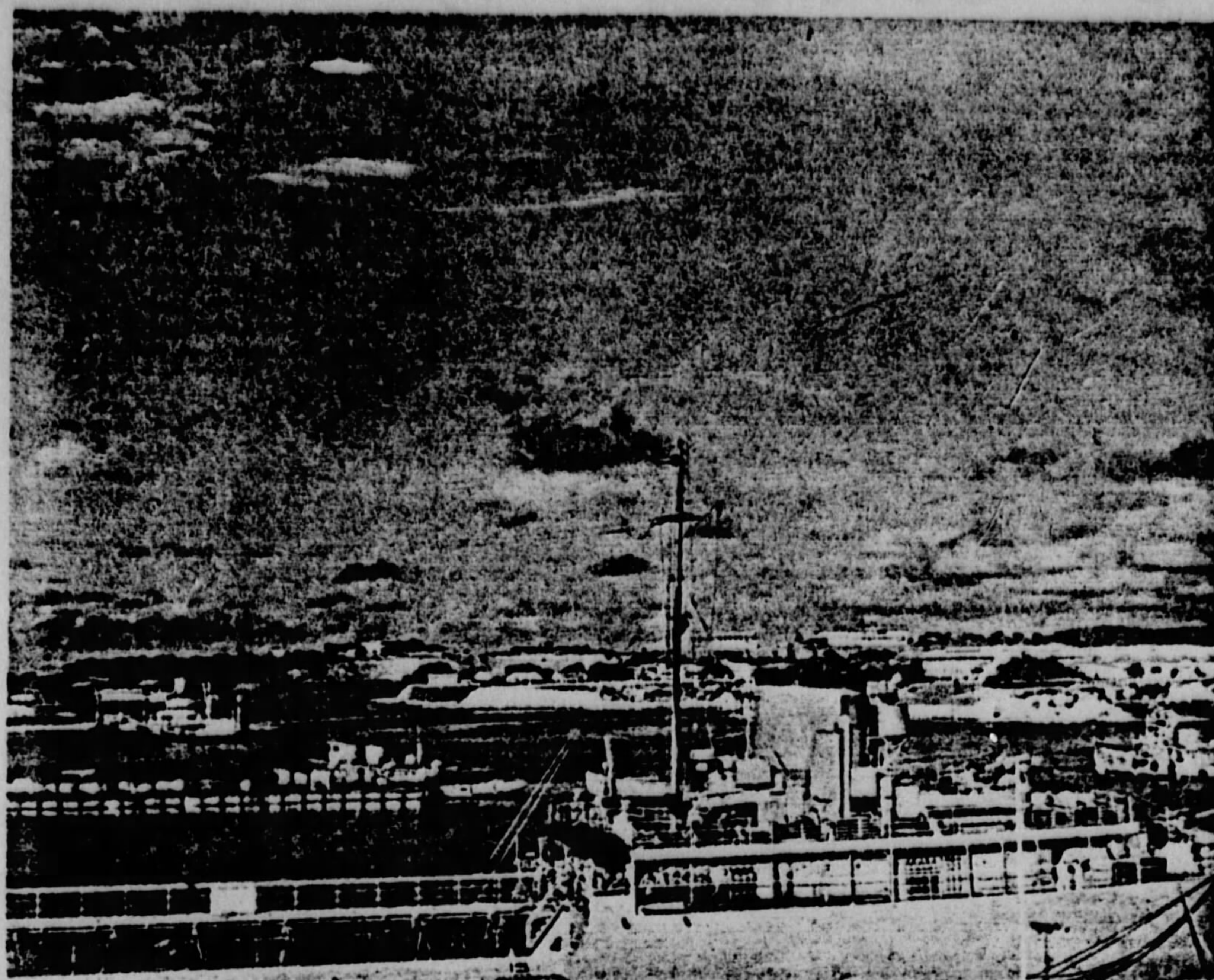
1. Analysis of the movie film reveals nothing of an unusual nature. The film was poorly exposed and the panning was such that it is plausible to assume that a child was taking the pictures. There was also an indication of a light leak on certain portions of the film. The Air Intelligence Information Report was of no value as there was nothing in the film which even remotely resembled the objects mentioned in the report.

2. The 35MM transparency was probably exposed inside of a building and through a glass window. The object in question is probably a reflection on the window from a light hanging from the ceiling. The inside of the shade creates an elliptical shape and the strong white area in the top central portion is the light bulb which also gives off a halation creating the "bump" on the top of this reflection.
