1. Reference attached copy of message from Satellite Organ to Satellite, Cambridge, Massachusetts, dated 12 October 1960. This message is concerned with the sighting of unidentified flying objects by Mr [REDACTED]. The sighting occurred on 12 October 1960 in New Mexico.
2. The ATIC analysis indicates that the objects of this sighting were probably high flying jet aircraft. The angular velocity reported by Mr [REDACTED] results in a linear velocity well within the capability of jet aircraft and much too slow for meteors.
3. Telephone contact with Mr [REDACTED] reveals that he believes the objects were high flying jet aircraft. The conversation with Mr [REDACTED] also brought out the description of lights seen in conjunction with the objects which also indicates that they were probably jet aircraft.
4. ATIC has not as yet been able to pin down the specific operation to which the aircraft belong, but when and if this information becomes available your organization will be advised.
