Object estimated to be 5-8' in diameter and was observed at a distance of approx 20'. Object was in sight approx 10 min. then simply disappeared. Younger witness had experienced seeing same phenomenon on another occasion.				11. COMMENTS Phenomenon responsible for this sighting was probably "ball lightning". According to a paper on ball lightning by [redacted] Swedish scientist, dated 12 Sept 51, this phenomenon can exist in the sizes described by the Conn. witnesses and may appear reddish in color. Disapation of lightning may come due to a change of temperature. If the change is sudden and extreme an explosion may occur. If cooling occurs on one side or the other a mechanical

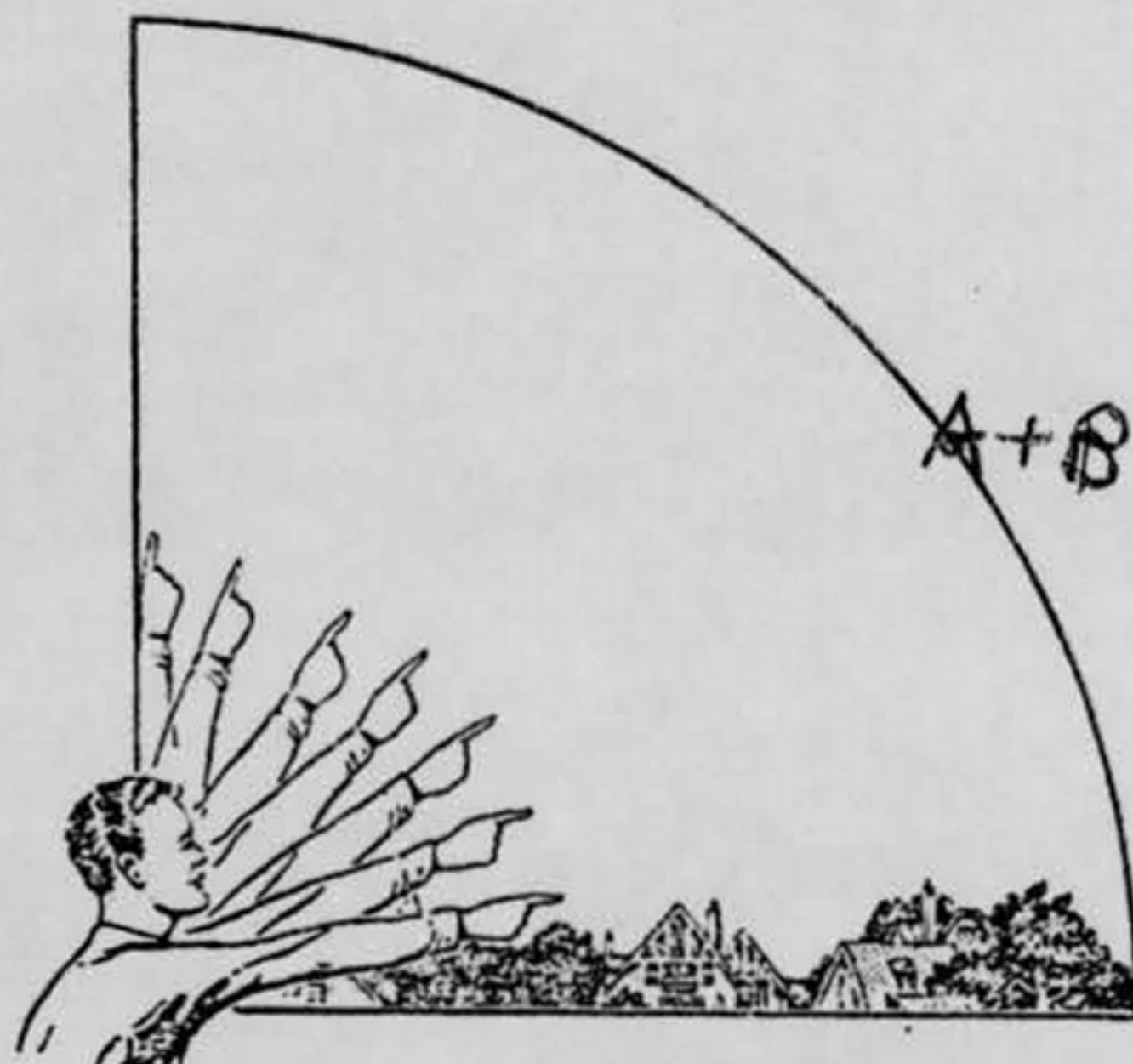

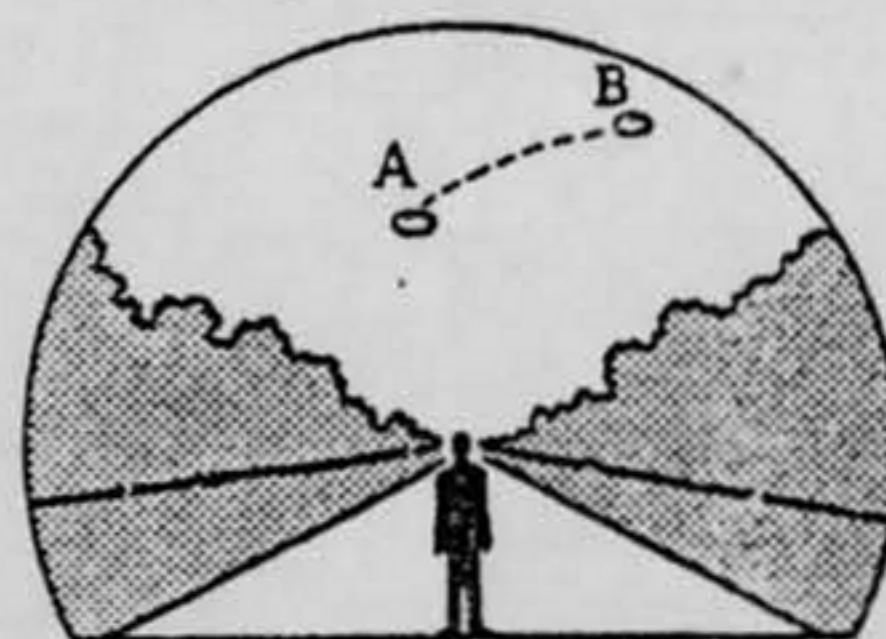
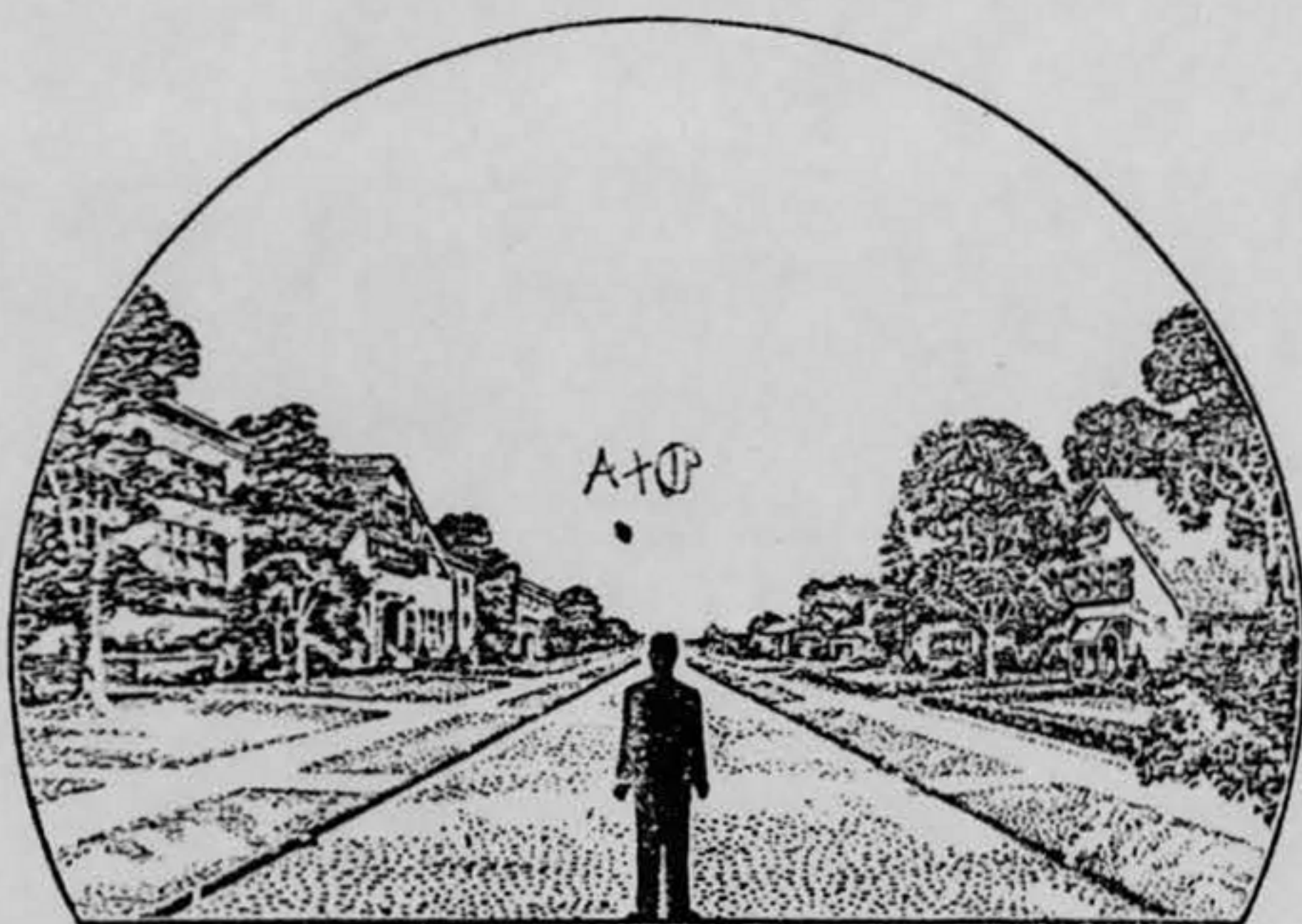

Oct. 9, about 7pm in October. I was going with my father to meet a friend in Norwalk, Conn. We were on an old dirt road and we missed our turn off to the proper one. As we got the instructions to make a U turn and go back down the road where our proper turn off would be, (son) got out of our car to aid in the U turn. As I turned towards the back of the ~~other~~ car, there it was. Orange colored, about ~~5-8~~ 5-8 inches in diameter, round and just standing about 15 feet above

the ground, and dimly glowing. My father not being scared as I was got out of the car, and went a little closer for a better look. He returned without any explanation and we both returned into the car. He told me to back up the car and make the turn. This would mean that I would have to back right under it. Well, we did it, and as we looked up as we passed under it, there were no remains of the object.

The reason why I wish a possible explanation is because this is the 2nd time I ^(son) have seen this thing, and it has aroused my interest in it. I have ample evidence of a friend and my father, that what I write to you is really what I say it is.

Dear Sir,

My name is [redacted]. I am 17 years old, and I live at [redacted] in [redacted]. I am writing to you because I wish you could help me out or give me a logical explanation for probably the strangest possible phenomenon.

One November day last year just before a large snow-storm that hit our area, I was walking outside my home with a friend of mine at about 6 p.m. (Miss [redacted] of [redacted]). As we both got out in the middle of the road in front of my house, my friend looked up and said "oh isn't that beautiful". As I looked up I saw a large object of about 10 feet in diameter having an orange-red color. This was a perfectly round object. This object was dimly glowing and didn't appear to be a solid. It had no definite border. By that I mean it had no definite ending of where you would say this still is the object and here is its end. The edges were blurred, although the entire object was almost entirely round. As we looked at it, it was approximately 50 feet high, straight above us. As we stood there we got extremely shocked because it started coming down on us at a slow speed. As it came down it swelled to almost 15 feet in diameter. The closest it ever came to us was about 5 feet above our heads. At that point we weren't interested in it anymore and we both ran hysterically to my house door step. I rang the door bell frantically but my parents were at the other end of the house so they didn't get to the door right away. Meanwhile this object came down almost level to the ground and just stood there about 30 feet from us. I made a frantic attempt to get away by running around the other end of the house to our kitchen entrance where my parents were having dinner. As I was about to enter the kitchen door, I heard my friend scream terribly. (She still remained at the front door, not wanting to take the chance of running into the open.) By the time that I got to the front door to let her in I saw her turn white from scaredness. She told me that she went out to see what this thing that scared us was. As she went out from the door step she said she saw it go way up into the sky until it became about the size of the moon or a little smaller. Then she said it changed color to a yellow-white and started down at her at extreme velocity. As it came down again it swelled up to being about 15 feet in diameter.

As we both were very scared we told my parents the story, and they both laughed at us and told us that we were dreaming. That was the end of the first sighting.

About 2 months ago (I don't remember the exact date) almost a year after the first sighting, My father (Mr. [REDACTED]), and myself ([REDACTED] , son) were going to visit a gentleman in Norwalk, Conn. On a business matter. We were right off exit 37 on the Merritt Parkway. We were on a small dirt road right off of the Parkway parallel to U.S. 7, which goes to Danbury, Conn. It was about 7 p.m. (1 hour after dark). We got lost on the dirt road and couldn't find the proper turn off. A car passed by and we asked for directions. The man told us just to back up a few hundred yards and there would be the turn off. My father told me to get out of the car and guide him for a U turn. As I got out and looked in back of the car, for a moment I got terribly scared, because the same object which my friend and I saw about a year ago was about 20 feet behind the car, 25 feet above the ground and about 10 feet in diameter. It had that same orange-red color. At that point I didn't need a second look, I just ran back into our car so fast that my father thought that I was completely out of my mind. This time my father got out of the car and looked at it. We were both standing there petrified at first but then as we kept on looking at it our fears were somewhat eased because it just stood there in mid-air and didn't do a thing. We both were standing there for at least 10 minutes studying the situation. My father not ~~being~~ ~~quite~~ as scared as I was started to approach it. He got within about 10 feet of it and then just stood there for a few seconds and then came back to our car. At first he wasn't sure what to say, but then he said " It is probably a phenomenon that happens once in a while which is unexplainable. He returned into the car and told me to back up the car for that few hundred yards and make the proper turn of the road. This would mean that I would have to back up right under this thing. First I hesitated but then I pulled myself together and said " Well what's the difference anyway " . As I passed under it and then passed behind it, it was a very tense moment for us. As we looked up after we had passed it, there was no trace of the object left. This was the last we saw of it.

Description of Object Seen

- 1) No noise from object.
- 2) No fumes or any objects came from it.
- 3) In the first sighting it had the capability to change colors.
- 4) Varied from about 3 to 15 feet in diameter in the first sighting.
- 5) It definitely was dimly glowing.
- 6) It had no definite border or edges to it.
- 7) It was almost perfectly round.
- 8) It didn't appear to be a solid, but rather a form of gas.
- 9) At the first sighting it had the capability to move in any direction at fast speeds.

Dear Sir, it is our hope that you look into this and possibly give us a logical explanation for these sightings. The thought of seeing it has kept my friend and me up many nights, and it has kept my father in a complete fog about what it could be.

The entire purpose of my letter to you, Sir, is to tell you that I () have seen this thing twice in my life, once with a friend and the other time with my father. I would have never if I alone would have seen these sightings, because you wouldn't think to much of my letter. I write to you only because I have ample evidence of my father and friend to prove that these sightings were really what I say they

I was thinking that maybe you have heard of such
 articular sightings and could lessen our fears by telling us that you have.

We would all be greatly honored to hear of any explanation that you might have or theories on this subject.

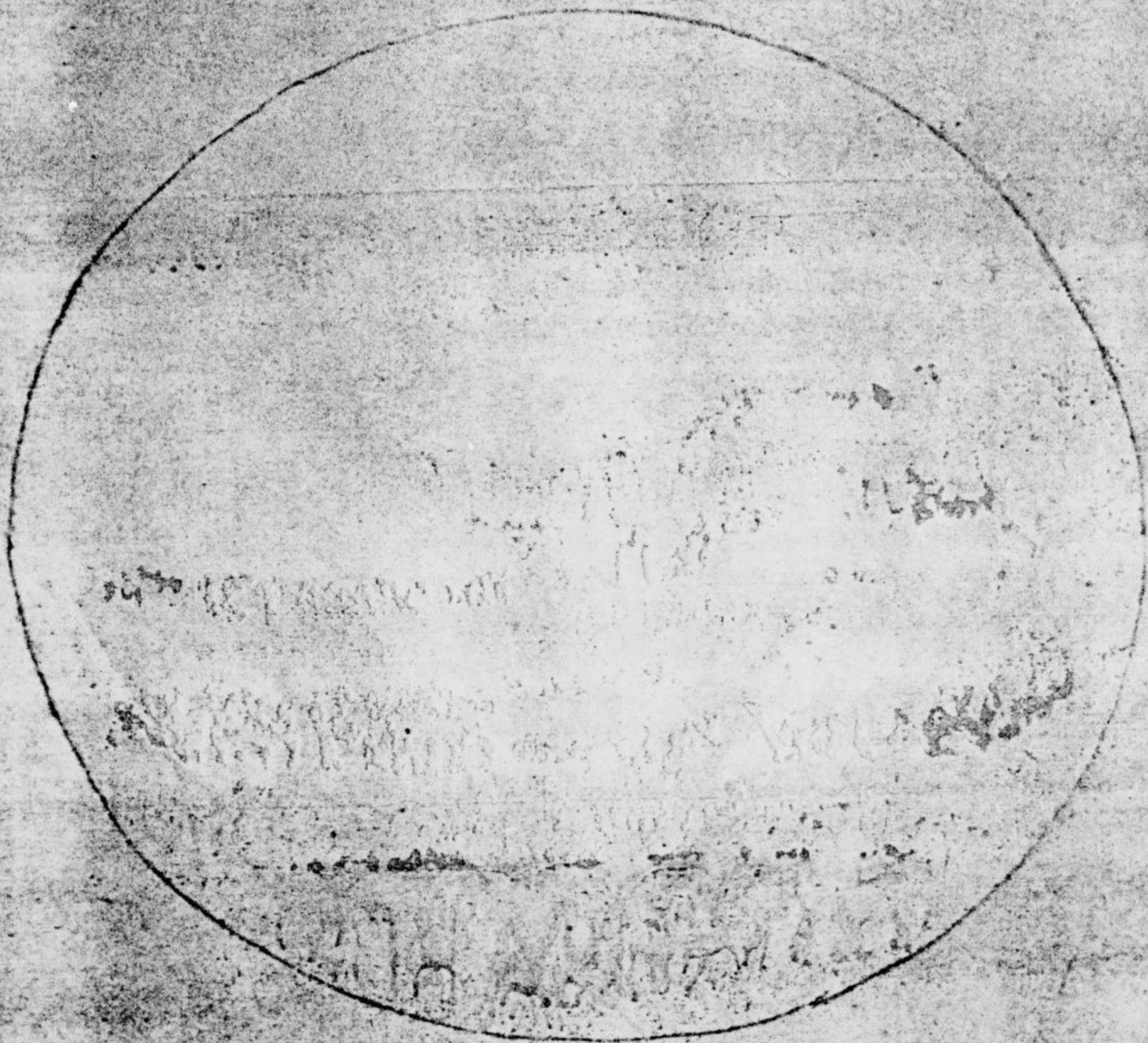
