AIR. I HAD THAT ARE OBJECTS FLOWING ABOUT IN THE SKY AND I SAW ONE
ONE YEAR AGO WHILE VISITING IN BALTIMORE. "BALTIMORE" OF FIRST
STREET.

IT WAS A VERY HOT NIGHT AND I HAD MY HAND ON A PILLOW ON THE
WINDOW SILL TRYING TO SLEEP WHEN I HEARD A SOFT HUMMING NOISE AND THOUGHT
