1. Reference the attached letter from [REDACTED], dated 28 Oct 63, requesting information on an unidentified flying object. Records reveal no previous correspondence received from Mr [REDACTED]. The Air Force files do not contain a case for Thailand, for the month of June 1962.
2. It is suggested that Mr [REDACTED] be informed that he is free to discuss any aspects of the sighting from a UFO standpoint. Since we are not familiar with the case, we do not know whether the incident contained any classified information. The unidentified flying object in itself is not classified. Mr [REDACTED] is free to talk as an individual about any experiences which he may have had with UFO's. It should be understood that these opinions are his and not necessarily those of the military service.
3. If Mr [REDACTED] has first hand information regarding this sighting, we would be pleased to accept it and offer our evaluation.

This is in response to your letter of October 28, 1963, addressed to the Aerospace Technical Intelligence Center at Wright-Patterson Air Force Base.

Therefore, we have no knowledge whether or not there was a classified aspect to the case.
