COMMENTS No positive conclusion can be reached in this case due to lack of substantial data and fact that exact positions of all a/c in area cannot be determined for specific times. However there was a flight in area at time of sighting and light of a/c was probable cause for sighting. Unusual perspective experienced when viewing celestial vault fm prone position is probably a contributing factor. There is no evidence available which indicates objt was not and a/c.

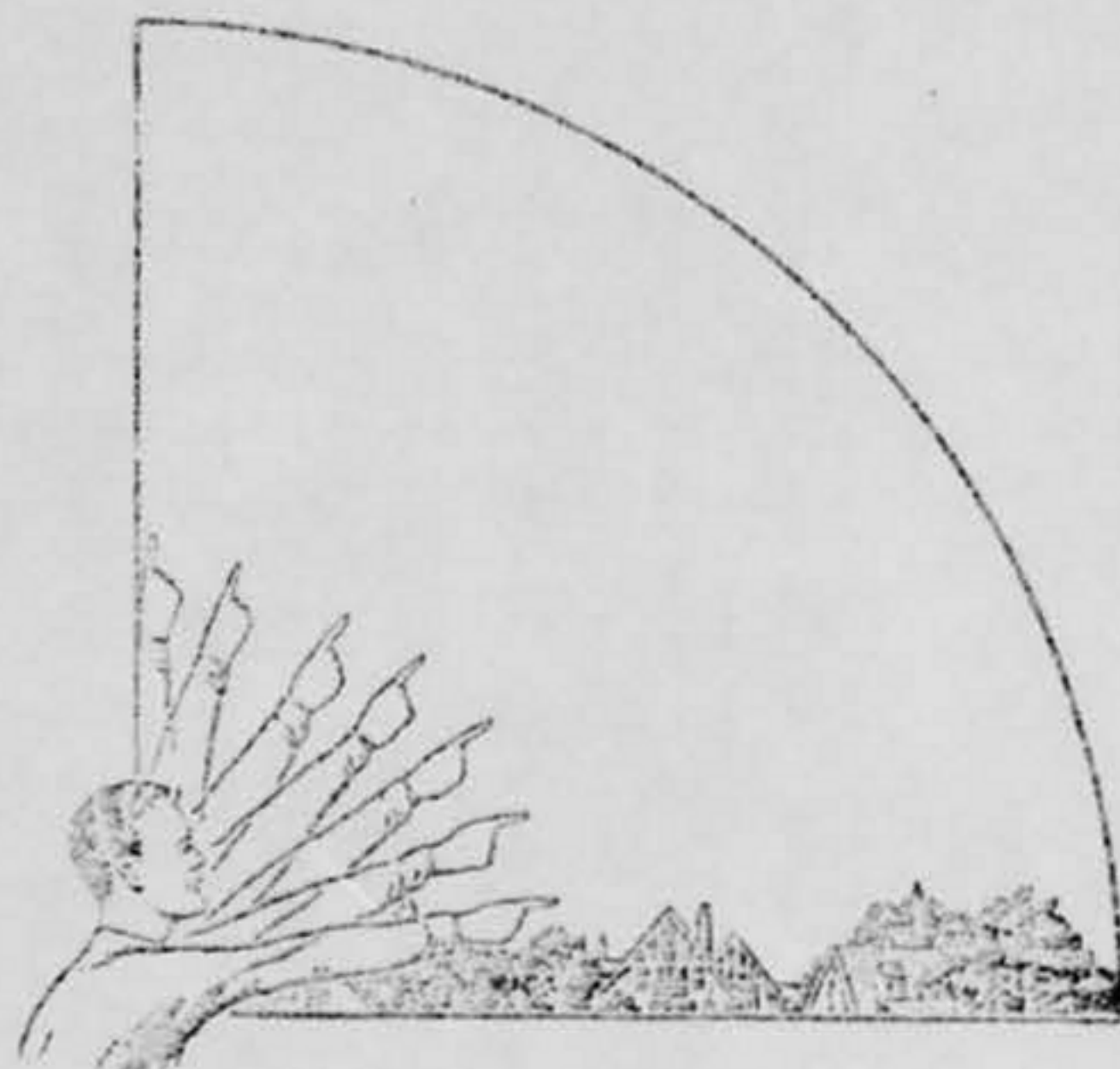

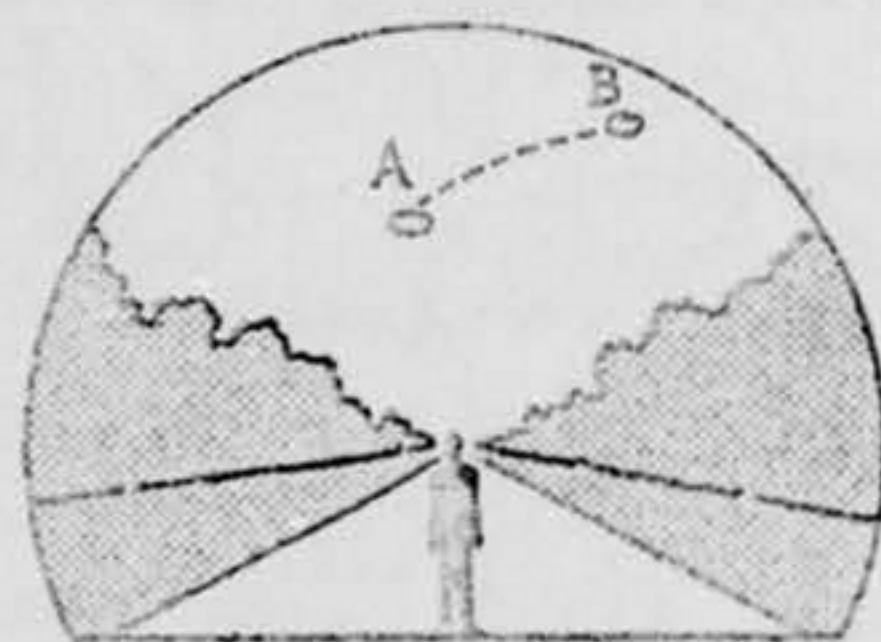
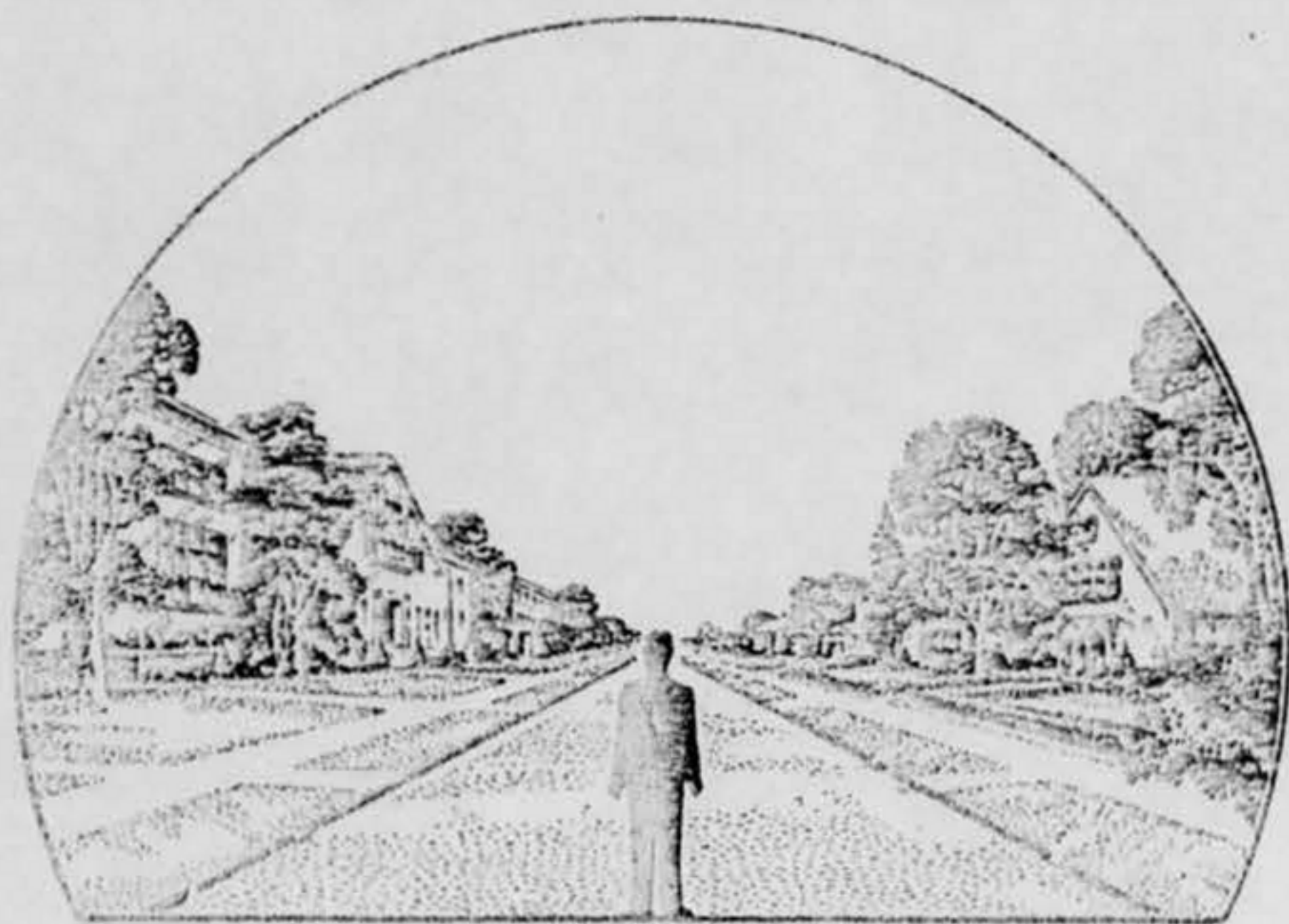
