IN A WAVY PATTERN, AND ANGLE OF ELEVATION AT DISAPPERANCE 075.  
OBSERVER INDICATED THERE WAS NO RAIN AT TIME OF NIGHT SIGHTING  
AND THAT THE SKY WAS PARTLY CLOUDY. THERE WAS NO UNUSUAL  
METEROROLOGICAL ACTIVITY. REPORT FROM LAJES AWS FOR 0600Z INDICATED  
WIND DIRECTION 160 DEGREES MAGNETIC AND VELOCITY 3 KTS AT SURFACE,  
230T AND 9 KTSS

T 6,000 FT AND 290T AND 30 KTS AT 10,000 FT. CEILING  
WAS 2700 FT SCTD WITH CLOUD COVER LESS THAN POINT 5. VISIBILITY WAS  
12 MI, TEMP 47F AND THERE WERE NO THUNDERSTORMS IN THE AREA. LAJES  
TCC VERIFIED THAT NO KNOWN AIRCRAFT WERE IN AREA AT TIME OF SIGHTING,  
HOWEVER, REPORTING OFFICER, LCDR D. T. LASOWSKI, USFORAZ, BELIEVES  
UNKNOWN AIRCRAFT TRANSITING AREA OF SIGHTING IS A DEFINITE  
POSSIBILITY.

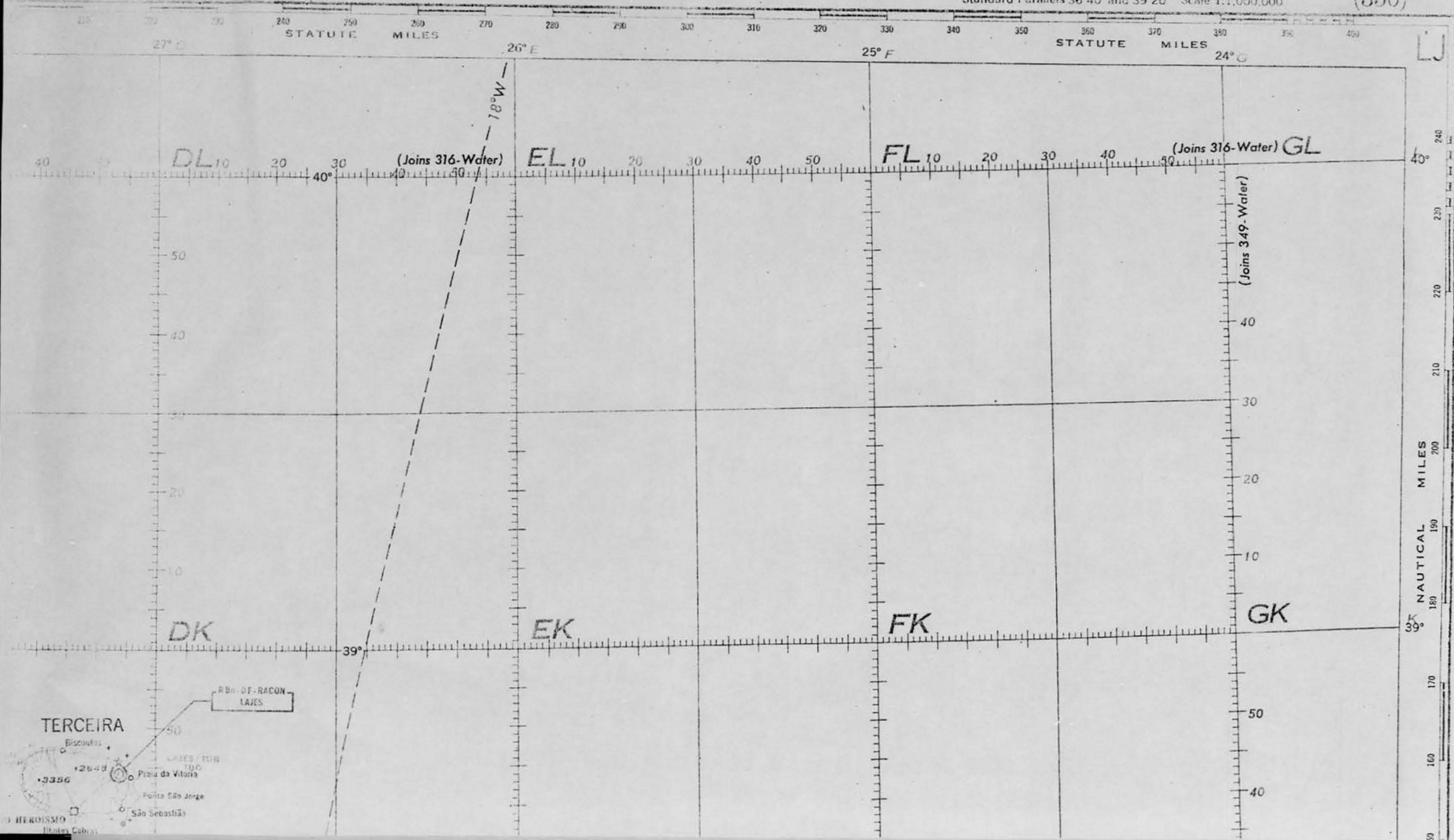
