① Its erratic behaviour, which immediately distinguished it from any orthodox flying object.

② Its very considerable velocity. I believe the rather constant brightness of the object must have led me to assume it to be at a great distance.

I am sorry to say that a good deal of information I had given at the time I have now forgotten.

When in the field I normally have a pocket transit with me, I should be willing to record data of the kind you ask for in the event of my seeing any other mysterious objects in the sky. In return I should expect to be kept informed of the results of your investigation.

(U) Unidentified flying object sighted in North Lebanon by university professors.

1. (OUO) On 15 APR 63 source was on a camping trip on Jebel (mountain-34-25N 36-15E) Kharrouha (elev. 4500 ft) in the north of Lebanon. This area is very isolated and is accessible only by foot. His party consisted of four other professors. At 1915B they sighted a high flying, very bright object traveling from northeast to southwest. It appeared to generate its own light, much like a star. The moon had not risen and the sky was clear and dark.

2. (OUO) As it traveled across the sky it made several very abrupt changes in course, much too quickly to have been an aircraft. As it approached the horizon in the southwest it reversed course and eventually disappeared when once more overhead. No sounds were heard at any time. The total time of observation was 10 minutes.
