Two times as bright as Arcturus. White color, No sound. Witness believed object to be satellite. <i>De mi</i>				11. COMMENTS Duration & movement not satellite. Same alt & position in a small area rules out a/c. Initial impression was that obj was star or planet. Mars (mag 1.4) is in approximate position; however, this obj usually appears to be red. Regulus (mag 1.3) is about 10dgr of elevation lower. However, the stars or planets will not change their relationship to the moon by 10dgr in one hour. Possible balloon sighting. No wind data to determine if balloon could remain in area.

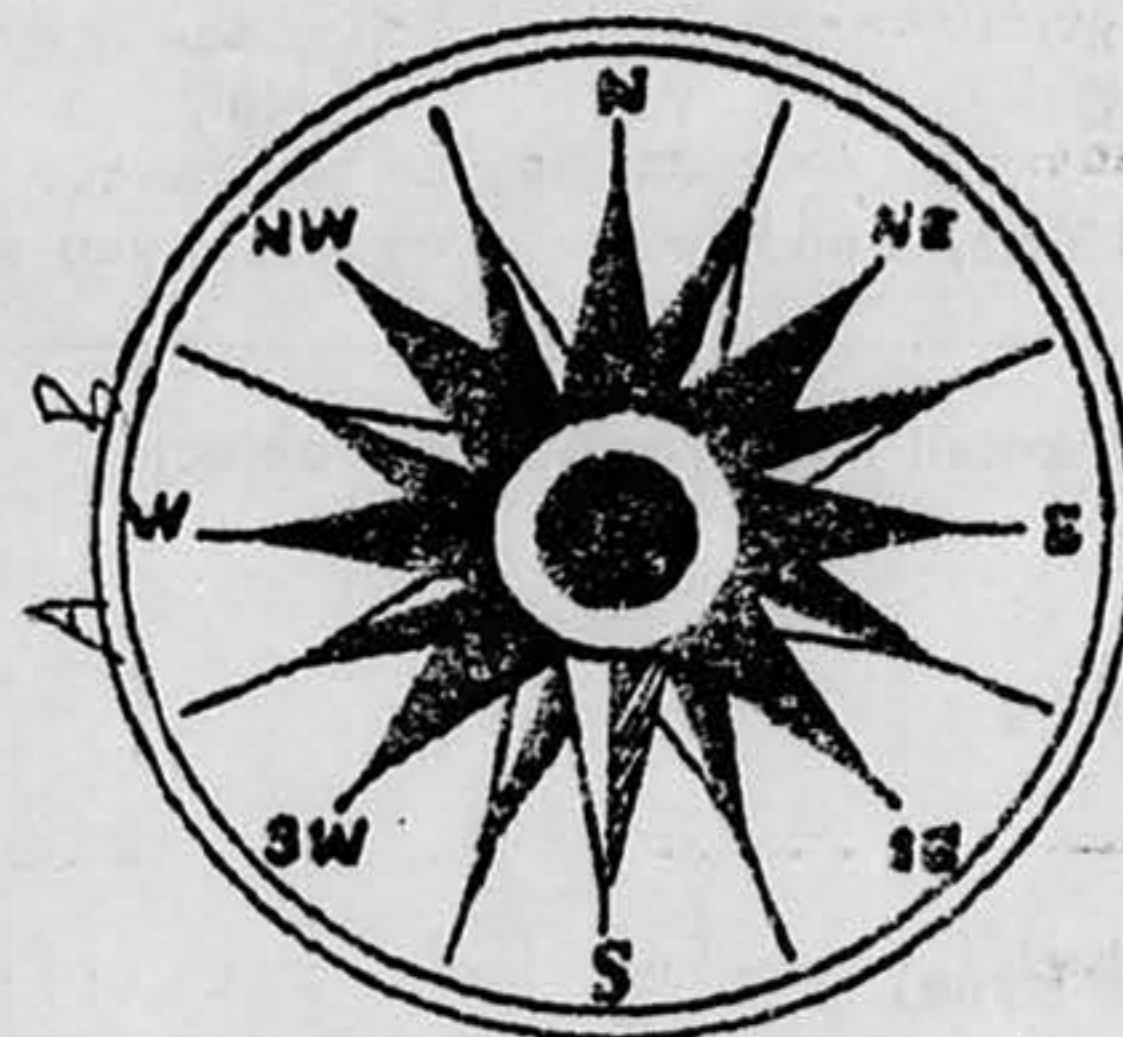
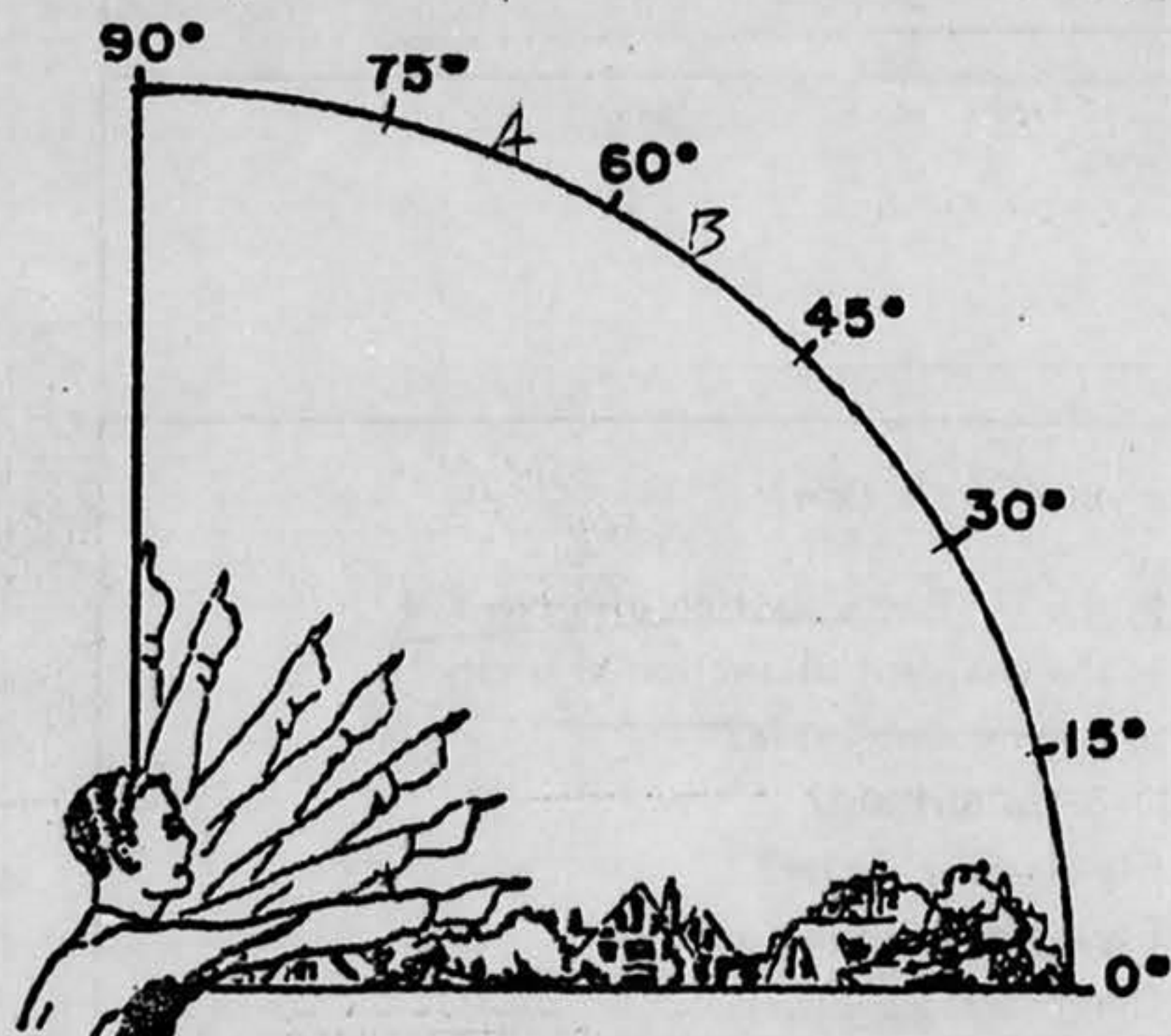
