"I feel silly reporting this but I have never seen anything like it in my life & my wife & son saw it also at the same time", was the opening statement to me. Lt Col Decker stated that he & his family were looking at a bird on their TV antenna when they spotted the object moving across the sky. When a cloud moved in front of it he called me (1720Z). After three minutes discussion he went back outside but was never able to spot it again. We continued our phone conversation again at 1735Z. He has observed ECHO & movement of this object was about the same.

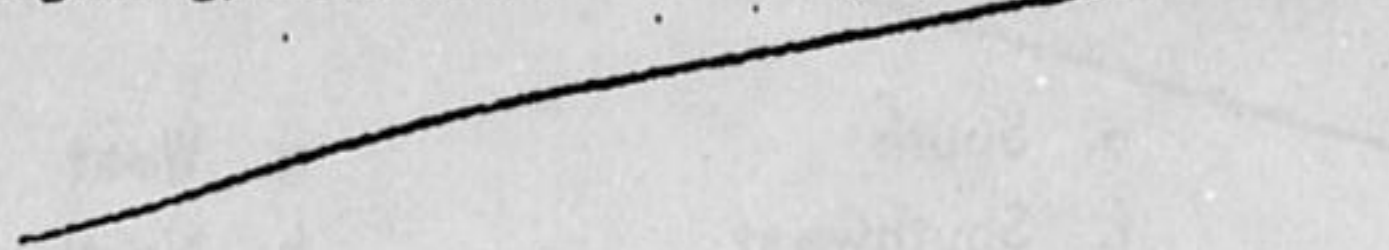

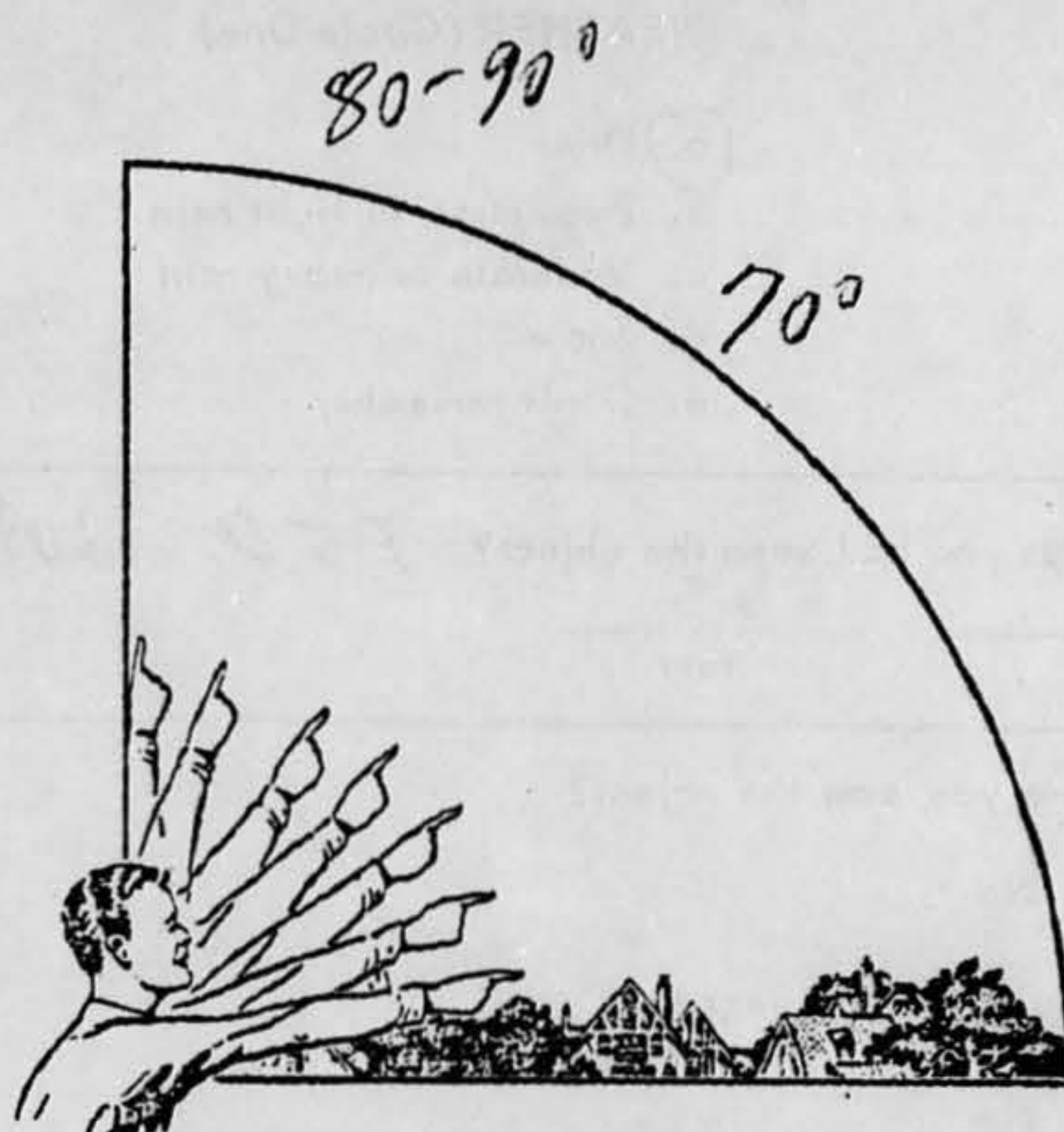

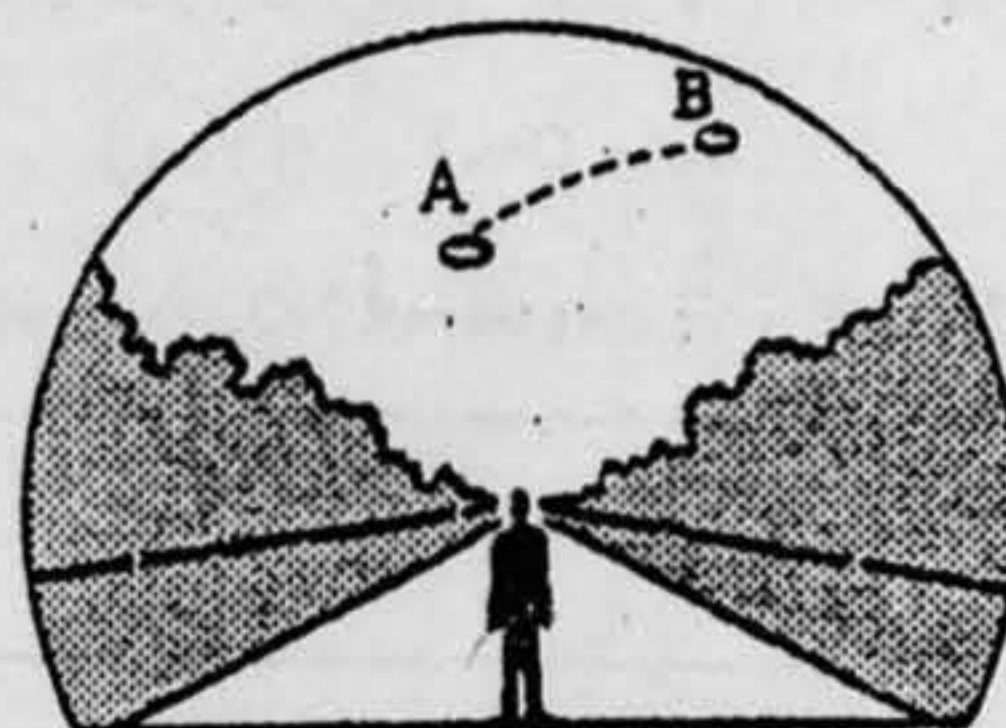
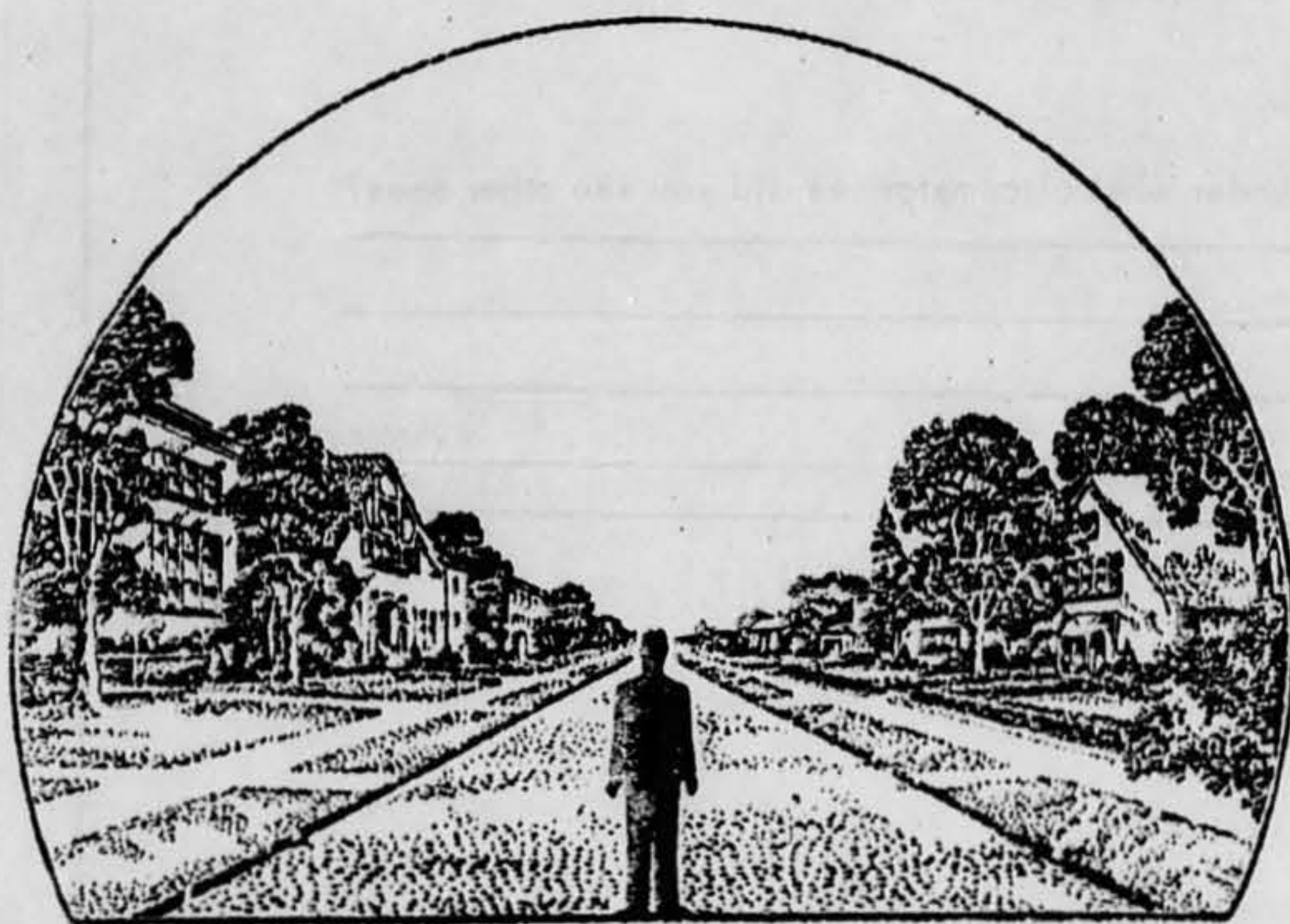
