JUPITER WHILE IN EAST WOULD APPEAR TO MOVE SE. OBJECT ONE OF THESE TWO ASTRO BODIES.		11. COMMENTS Jupiter is in East (azimuth 80 deg) and moving slowly South toward the SE however, never exceeding 30deg elevation. Probable some distortion in estimates on direction and elevation. Object reported is characteristic of an Astro body and Jupiter is in the East and very bright. Case evaluated as Jupiter. CAPRELLA AT 30° AZIMUTH 5° ELEVATION MOVING TO SOUTH RISING TO 20° ELEVATION 45° AZ. AFTER 1 HR. 45 MIN.
