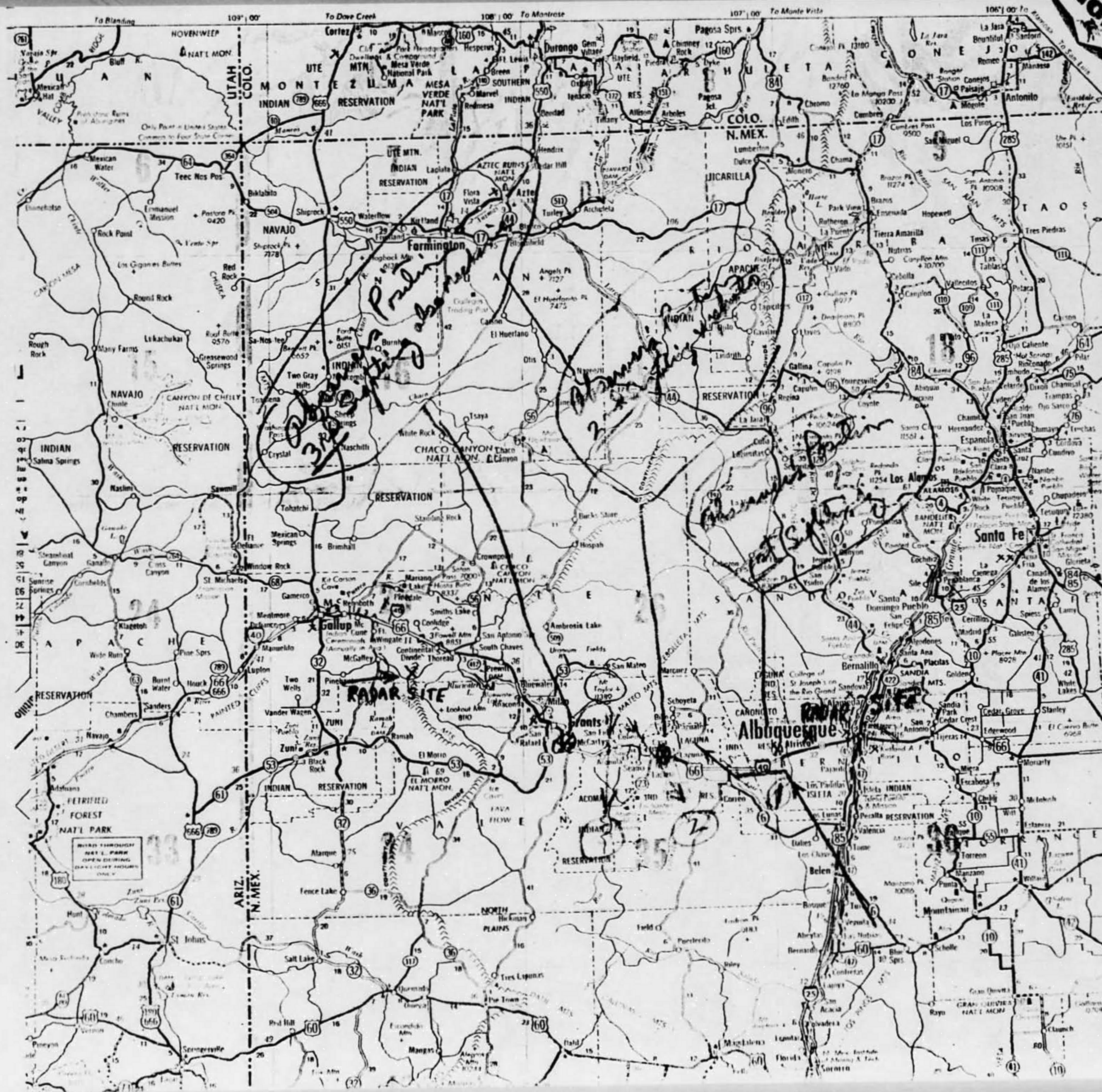

Reference your letter, Supplemental Information on UFO Report, TWX DO-161-2D 2030Z, 30 Apr 64, Luke AFB, Arizona. The film was developed and printed by the Kodak Company in Chicago, Illinois. Please return these slides to Mr. [REDACTED], Phoenix, Arizona, owner, thanking him on behalf of the Air Force for there use. We did not find any pictures which would be useful in identifying the reported UFO, in fact the slides are blank. However, the sighting and the object reported by Mr. [REDACTED] was an aircraft on a low level night photo reconnaissance mission for Project Cloud Gap. The unusual thing about the aircraft was its use of a strobe instead of the conventional lights and/or flares. We are returning the photos which were processed and returned to us by the Kodak Company.

1. Contacted Mr. [REDACTED] personally at his teaching position, [REDACTED] School, Phoenix, Arizona at 1300 Hours, Friday, 1 May 1964.

2. His camera is a KONICA, Model L, 35mm (Hexar lens 2.8, F-40mm), made in Japan. He took the photograph during the second sighting in the dark, with lens setting of 2.8 (wide open); speed: 1/50; Film Kodachrome #2, 35mm, ASA 25, Hand-held; so he is not sure of what he got, if anything.

3. He stated that he did not mind letting the Air Force have the film, but that he wanted to be sure he gets back copies of the pictures (including one of the object). One picture has a legal value and involves a will that is in litigation on monies he is to inherit. I assured him faithfully that the Air Force would guard his property rights in the film and return to him as requested. Please personally see that this promise is fulfilled.

4. Reference Item B(2)(3) and Item E(1)(2) and (3) in subject TWK: Heading of object are indicated on enclosed Mobil road map by the observer's personal annotations; also his exact location at time of the three sightings. These are different from locations and headings previously submitted by TWK and based on telephone conversation with observer. I had him personally mark them on map; since I was not a witness myself and am unfamiliar with the area.

5. The observer also stated that his first thought was that the sighting was "an experimental aircraft on a night photo recon mission, but then -- it definitely was not -- that it would not be flying at such a low altitude in the terrain of the area at night -- there were no navigation lights. Definitely was not an aircraft" "At time of second sighting, what appeared to be a satellite could also be observed through broken cloud cover on an East-Southeast heading at great altitude, estimated to be 40,000 feet or more."

6. The observer appears to be competent, reliable, intelligent, sincere and truthful in his reporting.

DESCRIBED THE WHITE LIGHT AS PULSATING ONCE PER SECOND AND REMINED HIM OF AN ELECTRONIC FLASH UNIT. (4) ONE (5) N/A (6) NO FEATURES DISCERNABLE OTHER THAN SYMMETRICAL SHAPE. (7) NONE (8) NONE. HOWEVER, GARAGE MECHANIC WHO OBSERVED OBJECT WITH THIS OBSERVER ON THE THIRD OBSERVATION STATED THAT WHEN IT CAME OVER HIM EARLIER IN THE EVENING IT WAS MAKING A "TERRIFIC NOISE". (9) NONE

(1) THE UNUSUAL BRILLIANT RED LIGHT AND THE WHITE LIGHT SHINING DOWN ON THE TERRAIN. (2) 500 FEET, 170 DEGREES AZIMUTH AT A 10 TO 12 DEGREE ANGLE FROM OBSERVERS POSITION. (3) OBJECT EXECUTED A 90 DEGREE TURN JUST SOUTH OF HIGHWAY 66, PROCEEDED WEST ALONG THE HIGHWAY FOR ONE AND HALF MILES, EXECUTED ANOTHER 90 DEGREE TURN TO RIGHT (NORTH) TOWARD MOUNT TAYLOR. THE OBJECT WITH THEM. THE MECHANIC WAS DRIVING A RED INTERNATIONAL PICK-UP TRUCK; NAME UNKNOWN. HAS A GARAGE ON NORTH SIDE OF HWY 66: R RZXTY IN GRANTS, NEW MEXICO. OBSERVER, WOODRUFF, APPEARED TO BE A VERY RELIABLE AND COMPETENT OBSERVER, WITH AVIATION EXPERIENCE AND TRAINING HE COMMENTED THAT HIS FIRST THOUGHT ON THE RED LIGHT WAS THAT IT MIGHT BE A NAVIGATION LIGHT, BUT THAT IT DEFINITELY WAS NOT. FROM HIS FIRST POSITION HE WAS LOOKING DOWN FROM AN ELEVATED TERRAIN POSITION TOWARD HIGHWAY 66 WHEN HE SIGHTED THE OBJECT AT AN ESTIMATED 500 FEET ABOVE THE GROUND. HE THOUGHT IT WAS VERY STRANGE THAT AN AIRCRAFT WOULD BE FLYING AT SUCH LOW ALTITUDE IN SUCH MOUNTAINOUS TERRAIN IN A VALLEY. HE COMMENTED THAT ONE RADAR BASE WAS LOCATED VERY NEAR AT LAGUNA, AND ANOTHER AT THE CONTINENTAL DIVIDE, BUT " DOUBTED THEY COULD PICK UP THE OBJECT BECAUSE OF GROUND CLUTTER AND PERMANENT ECHOS ON THE SCOPE AT ALTITUDE OF THE OBJECT". HE WAS VERY HESITANT ABOUT MAKING A REPORT AND DID NOT DO SO UNTIL THE MORNING OF APR 29 AT THE URGING OF, AND AFTER DISCUSSION WITH ANOTHER TEACHER AT THE SCHOOL, WITH REGARD TO NEWS PAPER ITEMS ON SIX OTHER REPORTS IN THE SOCORRO, NEW MEXICO AREA. BELIEVE WITNESS TO BE COMPETENT, CREDIBLE, AND TRUTHFUL. REPORTED TO LUKE AFB, ARIZ.
